### US Dept. of Homeland Security, Assistance to Firefighters Grants (AFG)

These grants provide financial assistance directly to eligible fire departments, nonaffiliated emergency medical service (EMS) organizations and state fire training academies (SFTAs) to equip and train emergency personnel to recognized standards, outfit responders with compliant personal protective equipment, provide funding to retrofit or modify facilities to protect personnel from known health hazards, acquire emergency response vehicles, design and implement health, wellness and resiliency programs that prepare responders for incident response, enhance operational efficiencies, foster interoperability and support community resilience.

### US Dept. of Health & Human Services (HHS), Transition for Youth with Autism and/or Epilepsy Demonstration Projects

### **National Science Foundation (NSF), Strengthening American Infrastructure (SAI)**

This funding supports projects that stimulate human-centered, use-inspired, fundamental and potentially transformative research aimed at strengthening America's infrastructure. Achieving these objectives requires the integration of expertise from across all science and engineering disciplines.

### **US Dept. of Veterans' Affairs (VA), Grants for Adaptive Sports Programs**

These grants will assist eligible adaptive sports entities to plan, develop, manage and implement programs to provide adaptive sports activities for veterans and members of the Armed Forces with disabilities. Adaptive sports activities include:

### **US Dept. of Housing and Urban Development (HUD), Green and Resilient Retrofit Program Elements (GRRPE)**

This funding seeks to amplify recent technological advancements in utility efficiency and energy generation, bring a new focus on preparing for climate hazards by reducing residents' and properties' exposure to hazards, and protecting life, livability and property when disaster strikes. GRRPE is the first HUD program to simultaneously invest in energy efficiency, greenhouse gas emissions reductions, energy generation, green and healthy housing and climate resilience strategies specifically in HUD-assisted multifamily housing. These grants are designed for the widest range of properties, including those that have not yet developed a recapitalization plan. To the greatest extent feasible, these approaches will:

- ◆ substantially improve energy and water efficiency, including moving properties toward net zero, zero energy ready, or zero over time energy performance
- ◆ address climate resilience, including synergies that can be achieved between efficiency and resilience investments
- ◆ enhance indoor air quality and resident health
- ◆ implement the use of zero-emission electricity generation and energy storage
- ◆ minimize embodied carbon and incorporate low-emission building materials or processes
- ◆ support building electrification

## US Dept. of Health and Human Services (HHS), State Maternal Health Innovation (MHI)

This funding will help reduce maternal mortality and severe maternal morbidity (SMM)<sup>3</sup> by:

### Perelman Performing Arts Center (PAC NYC) & Galvan Initiatives (Galvan), The Democracy Cycle, Commissions

These commissions will support new works that illuminate the promise, practice, imperfection and opportunity of democracy. Proposals are requested for new performing arts works following that theme from artists working in theater, dance, music, opera and multi-disciplinary performance. The commissioned works will explore themes relating to the nature, practice and experience of democracy.

### Eligible Applicants Must:

- ◆ be generative artists currently creating new work in theater, dance, music, opera and multi-disciplinary performance
  - ◆ have created two or more completed and presented works
  - ◆ not be enrolled as a full-time student in a degree-granting program

## Robert Wood Johnson Foundation, Healthy Eating Research (HER) Grants

HER's mission is to support and disseminate research on policy, systems and environmental strategies that promote healthy eating among children and families and advance nutrition security and health equity. These grants will help fund research to generate evidence on supportive family policies and programs that have strong potential to impact equitable access to nutritious food in communities, nutrition security, diet quality and improved nutrition and health outcomes.

## Foundation for Contemporary Arts (FCA), Emergency Grants

These grants offer immediate, project-based assistance to visual and performing artists living and working anywhere in the United States, for projects occurring in the U.S. and abroad. Emergency grants provide urgent funding for visual and performing artists who:

- ◆ have sudden, unanticipated opportunities to present their work to the public when there is insufficient time to seek other sources of funding
- ◆ incur unexpected or unbudgeted expenses for projects close to completion with committed exhibition or performance dates

### ■ Eligible Applicants Must:

- ◆ be living in the United States or U.S. territories and have a U.S. tax ID number (SSN, EIN, ITIN, or other)
- ◆ have committed performance or exhibition opportunities and be able to provide specific dates at the time of application
- ◆ be individual artists, or an individual representing an artist collective, ensemble or group. Curators, producers, workshop organizers, organizations or arts presenters are not eligible to apply
- ◆ not reapply for a project for which they have previously been denied funding

### Point Foundation, BIPOC Scholarships

## Patient Advocate Foundation (PAF) College Scholarships for Survivors

These scholarships help provide support to individuals, under the age of 25, who have been diagnosed with or treated for a cancer or chronic disease within the past five years.

■ **Eligible Applicants Must:**

- ◆ be under the age of 25
- ◆ be a United States citizen
- ◆ have been diagnosed with and/or been actively treated for a cancer or chronic disease within the past five years
- ◆ be pursuing an associate degree or higher
- ◆ complete a Scholarship for Survivors application in full
- ◆ write an essay on how their diagnosis has impacted their lives and future
- ◆ submit a copy of an acceptance letter from the college or university the applicant is planning to attend. If applicant is unsure or has not received acceptance letters yet, please list colleges for which student has applied to. If selected as an award recipient, acceptance will be verified
- ◆ upload two letters from two non-related persons (examples: teachers, coaches, community leaders) to provide a letter of recommendation. The recommender should be able to speak to your personal character, academic achievements and work and volunteer experience
- ◆ provide a copy of an official transcript
- ◆ submit completed financial section that will demonstrate financial need and include a copy of the first two pages of a tax return for the individual claiming the student as a dependent. If the student or parent claims \$0 income on taxes or did not file their taxes, please complete the official letter of non-filing from the IRS and complete the Declaration of Income Form
- ◆ verify patient's diagnosis by having their treating physician complete the Diagnosis Verification Form or on medical letterhead by patients' oncologists, primary care physicians or nurses. The letter must only include:
  - ◆ patient's name

- ◆ patient's diagnosis
- ◆ date of diagnosis
- ◆ when the patient began or will begin active treatment
- ◆ when patient ended or will end active treatment (chronic illnesses do not require end date)

■ **Award Amount:** Undergraduate scholarships of \$3,000 per school year (\$1500 per semester: Fall/Spring) for four consecutive years until the student receives a maximum of \$12,000 or graduates with a bachelor's degree, whichever comes first.

## Microsoft Disability Scholarships

These scholarships will be awarded to promising high school seniors with disabilities who plan to attend a vocational or academic college and aspire to have a career in the technology industry.

- ◆ be a current high school senior living with a disability as defined by the World Health Organization (WHO), including visual, hearing, mobility, cognitive and/or speech disabilities or other disability
- ◆ plan to attend an undergraduate program in a two or four year university/college or technical college in the fall of the academic year following high-school graduation
- ◆ declare an approved major in engineering, computer science, computer information systems, law, business or a related field (e.g. paralegal, pre-law, finance, business administration, or marketing)
- ◆ demonstrate a passion for technology
- ◆ demonstrate leadership at school and/or in the community
- ◆ have a high school cumulative GPA of 2.5 or higher
- ◆ require financial assistance to attend college
- ◆ enrollment status must be full-time or half-time
