Dear President Kirchner:

We register our grave concern surrounding the death of Argentine Prosecutor Alberto Nisman, the investigation into any cover-up of Iranian involvement in the 1994 bombing of the Asociacion Mutual Israelita Argentina and the rise of anti-Semitism in Argentina.

The mysterious death of Mr. Nisman, just hours before he was to testify before the Argentine Congress about the cover-up, is intensely troubling, as are the attacks on 10 Israeli tourists at Lago Puelo on January 19 and the sudden appearance of anti-Semitic graffiti.

This matter is hauntingly reminiscent of the Dreyfus affair. We are gravely concerned over the safety of Argentina's 250,000 Jewish citizens.

We urge that the Government of Argentina take every measure to investigate the death of Mr. Nisman and the allegations that senior governmental officials participated in a cover-up of Iranian involvement in the bombing and that every measure be taken to end the rise anti-Semitism occurring in your nation.
