### **Grants for Programs Serving Adults with Disabilities**

#### **Ethel Louise Armstrong Foundation**

The vision of the Ethel Louise Armstrong Foundation is "to change the face of disability on the planet." In order to accomplish this vision, the Foundation's mission is to promote, through grants and scholarships, the inclusion of people with disabilities in the areas of arts, advocacy, and education. The foundation funds program grants in the areas of arts, advocacy, and education for adults with disabilities (over 22 years old).

**ELIGIBILITY**: Applicants must be U.S. nonprofit 501(c)(3) organizations that serve people with disabilities and have been in existence for two years or longer. Support from other funding sources in the community for the program must be demonstrated in the grant application.

**FUNDING**: Grants range from \$1,000 to \$5,000 each.

**DEADLINE**: The online grant application form must be submitted by March 15, 2007 for the May 1, 2007 full grant application deadline.

#### HIV Prevention Interventions and HIV-Related Supportive Services in Communities of Color

### New York State Department of Health, AIDS Institute

The AIDS Institute has announced that funding is available for HIV prevention interventions and HIV-related supportive services in communities of color. Program services and interventions may include outreach, prevention interventions and activities, supporting services, and peer-delivered services.

ELIGIBILITY: Not-for-profit 501(c)(3) health and human services organizations; this may include community-based organizations, faith-based organizations, community health centers, or drug treatment centers. FUNDING: The total annualized amount available for awards is \$2,500,000. The funding will be allocated statewide. #### **Healthy Families New York**

### **New York State Office of Children** and Family Services (OCFS)

Healthy Families New York (HFNY) offers home based services to expectant and new parents, beginning prenatally or shortly after the birth of the child. Families who participate in the program are offered long-term in-home services until the child is in school or Head Start. HFNY follows the standards of Healthy Families America, a national initiative of Prevent Child Abuse America. Grant funds may be utilized for, but not limited to home visiting staffing and fringe benefits; project equipment and furniture; computers and appropriate software for the project; supplies, mailing and printing costs of project-related flyers, pamphlets and educational materials; staff travel costs at the approved State travel rate; telephone installation and monthly billing; consultants retained by a formal agreement; rental of space; and a maximum of 10% federally approved Indirect Cost Rate with appropriate documentation. A 10% local share is required.

ELIGIBILITY: Social services and health not-for-profit corporations, local government agencies, other 501(c)(3) organizations including community and faith based organizations, BOCES programs, or religious organizations.
FUNDING: The total funding is

#### **Tobacco Free Schools**

The Tobacco Free Schools Support

#### **New York State Department of Health**

Programs will assist in the development, implementation, and enforcement of effective tobacco-free school policies.

Partners funded for this service will focus on middle and high schools, unless entire school districts can be engaged.

ELIGIBILITY: Non-profit agencies or governmental subdivisions serving the initiative's catchment areas. Eligible applicants must have no affiliations or contractual relationships with any tobacco company, its affiliates, its subsidiaries or its parent organizations.

**FUNDING**: Funding is available for 11 catchment areas covering parts of New York State, with total available funding of \$1,075,000 per year for this service. Contact the Department of Health for catchment area details.

### **Child Abduction Prevention Education Program**

### **New York State Education Department (SED)**

SED has announced the availability of funding to help school districts and boards of cooperative educational services meet the statutory requirement to provide instruction in the prevention of abduction for students in K-8. Grantees may use funds to develop or adopt a curriculum and/or implement an instructional program to help prevent child abduction.

**FUNDING:** A total of \$1 million is available. Grants can not exceed \$10,000 per applicant and all grant funds must be obligated by June 30, 2007.

### **Preserve New York Grant Program**

Preservation League of New York State and the New York State Council on the Arts

The Preservation League of New York State and the New York State Council on the Arts announce the 2007 Preserve New York Grant Program. The program provides funding to municipalities and not-for-profit organizations, and supports three types of projects only: historic structure reports, historic landscape reports and cultural resource surveys. Through the program, the Preservation League, a statewide, not-forprofit organization, and the Council, the state's arts funding agency, seek to support efforts to plan for the preservation, restoration and rehabilitation of historic buildings and landscapes throughout the state. In 2007, the Preservation League especially encourages projects that advance the preservation of neighborhoods that qualify for the New York State residential rehabilitation tax credit; preserve historic buildings and transportation corridors including rural roads and canals; continue the use of historic municipal buildings; and support Main Street revitalization.

ELIGIBILITY: Municipalities and not-forprofit organizations with 501(c)(3) status are eligible to apply unless they are applying for funding directly from the New York State Council on the Arts' Architecture, Planning and Design Program (APD) for another project in 2007. Groups are limited to one project with APD support per year. State agencies and religious institutions are ineligible for support. Groups that previously received funding through this grant program must have successfully completed their projects to be eligible for the 2007 grant round. The grant panel members will evaluate: architectural and historic significance of the building, landscape or area; the need for the project and for financial support at this time; the applicant group's ability to carry out the project within a stated schedule; the applicant group's ability to raise sufficient funds to complete

the project; the appropriateness of the project budget and consultant(s); extent of local support for the project; and the likelihood that significant restoration or planning work will result.

FUNDING: A total of \$87,200 is available and will be split among all three project types. Grants are likely to range between \$3,000 and \$10,000 each. No formal financial match is required; however, the Preservation League and the New York State Council on the Arts expect to see a project budget that reflects the applicant's meaningful commitment to the project. Please note that it is unlikely that this program will be able to provide full support for any project. It is also expected that the consultant fee structure reflects the applicant's understanding of the value of these professional services.

**DEADLINE**: Applications must be postmarked no later than May 1, 2007. Please follow the directions included in the application for assembling the packets.

### **Adult and Family Literacy Programs**

#### **Dollar General Literacy Foundation**

The Foundation's Adult Literacy Grants
Program awards grants to direct service
providers in the following focus areas only:

Grants Program awards grants to

ELIGIBILITY: Organizations with 501(c)(3) status established for public use that provide direct literacy-based programs to adults and families, located in Dollar General's market area, and located within twenty miles of a Dollar General store.

FUNDING: In fiscal year 2007, the Foundation will award a minimum of \$1.5 million in grants to qualifying nonprofit adult literacy providers, and a minimum of \$1.5 million to qualifying nonprofit family literacy providers.
