# **Course Description**

The seminar is designed to provide an introduction to the state legislature and the issues it faces in New York. It is also intended to introduce the Graduate Scholars to the work and work products expected of legislative staff in New York.

Scholars are expected to do the weekly readings and attend a series of 14 seminars. These will be held in accordance with the schedule below. You will notice "Hold" on some dates. These will give us the opportunity to hold "make-up" sessions should they be required. If not, they will be "buy" weeks with no seminar and you can expect to be assigned topical readings or on-line discussions instead. Also, we will be flexible with the readings and seminar topics. There may be occasions where current events would make it worthwhile to change the schedule so that the seminars and readings coincide with events.

Scholars will also be expected to write professional work products. Smith's "Writing Public Policy" (one of the assigned books below) will be used as a guide. These will be related to the work of the office. Each scholar is asked to develop the proposal for each in consultation with both the office supervisor and with me. The written assignments must be completed to the satisfaction of the office supervisor and submitted to both the office supervisor and me in a timely manner. Expect the

assignments to be settled upon before the February break.

All of the usual academic rules apply. Proper citations to works and people consulted, etc. are expected.

In addition, the scholars will be asked to present their work to their colleagues.

I will be available in the Intern Office immediately before and after our seminars and by e-mail or telephone. Please make specific arrangements with me via email for an appointment to see me if at all possible. You are always welcome to stop in or call without prior arrangement, but you should know that you may be competing with other classmates that have appointments. And, of course, the staff of the Intern Program are always available to you should any issue arise when I am not in Albany.

If you are unexpectedly confronted with a scheduling conflict or any other kind of issue, please send me an email to let me know you will not be attending the seminar. Many of the activities of the legislature are intimately connected to the session calendar. But many are scheduled with little advanced notice because members and staff frequently need to adjust their schedules to address the requirements of issues, meetings, etc. originating outside the Assembly. Ill health, prior commitments, or office scheduling issues are legitimate excuses from seminar attendance.

The reading assignments and class meeting times for the first few weeks are identified below. You should expect to get further detail regarding <u>additional</u> readings and other assignments in the weeks to come.
