WORKING FOR YOU!

LAWS YOU SHOULD KNOW

Perhaps you don't need to know that having an ice cream cone in your pocket on Sundays is illegal in New York (yes, it really is), but you should know the following lesser known laws which could save you a fine or imprisonment:

- **Slow down when passing garbage trucks** – As of October of this year, New York is now the 12th state to enact a “**Slow Down to Get Around**” law, which classifies garbage trucks and waste collection vehicles as “hazard vehicles.” As such motorists must now reduce their speed when passing waste and recycling collection vehicles with flashing lights. Violating the law comes with a fine of \$45 to \$100 and could carry a jail term of up to 15 days.
- New York also adopted a “**Move Over**” law in 2012 which required motorists to slow down when passing a construction zone or public safety vehicle with flashing lights.
- **Don't paint that curb along your driveway yellow** – A homeowner may not paint curb, street or sidewalk to highlight driveway or for any other reason. New York City Administrative Code § 19-138 considers this “defacing” and violating the law carries a \$50 fine.
- **Don't Cover that License Plate!** – Placing anything over your vehicle's license plate is illegal in New York State, and police are cracking down. A ticket will cost you up to \$150.
- **Even more reason now to not tint car windows too dark** – Window tints on your vehicle's windshield or front windows that block more than 30% of light is illegal and carries a \$150 fine, and a new state law prohibits any vehicle from passing inspection when tint is too dark.

Assemblyman Perry wants to remind both tenants and landlords that tenants are entitled to, and landlords are required to provide hot water everyday at a constant minimum temperature of 120 degrees Fahrenheit.

Between October 1st and May 31st, a period designated as “Heat Season,” landlords are also required to provide tenants with heat under the following conditions:

- Between the hours of 6:00 a.m. and 10:00 p.m., if the outside temperature falls below 55 degrees, the inside temperature is required to be at least 68 degrees Fahrenheit; and,
- Between the hours of 10:00 p.m. and 6:00 a.m., if the temperature outside falls below 40 degrees, the inside temperature is required to be at least 55 degrees Fahrenheit.
