VETERANS DISCOUNT PROGRAM



Assemblyman Cusick partnered with the Staten Island Chamber of Commerce to initiate a discount program for veterans

of the United States military who live on Staten Island. Over 100 local businesses, ranging from auto body shops to law firms to restaurants, are currently members of this program as it continues to



grow. To join this program and receive reductions on goods and services at participating businesses, sign up at Assemblyman Cusick's office at 1911 Richmond Avenue. Please bring your discharge papers (DD-214) to receive your Staten Island VETS card. You will be given a listing of participating businesses that offer discounts at their establishments. OPERATION RECOGNITION **HELPING OUR VETERANS GET THEIR HIGH SCHOOL DIPLOMAS**

Operation Recognition was created to recognize the dedication and sacrifice of World War II, Korean War, and Vietnam veterans who left school before graduation to join the military. In 2005, a law Assemblyman Cusick authored (A.239/Chapter 652) added our Vietnam veterans to Operation Recognition. This program acknowledges that the experiences and skills learned in the defense of freedom have given veterans unique knowledge and special insight most could never attain. This diploma reflects our pride and gratitude for their sacrifices and bravery.

Who is Eligible?

- Must have been a member of the U.S. Armed Forces, and engaged in qualified service during the below periods:
- * World War II: December 7, 1941 – December 31, 1946
- * Korea: June 27, 1950 January 31, 1955
- * Vietnam: February 28, 1961 May 7, 1975
- Is a resident of New York State and received a satisfactory discharge

To participate, veterans need to only present one of the following as proof of service:

- DD Form 214 (Report of Separation)
- Certificate of Service (Honorably Served)
- · Certificate of Release or Discharge from Department of Defense (Merchant Marines)
- Letter from a recognized veterans agency affirming such service

How do you apply for a diploma?

- Interested veterans should bring their honorable discharge certificate or letter to any New York State school that issues general or local diplomas. There is no fee for this service.
- Candidates do not need to show evidence of attendance at a school in New York State. They only need to affirm in writing that they do not possess a high school diploma.

Candidates that possess a High School Equivalency (GED) diploma and can provide proof of service are eligible for the program. Diplomas may also be awarded to the next of kin if eligibility is established.

This program is designed for children of those who we lost or became seriously disabled while serving in our armed forces. The program provides \$450 per year to these students. In 2014, the State Legislature passed legislation which allows veterans attending a community college, the State University of New York, or the City University of New York under the federal GI bills to qualify for the in-statetuition rate. Extending this offer to our veterans is another example of the commitment made by New York State to those who fought and served our country after their active duty concludes.



VETERANS **TUITION AWARDS**

The New York State Higher Education Service Corporation (HESC) provides Veterans Tuition Awards for full-time study and part-time study for eligible veterans matriculated in an approved program at an undergraduate or graduate degree-granting institution or in an approved vocational training program in

New York State. Veterans who wish to apply must complete the Free Application for Federal Student Aid (FAFSA) and an accompanying application available by calling 1-888-697-4372. MILITARY ENHANCED RECOGNITION INCENTIVE AND TRIBUTE (MERIT) FINANCIAL AID PROGRAM

This program benefits children, spouses, and financial dependents of those who, while New York State residents, served in the U.S. Armed Forces or state-organized militia at any time after August 2, 1990, and died, became severely and permanently disabled, or were classified as missing in action in a combat zone. Those who qualify for this program are eligible for up to \$22,487 in funding to cover tuition, room & board, and living expenses. MILITARY DECORATIONS FOR NEW YORK STATE VETERANS

Many veterans are not aware that New York State has three military decorations the New York State Conspicuous Service Star, the Medal for Merit, and the Cor spicuous Service Cross.

The awards are available to New York State residents who served honorably in the U.S. military and who received a military citation while serving in the U.S. armed forces and are recipients of specific commendations, decorations or awards.
