Dear Friends and Neighbors:

As we close 2009, we must reflect on the fact that these are difficult times in New York State in general and Yonkers and Mount Vernon in particular. As I write this letter, the state is experiencing a deficit of over \$4 billion in personal income tax revenue, not by any overspending by the state. The national recession and the deterioration of the job market, especially on Wall Street, have caused New York to lose thousands of jobs.

Through no fault of our own, we must, as a state, deal with this situation. In early December the state reduced budgeted expenditures by \$2.8 billion and the governor is delaying another \$2 billion in budgeted payments because there is not enough cash in the bank.

I will continue to lead the fight to preserve vital services for Mount Vernon and Yonkers. Both cities are overburdened with high taxes now and ways must be found to stabilize existing taxes and expand our tax base to spread the cost of services over a broader spectrum.

2010 will be a very difficult budget year, thankfully Wall Street revenues are beginning to increase, but not fast enough. My priorities continue to be education aid, health care and direct aid to localities.

As we approach 2010, I hope that this year will bring you health, peace and prosperity. Please remember the thousands of men and women serving in the military. We thank them for all that they do to protect our country from any harm or danger.

HEALTHY NEW YORK

Last year I was instrumental in helping to create the New York Prescription Saver Card. The New York State Prescription Saver Card (NYPS) is a free Pharmacy Discount Card that is sponsored by the NYS Dept. of Health. The Saver Card offers participants significant discounts on thousands of prescription medications. Participants typically save more than 60 percent on generic drugs and 30 percent on brand name drugs. To be eligible for this card, you must be between the ages of 50 and 65 with an annual income of \$35,000 or less if single and \$50,000 or less if married. Medicaid recipients or those enrolled in the Elderly Pharmaceutical Insurance Coverage (EPIC) program are not eligible for the Prescription Saver Card.



In addition to the NYPS, I fought for a budget that preserves critical aspects of the Elderly Pharmaceutical Insurance Coverage (EPIC) Program helping to keep prescription medication affordable for thousands of New York Seniors and thereby helping keep seniors healthy.

The enacted budget preserves more than \$50 million in “wrap-around” coverage, which pays for EPIC enrollees’ prescription drugs when the drugs are not covered by a Medicare part D plan. In addition to helping keep seniors healthy by giving them access to the medications they need, EPIC ultimately saves taxpayers millions of dollars a year by decreasing the number of emergency room visits and nursing home admissions.



UNCLAIMED FUNDS

The State of New York is holding billions of dollars of unclaimed funds and you may have a claim to a portion of these funds. Types of funds that can be claimed include but are not limited to: savings accounts, checking accounts, unclaimed checks, telephone utility deposits, rental security deposits, wages, etc.

AVOID FALLING VICTIM TO DEBT SETTLEMENT COMPANIES

Unfortunately, we are facing historically difficult times. According to the Department of Labor, the unemployment rate across the United States continues to rise, and New York State faces the same bleak picture. People who have never struggled to pay their bills are now forced to consider defaulting on their debt. Due to the rise in consumer debt, the number of debt settlement companies has tripled to 2,000 which has led to an increase of complaints to state attorney general offices about how these companies conduct business. In order to protect consumers, the Assembly passed a number of bills that will implement penalties for those who violate the law. These bills will help protect the debtors from unscrupulous debt collection practices, punish debt collectors who violate the law, and give the information they need to get back on firmer financial ground.
