### NY State Student Loan Forgiveness Program

Applications for the [Get On Your Feet](#) program are now being accepted. Students who graduated both high school and college in the State and received an [undergraduate degree in or after the 2014-15](#) academic year and have lived in the state for 12 continuous months may be eligible to have up to two years of federal student loan payments forgiven. To be considered for the program, applicants also have to be enrolled in either an income-based or pay-as-you-earn loan repayment program and have an adjusted gross income of less than \$50,000. Let it be known that any company or organization who singles out a group of individuals in a discriminatory advertisement because of its national origin is unacceptable and will not be tolerated. The advertisement not only offended the Haitian and Haitian-American Community in New York State and throughout the country, but also members of the larger community regardless of their individual ethnic and cultural background.



## Assembly Budget Proposal Eliminates GEA, Restores \$434 Million for Schools



The Assembly budget proposal provides \$25.4 billion in aid for New York's schools, including \$434 million to eliminate the Gap Elimination Adjustment (GEA) that has left schools underfunded and school districts and taxpayers overburdened. It also includes \$1.1 billion in foundation aid, which is targeted primarily to high-needs school districts. The foundation aid is part of a plan to get back on track with a four-year phase-in of the \$4.4 billion in foundation aid that is owed to school districts as part of the historic

Campaign for Fiscal Equity settlement. In addition, the plan includes \$200 million for community schools, a program that offers social, emotional, health and academic supports to students, particularly in some of the neediest communities in the state. Now is the time to ensure our schools have the funding they need to give kids the quality education they deserve. Pictured above, members of NYSUT in Albany.
