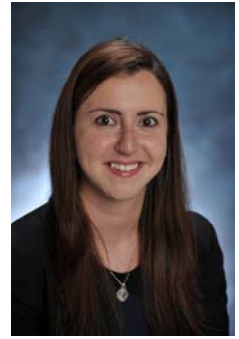

## **PASSING THE MTA SAFETY DATA REPORTING BILL**

On June 10, I passed my second bill - the MTA Safety Reporting Act (A02370/S01238). This bill requires the MTA to submit annual reports on attacks, injuries or deaths reported to it in connection with its facilities and premises. Safety in the MTA has been a major concern for many New Yorkers as there haven't been many reports of assaults, fatalities, and accidents in recent years. I am very proud to see this bill pass the Assembly so that we can ensure that the MTA has an accurate procedure for reporting any unsafe condition that occurs in the MTA system. The system serves millions of New Yorkers and each of its customers and employees deserve to have safe commutes and work environments.

## **CALLING FOR A SOLUTION TO FLOODING**



This month, I stood with Public Advocate Bill de Blasio, community leaders, and neighbors to call on the City to get to work and provide sewer upgrades and more responsive policies to handle frequent flooding in Queens. Our neighborhoods in Eastern Queens flood frequently, and they should be prioritized in capital plans. We emphasized a need for the City to examine plans for both short term flood mitigation, like street landscaping to reduce storm runoff, and reimbursement policies for damage caused by failures in the sewage system. As heavy rainfall events become more common, the City's outdated sewer systems have been overwhelmed, leading to extensive damage from sewage back-ups and flooding into homes. We cannot continue to let Fresh Meadows weather the storm alone.
