# **Assemblymember Rodneyse Bichotte**

Chair, Subcommittee on Oversight of Minority and Women-Owned Business Enterprises

Dear Friends.

This year is a critical year for all Minority- and Women-Owned Business Enterprises (MWBE). In March, the Assembly will be voting on what we hope will be a robust MWBE Program, Article 15-A.

The high-profile Elimination of the \$3.5M Personal Net Worth Cap legislation that I put forward last session, which passed both the Assembly and the Senate, was vetoed by Governor Andrew Cuomo. Another piece of legislation worth noting that was signed into law is the legislation, allows New York City to increase its discretionary spending from \$20K to \$150K, while significant, is still very limited.

This session I have introduced several new Bills including the re-introduction of the Elimination of the \$3.5 Million Personal Net Worth Bill. Some of the other highlighted Bills include:

- Redefining the way an MWBE graduates from the MWBE program in lieu of a personal net worth cap;
- Increase New York City's discretionary spending to \$400K;
- Include MWBE participation goals for any municipality and locality receiving state contracts;
- Conduct a study on the feasibility of a minority- and women-owned business enterprises for capacity building
- Change the finance statute to include DASNY, OGS, DOH, DOT, Thruway, Bridges, and ESD to have capacity building and mentorship programs similar to that of the MTA's capacity mentor program.

I will continue to work as a strong advocate and utilize the recommendations from the 2017 disparity study and those garnered from members of the MWBE community to continue to fight for the strengthening of MWBEs. ## **ARTICLE 15A NYS MWBE PROPOSALS**

## ASSEMBLYMEMBER BICHOTTE PROPOSAL

- **1.** Eliminate the Personal Net Worth requirement (**Bill A9631**).
- 2. Redefine MWBE eligibility to SBA industry size and contract value over a 3-year period with no personal net worth cap (Bichotte Bill pending).
- **3.** Increase NYC discretionary purchase threshold from 150K to 400K (Bill A9813).
- **4.** Unbundle large procurements into smaller contracts (**Bichotte Bill pending**).
- **5.** Amend the finance statute and public authorities law to include a Capacity mentor program for DASNY, OGS, DOH, DOT, Thruway, Bridges and ESD just like MTA (**Bichotte Bill pending**).
- **6.** Ensure that all state funded contracts to municipalities, and school districts have MWBE goals (Bill A453).
- **7.** Provide debriefing sessions for unsuccessful bidders (**Bichotte Bill pending**).
- **8.** Accept DD Form 214 Military Discharge Document to prove ethnicity and / or other required pertinent information such as D.O.B. and address (**Bichotte Bill pending**).
- **9.** Modify the definition of Minority in MWBE for Hispanic to include Latino (**Bichotte Bill pending**).
- **10.** Conduct a study on the feasibility of a minority-and women-owned business capacity enterprise mentorship program on State Agencies (**Bill A230**).
- **11.** Stipulate employment goals for minorities and women in requests for bids to the construction trades.
- **12.** Streamline the MWBE-certification process and outsource to Chamber partnerships and MWBE Consultants (**Bichotte Bill pending**).
- **13.** Remove the barriers to MWBEs that provide the commodities and services currently in the exclusive domain of the Preferred Source Program (Bichotte Bill pending).
- **14.** Institute a Payment Verification Program to ensure subcontractors get paid in a timely manner (**Bichotte Bill pending**).

- **15.** Sole source and single source procurements should be modified to include the MWBE requirements (**Bichotte Bill A240**).
- **16.** Create partnerships with pre-apprentice programs to allow prime contractors to effectively locate workers (**Bichotte Bill pending**).
- **17.** NYS Comptroller should be mandated to put a report in grading all state agencies on MWBE spending similar to NYC Comptroller (**Bichotte Bill pending**).
- **18.** NYS Comptroller should be mandated to produced a comprehensive and Interactive report on MWBE spend (**Bill A427**).
- **19.** Publication of Waivers on each vendor per contract with details of the bid won (**Bichotte Bill A228**).
- **20.** Empire State Development to hire MWBE consultants with the specific goal of reducing contractor violations and to serve as an independent monitor to oversee their compliance (**Bichotte Bill pending**).
- **21.** Create a fund for MWBE investment Manager to manage NYS Pension (**Bichotte Bill pending**).
- 22. Do a Project Labor Agreement (PLA) study to analyze impact on MWBE (Bichotte Bill pending).
- **23.** Pass the Delay Damage Legislation to recover damages for delays on behalf of subcontractors (**Bill A7945a**).
- **24.** Pass the Substantial Completion Legislation which clarify the meaning of substantial completion and a timely correspondence and finish of construction projects.(**Bill A6572**).



## **GOVERNOR'S PROPOSAL**

In the Governor's Fiscal Year 2019 New York State Executive Budget are a few proposals, some we support and some we oppose.

- 1. A proposal to amend the Personal Net Worth Test by keeping the \$3.5 million cap for general purposes, but empower the Director of the Division of Minority and Women Business Development (the Division) to set industry specific personal net worth levels through regulation. (Bichotte opposes. The Elimination of the personal net worth cap, should be law and not be regulated by a director, that is subjective and opens up "pay for play" illegal activities).
- 2. Proposals to expand the State's MWBE law to all "State Funded Entities", including counties, local governments and other entities that receive funding through State appropriation. Currently, the State MWBE Program only applies State authorities and State contracting agencies. (Bichotte supports, Bichotte Bill A453).
- **3.** The requirement that the Division give final decisions on MWBE certification applications within thirty (30) days of submission of a complete certification application. (**Bichotte supports**).
- **4.** The modification of the definition of small business to eliminate the general cap of 300 employees but allowing the Director to set industry specifics levels. (**Bichotte supports**).
- **5.** Amending the role of the "statewide advocate" from a position "to receive" and investigate complaints about compliance with certification delays to a position that investigates contracting issues with State contracting

- entities and with contractors. (Bichotte supports).
- 6. Authorizing the Director to adopt regulations and programs to ensure that MWBE's participate to the maximum extent feasible in State contracting based on (i) contract opportunities, (ii) availability of MWBEs (based on the State's MWBE directory), and (iii) the 2016 Disparity Study. (Bichotte opposes, many of the regulations should be law and not governed/regulated by the director or any one person).
- **7.** Creating a new Workforce Diversity Program under the Executive Law that calls on the Director to establish aspirational workforce goals for minorities and women. (**Bichotte Supports** just as long it reflects the results from the disparity study).
- **8.** Increasing the Discretionary Purchase thresholds for MWBEs from \$200,000 to \$400,000 for state agencies. (**Bichotte supports**).
- **9.** Amending the State Public Building Law provisions on lowest responsible and reliable bidder to direct awards to MWBE firms who qualify as responsible and reliable bidders where the bids of such firms do not exceed 110% of the lowest bid made by a responsible reliable bidder that is not an MWBE. (**Bichotte supports**).
