Before I get to the update from Albany this week, I want to share that I am hosting a town hall meeting on the MTA with **Andy Byford, the President of the New York City Transit Authority** on Tuesday, May 29th from 6:30pm-8:30pm at John Jay Educational Complex (237 7th Avenue) in Park Slope.

As you know, improving our public transit system has been among my top priorities in my time in the legislature. I remain committed to advocating for a plan that will establish a dedicated funding stream to fully fund the MTA's capital plan so that we can upgrade our signals and switches, update our fleet of subway cars and buses, and increase the capacity of sub stations so that trains can run in more rapid succession.


Lobby Day for the Young Voter Act:

This week in Albany, I welcomed 80 high school students from 11 schools around the state to lobby on behalf of the Young Voter Act ([A.6839/A.6840](#)), my bill to lower the voting age to 17 for state and local elections. In addition to lowering the voting age, the bill would require all pupils in the ninth grade or higher to receive at least eight full class periods of civics education and mandate that every New York high school provide each student with a voter registration form in the year that they turn 17. Last May, for the bill's first lobby day – we had 30 students come up to Albany to speak to legislators, this year that number almost tripled.

As a result of the efforts of these wonderful young people, we were able to add another 11 co or multi-sponsors to the bill. **There are now 31 co-sponsors and 2 multi-sponsors on The Young Voter Act** and so much of that is due to the hard work and commitment of these young leaders. It's clearer now than ever that young people should have a say in their future and the best way for them to have a say is for them to have the right to vote.

Assembly Passes Earth Day Legislative Package

I am proud to have co-sponsored several bills in the Assembly's important Earth Day environmental legislation package that passed this week. As the Federal Government continues to roll back environmental protections and jeopardize public health, it is more important than ever for New York State to do everything it can to ensure a safe, healthy environment for its citizens. This important legislation covers a variety of environmental protections, from banning toxic pesticides to protecting communities that have existing environmental hazards from further damage; it guarantees New Yorkers the right to clean air and water and prioritizes keeping contamination like dangerous chemicals and pesticides out of our drinking water.

Some of the most vital elements of the legislative package include bills I am co-sponsoring: [A.6279](#) is a proposed amendment to the New York State Constitution that would ensure that clean air and water are treated as fundamental rights for New Yorkers. [A.8270](#) will address and mitigate the impacts of climate change in the state by establishing the New York State Climate Action Council consisting of 25 members including state agencies and individuals with expertise in environmental issues, environmental justice, labor and regulated industries. It would also establish a Climate Justice Working Group to identify disadvantaged communities for the purposes of co-pollutant and greenhouse gas emissions reductions and the allocation of certain investments. This legislation previously passed the Assembly in 2017.

SCRIE/DRIE Update:

Were you denied or did you lose rent freeze benefits because you were late submitting your SCRIE or DRIE application due to a disability or physical or mental impairment? As a result of the recent settlement of federal class action case *Pfeffer et al. v. New York City Department of Finance et al.*, renters who were unable to appeal or renew their Senior Citizen or Disability Rent Increase Exemption (SCRIE or DRIE) after December 1, 2011, because they needed more time to file due to a disability or physical or mental impairment are now eligible to have their benefits restored or reduced to the prior frozen rent if they are back in the Rent Freeze Program.

If you believe you are eligible based on the criteria above, you can apply to be reinstated to the Rent Freeze Program. Please call my office to request an "Application for Additional Time to Renew Lapsed Benefit" or "Application for Additional Time to Renew Expired Benefit." You may also request an application by calling 311 or going to <http://nyc.gov/rentfreeze>.

Completed applications and all supporting documentation must be submitted no later than **October 26, 2018**. The applications contain instructions for submission. You may contact DOF's disability services facilitator via www.nyc.gov/contactdofeeo if you have any questions.
