Happy New Year! I hope 2024 is off to a good start for all. There are lots of pressing issues that we must address in Albany this year and I will be providing updates as the work of the legislature progresses.

Governor Hochul Announces Proposal Regarding Childhood Literacy Drawing on My Right to Read Legislation

This week, the Governor previewed some of her priorities for the year ahead. I was glad to join her and my colleagues for her announcement regarding childhood literacy that is aligned with my legislation "The Right to Read Act" (A.2897/S.5480). The Governor proposed to devote \$10 million to teacher training on the evidence-based methods, expand SUNY and CUNY's microcredentialing programs for teachers focused on the science of reading, and to require the state to set standards for teaching literacy grounded in evidence-based best practices and for local districts to adopt those standards. Unfortunately, it has to be repeated that for far too long far too many of our children have not been taught to be fluent readers and that is why strong legislation is so necessary. I look forward to working with the Governor and my colleagues in the legislature to make sure that any legislation passed is robust and comprehensive. Accomplishing the changes needed is going to take the continued activism of those of you who have advocated for reforming how we teach literacy in our state, but the progress being made is significant.
