Preserving the Staten Island Resident Discount on the Verrazano-Narrows Bridge



In the 2017 Executive budget, I fought to ensure the continuance of the essential toll relief on the Verrazano-Narrows Bridge for Staten Island residents and commercial drivers with New York State E-ZPass tags. The final 2017-18 budget agreement included \$10.3 million in funding, as well as an additional \$3.5 million to completely offset what would have been an additional rate hike. The Staten Island resident rate is \$5.50 per crossing with E-ZPass and the commercial discount will remain intact. Senator Andrew Lanza and I have successfully negotiated this deal with the Governor's Office and respective leaders in each house and were assisted this year with funding from Senator Diane Savino.


Sign Up for Goethals, Bayonne, and **Outerbridge Crossing Toll Relief**

Currently, the cash toll on at the Goethals, Bayonne, and Outerbridge crossings stands at \$15. Senator Lanza and I have constructed a plan which allows for E-ZPass holders to receive a reduced toll on their third round trip over New Jersey, within a calendar month time frame. Once an E-ZPass holder takes their third trip, the first two trips will be rolled back to \$6.25 toll cost, helping Staten Islanders to save on travel costs. Staten Islanders who want to participate in the three-trip plan must sign-up for the program. TRANSPORTATION UPDATE

West Shore Light Rail



Last year during budget negotiations, Senator Lanza and I obtained a commitment from the MTA for a study of a West Shore Light Rail as another means of transportation for Staten Islanders. This year, the MTA followed through on their commitment with the inclusion of \$4 million in their proposed Capital Plan. This is an important step forward in determining the feasibility of this project.



Opening of the Westbound HOV/Bus Lane on the Verrazano-Narrows Bridge

On September 5th, westbound on the Verrazano-Narrows Bridge Upper Level, the HOV/Bus lane opened. The lane operates in connection with the State's Gowanus/BQE new westbound operation in Brooklyn. The westbound HOV/Bus lane allows for a seamless route from Manhattan to Staten Island, which minimizes travel time for Staten Islanders commuting to the borough during afternoon rush hour. The eastbound HOV/Bus operation over the Verrazano-Narrows Bridge started on June 22nd, and travel time has been reduced for morning commutes due to that lane.

E-ZPass Alerts Program

With the new cashless tolls on the Verrazano-Narrows Bridge, it has come to my attention that constituents have received violations on their accounts due to low balance. In order to alleviate some of these issues, I have provided some information on how E-ZPass customers can track their accounts and avoid having to pay fines. Customers must monitor their account and replenish their account when needed.

To manage your E-ZPass account, you can sign-up for mobile alerts. You will receive a text message whenever something important occurs on your account, such as low balance. To sign up, log in to your account at ezpassny.com, select "Account Profile," then "Edit" in the Account Holder Information section, enter your cell phone number, accept the Terms and Conditions, and opt-in to "Mobile Alerts" or "E-mail Alerts." You can also call E-ZPass Customer Service at 1-800-333-8655 to sign-up for email/mobile alerts.


Update on Construction of the Goethals Bridge






As you know, the Goethals Bridge will have a second span, which is scheduled to be fully constructed by June of 2018. The new Goethals Bridge span will have four 11-foot lanes, plus narrow shoulders.
