A MESSAGE FROM

Assembly Member Rebecca A. Seawright

Dear Neighbor,

Veteran's Day is an important time to reflect and thank the millions of Americans who have risked their lives for our freedom. This day will always be a reminder of the lives that were taken in an effort to achieve world peace. I am grateful for all of those who sacrificed and for all of those who have served and are serving in the United States Armed Forces.

New York State is home to one of the largest veteran populations in the country, with over 900,000 veterans residing in the Empire State. Unfortunately, homelessness is an all-too-common occurrence, as 11 percent of America's adult homeless population is comprised of veterans, with many more considered at risk. Homelessness among the veteran community affects all races, genders and ages. The vast majority of homeless veterans are male, but women veterans are the fastest-growing demographic of homeless veterans in America. Forty-five percent of homeless veterans are African-American or Hispanic and half are under the age of 50.

I understand that this is a serious issue for those who have dedicated their lives for our freedom. Last year, we passed legislation that would direct key state agencies to gather information on the state's homeless veterans and their children in an effort to better support them (A.434-C of 2016). Previously, The Homeless Veterans Assistance Fund was created to help get more of our heroes into quality, stable housing (Ch. 428 of 2014).

Many times, for those returning to the workforce after being out of the country for a substantial period of time, finding a good job can be nearly impossible. That's why I helped pass legislation this year that would waive state application fees for civil service exams taken by honorably discharged veterans (A.1105-B).

We also want our veterans to have ample opportunity to showcase their patriotism and be proud of their service. New York State already offers a number of custom license plates for veterans, and a new law signed this year authorizes the commissioner of the Department of Motor Vehicles to issue plates specifically for AMVETS members (Ch. 105 of 2017). To learn more, visit www.dmv.ny.gov/custom-plates/military-and-veterans. Previously, the Assembly passed a law allowing eligible New Yorkers to have their status as a veteran designated on their driver's license, making it easier to access the many programs, benefits and discounts available to them (Ch. 487 of 2012).

The freedoms we enjoy should remind us of just how much veterans mean to this country. While we should be thanking them each day, Veterans Day is one reminder to reflect on their sacrifices. It's a day to educate ourselves on everything they've done for this great nation. Have a conversation with a local veteran. Listen to their stories. To find more information on Veterans Services, contact your local AMVETS, Veterans of Foreign Wars (VFW), American Legion or Vietnam Veterans of America (VVA) organization. A night at the ‘Rat Academy’

As the rodent problem worsens on the UES, a session hosted by Seawright focuses on prevention methods



As an Upper East Sider for 41 years, Ruth Gutman routinely takes her evening stroll through the neighborhood with her dog. But recently, Gutman has encountered other creatures on her walks down 88th Street between York and East End Avenues — rats.

“Every night, I see them skittle across the road,” Gutman said. “Some look even bigger than dogs!”

While most rats in New York City weigh no more than one pound, according to information from the New York City Department of Health, the rodent nevertheless poses a grave threat to many properties. The problem has been getting worse on the Upper East Side, according to Caroline Bragdon, director of neighborhood interventions and pest control services for the Department of Health.



Eleven tenants and one super attended a “Rat Academy” last Thursday hosted by Assembly Member Rebecca Seawright at the Brearley School. The free educational session instructed attendees on how to keep their neighborhood rodent-free and supplied guests with complimentary heavy-duty, lidded trash receptacles.

Bragdon led the presentation on rat prevention, continuously referring to garbage — also known as an endless buffet for the city rat — as the main culprit for increasing rodent populations.

“We’re trying to make more of an effort to engage property owners, rather than writing them tickets,” Bragdon explained about prevention efforts. Refusal to adhere to pest-control standards results in a fine. Fines begin at \$300 and can be as high as \$2,000.

Both rats and the accompanying fines can be avoided through the prevention methods outlined by Bragdon: inspect, clean and pest-proof.

Step one is to look for evidence of rat activity. Droppings, gnaw marks, and runways all indicate rat activity in an area. Next, Bragdon suggests the removal of any clutter, which could give rats a place to hide, sleep, nest and reproduce.

Since rats only require one ounce of food a day, garbage must also be managed to ensure the elimination of rodents. Garbage cans and bags should be brought to the curb as close to pick-up time as possible. Bragdon encourages the use of hard plastic or metal cans with tight-fitting lids.

“With rodents, you really have to be on the defensive,” Bragdon said about sealing any cracks and holes. Rats only need a quarter-sized hole to enter. She suggests metal door sweeps, sheet metal, and stainless-steel mesh to ensure the disappearance of the nosy visitors.

I would especially like to thank Dr. Christy Gamble and the Black Women's Health Imperative for inviting me and for supporting my legislation. In 2016, the New York State Legislature passed groundbreaking legislation related to Breast Cancer and Breast Cancer awareness which

I co-sponsored. The centerpiece of this legislation guaranteed that in any state-sponsored health plan mammography coverage was to be provided without a deductible or co-payment. The effective date of that law was January 2017. What we noticed with the implementation of the law in the fall of 2016 was that some large insurers were denying coverage to 3D mammography or requiring proof that it was medically necessary. That is when I stepped in," said **Assembly Member Rebecca A. Seawright**.

Attention Rent Controlled Tenants!

This week Assembly Member Seawright signed onto Assembly Member Rosenthal's letter to the Governor in advance of the biennial New York State Division of Housing and Community Renewal (DHCR) Maximum Base Rent (MBR) Hearing to urge him to freeze rents for New York's nearly 50,000 rent-controlled tenants.

Rent controlled tenants are facing a state of emergency in the face of 7.5% increases every year. The vast majority of Seawright's rent controlled constituents are seniors on low, fixed incomes who cannot carry the rent burden. In fact, rent controlled tenants have been facing higher increases than their rent stabilized counterparts.

Seawright is supporting her constituents and thousands of senior citizens across New York City by standing up to provide relief to vulnerable rent controlled tenants. There will be a hearing on the MBR program in New York City on Wednesday, November 29. Please see the notice below for more information.

The morning session of the hearing will be held from 10:00 a.m. to 12:30 p.m.; the afternoon session will run from 2:00 p.m. to 4:30 p.m.

The hearing will conclude when all registered speakers in attendance at the hearing have been heard. DHCR will also accept written testimony submitted prior to the end of the hearing. Zoning Challenge at 249 East 62nd Street

Assembly Member Seawright joined Council Member Dan Garodick and other local elected officials in efforts to support the Friends of the Upper East Side Historic Districts Zoning Challenge filed last week with the Department of Buildings. If constructed as currently approved, the Rafael Vinoly designed building will contain a 152 foot tall octagonal void in the middle of the building. The plans have been reviewed by a certified member of the American Institute of Certified Planners several errors have been found, including arithmetic errors, a 3 ft. side yard that does not meet the 8 ft. side yard requirements and a void which is larger than necessary for mechanical use and is considered in the overall floor area ratio. The Department of Buildings approval and inaction to correct exemptions made in error undermine the zoning resolutions and protections that are in place to protect the public with precise information on the composition of our neighborhoods.

Seawright's Statement on Federal Tax Proposal

Assembly Member Seawright's statement in response to the House's tax reform plan:

"In light of the proposals outlined in the 'Unified Framework for Fixing our Broken Tax Code', I am concerned for my constituents. The cumulative impact of the proposal is ill conceived and harmful to hardworking families across the country with the elimination of the State and local tax deduction the proposal includes a plan to eliminate the state and local taxes deduction that benefits many New Yorkers.

As a Member of the State Assembly, I am committed to fighting for policies and tax structures that are beneficial for New York. The plan that has been put forth will have a detrimental effect on middle-income, hardworking families.

According to a recent analysis by the New York State Department of Taxation and Finance, the elimination of the state and local tax deduction will cost New Yorkers more than \$17.5 billion in additional taxes on an annual basis. As currently proposed, over 1.8 million of New York's middle-income families (those earning \$50,000 to \$150,000) will see an average tax increase between \$1,299 and \$2,688.

New Yorkers already make extraordinary contributions through tax payments to the federal government each year. According to a report issued by the New York State Comptroller Thomas P. DiNapoli, in FFY 2016 New Yorkers sent nearly \$41 billion more in taxes to Washington than they received in federal spending in return. Eliminating critical tax deductions for hardworking families would only further widen this gap," **said Assembly Member Rebecca Seawright.**



A Message from the Chapin School

Following the installation of the tower crane on October 21/22, please be advised that the crane has passed all final tests and inspections by the NYC Department of Buildings' Cranes & Derricks division, and is now ready for use.

Our lifting program will begin this Saturday, November 11, 2017, from 9:00 am - 5:00 pm.

Note: The crane operator and mechanic are required to be on the crane between 8:00 am-9:00 am for pre-work inspection, but no activity will commence until 9:00 am.

This work will not require a street closure. Flagpersons will be onsite to control pedestrian and vehicular traffic while deliveries and lifts are in process, in addition to when trucks are entering or leaving the construction shed.

Additionally, please find, below, a reminder of important information pertaining to work dates, hours, and noise.

Please be advised that, when the crane is lifting steel or equipment, the Occupational Safety and Health Administration (OSHA) requires that a sound amplification device (air horn) be used. This is a safety measure to alert the workers that a lift is underway.
