LEGISLATIVE ACTION

The Legislature appropriates \$2,404,759,080 on an All Funds basis, a decrease of \$37,900,000 from the Executive budget submission.

Legislative Reductions

The Legislature excludes the appropriation authority contained in the Executive's proposal in relation to judicial salary increases.

Legislative Changes

The Legislature provides \$4,000,000 in additional support for Mental Hygiene Legal Services to provide representation to persons subject to the provisions of the Sex Offender Management and Treatment Act enacted by Chapter 7 of the Laws of 2007 and related provisions concerning persons potentially subject to civil confinement under law.

Article VII

The Legislature denies the legislation proposed by the Executive that would increase the Criminal History Search Fee to \$60 from \$52.

The Legislature excludes the Executive's proposal to include funding for judicial salary increases from the budget process, but agrees to continue discussions regarding a judicial salary increase post-budget.
