Description of Aid:

Flow of Funds: State to Local. Monies are provided on a current fiscal year basis for interest payments and appellate costs, and pursuant to contract for cleaning and minor repairs.

Type of Aid: Project Grant and Ongoing

Formulas: Percentage of expenditures by local governments for aided purposes. Ranges: 25-33 percent for interest. Aid percentage within range established by relative taxing capacity: factors are population and value of taxable property. One hundred percent of expenses associated with appellate courts are reimbursable. Beginning in 1998-99, there is a four year phase-in beginning at 25% and going to 100% in SFY 2001-02 for cleaning and minor repair costs.

Maintenance of Effort: See formulas. Also requires compliance with M&O standards and capital plan.
