### Seawright Gathers Fellow Elected Officials To Discuss Westview

On Monday, Assembly Member Rebecca Seawright hosted a group of elected officials at our district community office to discuss Roosevelt Island's Westview. Seawright was joined by State Senator Jose Serrano, Manhattan Borough President Gale Brewer and the Commissioner/CEO of NYS Homes and Community Renewal (HCR) RuthAnne Visnauskas. Representatives from Council Member Ben Kallos' and Congresswoman Carolyn Maloney's offices were in attendance.

**As Featured in the Main Street Wire: "Westview Deal Coming to a Vote"**

The Roosevelt Island Operating Corporation has scheduled a special Board meeting for Monday, July 23, to vote on an amendment to



the Westview ground lease. This means that years of negotiation regarding Westview's exit from the Mitchell-Lama affordable housing program could finally be coming to a close.

The ground lease negotiation has been one of several issues holding up the building's privatization process. Its

potential resolution suggests that the privatization plan is nearing a deal, as RIOC's ground lease terms have been contingent on the building remaining affordable.

On Wednesday, RIOC's Real Estate Development Advisory Committee spent their entire meeting discussing Westview in executive session. The resulting amendment has not yet been released. The meeting is open to the public and will be held at the Roosevelt Island Cultural Center, 548 Main Street.

At the June 28 Town Hall meeting with elected officials, many Westview residents turned out to express their frustration with the stalled privatization plan. Tenants carried signs stating "Don't Screw Westview" and "Save Our Homes." One resident, who blamed RIOC for the delay, went so far as to ask whether it wasn't time to give Roosevelt Island back to the City of New York.

***When Assembly Member Rebecca Seawright arrived, she addressed Westview residents, saying, "You should be upset; you should be angry. I'm angry along with you."***

In the intervening weeks, Westview tenants have continued to scramble for information with little success. At a Westview Task Force Meeting, July 10, only one Westview Task Force member attended, explaining there were no updates. Among the issues concerning tenants are potential rent increases and the question of whether they will have the opportunity to downsize or switch apartments prior to purchasing.

A July 16 meeting brought together the Island's elected officials along with New York State Homes and Community Renewal (HCR) Commissioner RuthAnn Visnaukas, Deputy Commissioner Betsy Mallow, and Attorney Mark Colon. The meeting didn't include Westview owner, David Hirschorn, or any representative from the Westview Task Force.

## Seawright and Krueger Host Forum: "What To Do With All That Stuff"



All of us can say that we have a special relationship with things, sometimes they are things that we cannot part with. For some people, the relationship to items becomes an unhealthy obsession. We hear from constituents every day that their stuff is getting in the way both literally, as they are unable to navigate the inside of their apartment and figuratively, as they

are emotionally unable to detach from their belongings for fear and anxiety. Often times, residents who are struggling with clutter or too much "stuff" present themselves to us at the district community office as someone who is facing a notice to cure or eviction.

That is why on Tuesday, Assembly Member Seawright joined State Senator Liz Krueger to host a forum to help individuals who have accumulated too much stuff, or too much clutter. There were many constituents in attendance which demonstrates the great need for supports for this issue in our community. Information was given by professionals in the social work field to those gathered.



***One presenter at the event said if you don't know whether to keep an item, look at it and say, "do I love it, or do I need it." If the answer is no to both, then it is time to part with the item.***

### **Assembly Member Seawright Attends Forum to Protect Title X**

On Thursday, Assembly Member Seawright attended a forum hosted by Public Advocate Letitia James' office on the threat to defund Title X funded programs by the Trump – Pence Administration.

***“The proposed changes to Title X represent just another stunning example of this administration rolling back the clock on women’s rights. This change is tantamount to a ‘gag rule’ and limits a woman’s ability to access all medically relevant information to make fully informed decisions about their healthcare. It is appalling that any institution that provides abortion services would be prohibited from participating in the family planning program. I want to thank Public Advocate James for holding this very important forum so that elected officials across New York City can work together to fight against this misguided rule change,” said Assembly Member Rebecca Seawright.***

Signed into law by President Nixon in 1970, the Title X National Family Planning Program is the only federal grant program dedicated solely to providing individuals with comprehensive family planning and related preventive health services. Without the funding provided from Title X there will be a drastic change in the ability of individuals to receive family planning assistance along with preventative health services. Title X funding currently supports health care services, including pregnancy testing, contraceptive counseling and services, pelvic exams, cancer screenings (including cervical and breast), sexually transmitted disease testing, and infertility services along with health education and referrals for health and social services. This defunding of Title X will significantly impact the way Planned Parenthood and other providers are able to help individuals get the services they need.



***At a press Conference following the round table discussion Rebecca said, "Enough is Enough! we cannot let this Administration take away access to comprehensive family planning."***

When women and men all across the country rely on publicly-funded family planning services to receive health care, defunding the source that provides such help is detrimental to our society.




#### SCREENING


