Eligibility: Volunteer firefighters & ambulance personnel who: (1) have been NYS residents for at least one year; (2) are enrolled in an approved undergraduate degree program in NYS; (3) have a course load of at least six credits per term; (4) if 23 years of age or older, have less than six months of volunteer service at time of initial award; (5) are not in possession of a baccalaureate degree or higher; (6) are attending a school/institution within 50 miles of volunteer organization, or if no college available within 50 mile limit, the nearest college/institution; (7) have a high school diploma or equivalent; and (8) have applied for state and federal financial aid.

Type of Program and Special Restrictions: Student financial aid for NY residents enrolled in undergraduate degree programs at approved institutions in NYS.

Action Required to Receive Aid: The volunteer organization distributes applications and selects one eligible candidate per year and submits the completed application to NYSHESC. Volunteer organization means ambulance company as defined in section three of the volunteer ambulance worker's benefit law or fire company as defined in section three of the volunteer firefighters law.

Description of Aid:

Flow of Funds: State to school/institution. Payment will be made on behalf of students upon certification of eligibility. Awards will equal the amount of tuition, reduced by any tuition-based grant, but cannot exceed the amount of tuition charged by the State University of New York. Recipients will continue to receive benefits as long as they are continuously enrolled, meet the eligibility requirements and funding is available.

Type of Aid: Ongoing. College financial grant.

Formula: If the number of applicants exceeds funding for the program, NYSHESC shall randomly select recipients from the applicant pool. Recipients of the scholarship in future years is based on funding but preference will be given to renewal scholarships.

Matching Requirement: Applicants are required to apply for State and Federal financial aid.

Maintenance of Effort: Applicant must: (1) file for State and Federal financial aid; (2) maintain a good academic standing; (3) maintain a "C" average; (4) maintain status as an active volunteer with an organization for duration of scholarship; and (5) maintain continuous enrollment in school/institution for duration of scholarship.
