In addition, certain segments of the New York population are now eligible for COVID-19 booster shots to help enhance immunity against COVID-19. Those New Yorkers aged 65 and older or residents in long-term care settings--as well as those aged 50-64 with underlying health conditions--should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least six months after completion of their Pfizer-BioNTech primary series. Assemblywoman Jean-Pierre: Apply for the New York State Covid-19 Pandemic Small Business Recovery Grant Program

"Small businesses are the backbone of our local economy and crucial to our recovery; I encourage all of our small business owners to apply for state grants to address COVID-19 related issues and help support their businesses."

Assemblywoman Kimberly Jean-Pierre: *The New York State COVID-19 Pandemic Small Business Recovery Grant Program is crucial for our recovery*


The \$800 million Small Business Recovery Grant Program is now accepting applications from small businesses, micro-businesses, and for-profit independent arts and cultural organizations that have experienced COVID-19 related hardships.

Grants can be used to cover COVID-19 related losses or expenses incurred between March 1, 2020 and April 1, 2021 including:

- ✔ Payroll costs
- ✔ Commercial rent or mortgage payments for NYS-based property (may not be used for pre-payments)
- ✔ Payment of local property or school taxes associated with a small business location in NYS
- ✔ Utility costs
- ✔ Insurance costs
- ✔ Pandemic-related expenditures to protect the health and safety of workers and consumers
- ✔ Heating, ventilation, and air conditioning (HVAC) costs
- ✔ Other machinery or equipment costs
- ✔ Supplies and materials necessary for compliance with COVID-19 health and safety protocols
- ✔ Other documented COVID-19 costs approved by ESD

Priority will be given to socially and economically disadvantaged applicants including minority and women-owned business enterprises, veteran-owned businesses, and businesses located in communities that were economically distressed prior to March 1, 2020. Additionally, businesses that applied for a PPP loan can still apply to the program.





Applications Now Being Accepted for Emergency Rental Assistance Program

Assemblywoman Jean-Pierre has announced that applications are now being accepted for the federally-funded Emergency Rental Assistance Program (ERAP) which covers households with income up to 80 percent of the Area Median Income (AMI). Applications for a new, state-funded program for households with income between 80 and 120 percent AMI will be accepted through the ERAP application portal beginning September 15.

Assemblywoman Jean-Pierre, Senator Sean Ryan Successfully Push NYS to Extend Emergency Certification Program for Educators

Assemblywoman Kimberly Jean-Pierre and New York State Senator Sean Ryan announced that the New York State Education Department (NYSED) has agreed to take action as a result of the legislators' letter requesting the extension of the Emergency COVID-19 Certificate program past its initial deadline of September 1, 2021. The deadline has been extended one year to September 1, 2022.

The COVID-19 pandemic created obstacles for educators seeking certification and recertification in New York State. Chief among those obstacles was a limited test center availability for certification exams. NYSED recognized these challenges and made temporary emergency changes to certification requirements in May 2020 to account for the difficult circumstances surrounding certification during the pandemic.

In July, with the application deadline for the Emergency COVID-19 Certificate approaching, lingering pandemic-related impediments continued to make it difficult for educators to complete the certification process. As a result, Senator Ryan and Assemblymember Jean-Pierre, who are respectively Chairs of the Senate and Assembly Libraries committees, called on NYSED to extend the application deadline to provide ample time for educators in New York State to get back on track.

In early September, a NYSED representative responded to the legislators' letter, explaining that NYSED recognized the concerns raised in the letter and planned to take action to amend the deadline. A regulatory amendment was then passed at the September Board of Regents meeting on September 14, extending the emergency certificate application deadline from September 1, 2021 to September 1, 2022.

Individuals who applied for the Emergency COVID-19 certificate prior to the extension will automatically have their certificate requirement deadlines extended

The Emergency COVID-19 Certificate is available to a wide variety of educators including classroom teachers, librarians, school administrators, teaching assistants, school athletics coaches, GED instructors, and jobs skills training instructors.

Assemblymember Kimberly Jean-Pierre said, "I sincerely thank the Department of Education and the Board of Regents for extending the emergency certification deadline an additional year to September 2022. With the COVID-19 pandemic severely disrupting the teacher certification process here in New York State, this accommodation will be vital to ensure that schools across our state have the flexibility to hire qualified professionals and ensure the needs of our schoolchildren can continue to be met."

Senator Sean Ryan said, "NYSED created the Emergency COVID-19 Certificate in response to the obstacles the pandemic created for teachers seeking certification, and many of those obstacles are still affecting the certification process today. I applaud the Board of Regents for their swift response to extend the Emergency Certificate deadline to September 2022. Their action has prevented an issue that would have unfairly hindered qualified educators and exacerbated staffing shortages in our schools."

Briana McNamee, Director of Government Relations & Advocacy of the New York Library Association, said, "We are grateful to the Board of Regents for their ongoing support and the recent decision to extend the Emergency Certificate deadline to September 2022. Seemingly minor, this extension provides immense relief for the library community."

Assemblywoman Jean-Pierre Elected Chair of Bipartisan Legislative Women's Caucus

On Wednesday, June 9th, 2021, members of the Legislative Women's Caucus of New York State elected Assemblywoman Kimberly Jean-Pierre (D-Wheatley Heights) as Chair for the 2021-22 term. The Caucus is an organization of elected women members of the New York State Legislature. Today, the Caucus is comprised of a record total of 73 women legislators, including 55 women serving in the Assembly and 18 women serving in the Senate.

"Throughout history, women have played an integral role in government, and being elected Chair of the Legislative Women's Caucus by my colleagues provides me an opportunity to better promote women's issues and improve the participation of women in all areas of government and life," said Jean-Pierre. "I look forward to working with my colleagues in the Caucus as well as women leaders in my community and throughout New York State in moving forward and addressing 21st Century issues impacting women and girls across our great state."



Assemblywoman Kimberly Jean-Pierre was elected to the Assembly in 2014, succeeding Assemblyman Bob Sweeney after he served the 11th Assembly District for 26 years. Prior to her election, she was employed by the Suffolk County Legislature and former Congressman Steve Israel and served as Director of the Town of Babylon's Wyandanch Community Resource Center.

The New York State Legislative Women's Caucus (LWC) is a unique, bipartisan and bicameral organization which was founded in 1983 for all women elected to the New York State Legislature. The LWC serves as a resource for its members, providing networking opportunities, support and various information. The Caucus facilitates an annual Women's History Month display in the Capitol and traditionally holds events with other women partners throughout state government, including commissioners, executive officials and female leaders within the SUNY and CUNY higher education systems.

Over the decades, women legislators through the LWC have advocated for a range of policies that promote equity and inclusivity for women, as well as increased resources for women, children and families throughout New York State. As a bipartisan caucus, the LWC focuses on issues which are embraced by all of its members.

Other officers elected to leadership positions within the Caucus include Assemblymember Carrie Woerner as First Vice-Chair, Assemblymember Mary Beth Walsh as Second Vice-Chair, Assemblymember Karines Reyes as Secretary, Senator Toby Ann Stavisky as Treasurer, and elected Directors include Assemblymembers Marjorie Byrnes, Sarah Clark, Patricia Fahy, Jodi Giglio, Jessica Gonzalez-Rojas,



Assemblywoman Jean-Pierre Passes Legislation to Improve Library System

Assemblywoman Kimberly Jean-Pierre recently announced that four bills she sponsored to improve libraries on Long Island and across the state have passed the Assembly. The legislation includes increased funds for library projects as well as measures to help libraries run more smoothly.

“While they certainly can be a quiet space to dive into a novel, libraries are far more than places to read,” said

Jean-Pierre. “Libraries have served as important centerpieces in our communities for years by providing internet access and educational resources and supporting other local libraries. As chair of the Assembly Committee on Libraries and Education Technology, I’ll continue to do all I can to ensure that libraries receive the funding they need to serve our residents as we continue to recover.”

One of Jean-Pierre’s bills would increase the percentage of total funds appropriated to a library system from 10% to 50% that may be used to support the total costs for projects set to receive state aid beyond 75% of the total project approved costs ([A.7060-A](#)). This change would provide greater discretion in awarding capital grants, a change that would support small and rural public libraries that are disproportionately disadvantaged under current statute, noted Jean-Pierre.

Jean-Pierre also authored and helped pass legislation that would:

- require publishers to offer licenses for electronic books to libraries under reasonable terms, which will help save money and offer more copies of books and literature ([A.5837-B](#));
- requires library board of trustees to take basic training so they can better serve their communities and know how to best allocate public funds ([A.6121-B](#)); and
- extends the time library construction aid can be used, along with adjusting other requirements so library services can be delivered more efficiently ([A.7021](#)).

Assemblywoman Jean-Pierre also helped pass the 2021-2022 state budget, which provided an additional \$20 million for library construction grants for a total of \$34 million.

The budget also restored \$4.5 million in aid to public libraries and increased funding by \$2.5 million, for a total of \$94.2 million.

Assemblywoman Jean-Pierre Co-Hosts Candlelight Vigil for Victims of Haiti Earthquake

Assemblywoman Jean-Pierre recently joined Suffolk County Legislator Jason Richberg and the Town of Babylon from hosting a candlelight vigil to honor all those who perished and continue to suffer from the recent 7.2-magnitude earthquake which struck the Republic of Haiti. The vigil featured prayer sessions from several local pastors and remarks from elected officials and community leaders including New York State Senator John Brooks, Legislator Richberg, Suffolk

County Legislator Sammy Gonzalez, Babylon Town Councilman DuWayne Gregory, New York State Assemblyman Clyde Vanel, and Suffolk County Deputy Executive Vanessa Baird-Streeter. In addition, several boxes of medical supplies were collected which have been transported to Haiti by medical professionals who have been summoned to assist with relief and recovery efforts.

Assemblywoman Jean-Pierre Attends Gun Violence Roundtable in Wyandanch

Assemblywoman Kimberly Jean-Pierre recently attended a roundtable in Wyandanch with other local and state officials to discuss initiatives to prevent gun violence in Suffolk County.

"The gun violence epidemic has long plagued our communities and now, as we've begun to resume our normal activities, this ongoing crisis has only grown worse," Jean-Pierre said. "There's nothing more important to me than keeping Suffolk County families out of harm's way, which means taking steps to protect our youth and ensuring those who are struggling receive the support they need. This roundtable allowed me to work alongside other officials to discuss and implement strategies that will keep our neighborhoods safe from gun violence and encourage a brighter future for all. I thank Governor Cuomo and his team for organizing this important initiative."



Numerous programs were discussed to address the recent scourge of gun violence in Suffolk County, such as the creation of both summer and long-term jobs for at-risk youth. In addition, a variety of summer youth programs will be established at local state parks this summer, including Robert Moses and Belmont

Lake. Other initiatives include hiring new violence interveners to work at existing community intervention programs and expanding assistance for mental health support, substance abuse treatment and family crisis intervention.

Participants at the roundtable included New York State Office of Temporary and Disability Assistance Commissioner Michael Hein, representatives from the Office of Governor Andrew Cuomo, school officials, not-for-profit executives, community leaders, representatives from the New York State and Suffolk County Departments of Labor and other elected officials. This comes after the Governor declared a gun violence disaster emergency in order to strengthen gun violence prevention efforts and allow the state to treat this ongoing problem as a public health crisis.

Jean-Pierre has worked tirelessly to make Long Island a safer place to live, and secured \$100,000 for the Wyandanch SNUG Neighborhood Violence Prevention Program during the past legislative session.



Assemblywoman Jean-Pierre, Cops N' Kids Long Island Host Successful Back-to-School Book Bag Distribution

Assemblywoman Kimberly Jean-Pierre recently joined the nonprofit organization 'Cops N' Kids Long Island' for a back-to-school book bag and supply giveaway for local schoolchildren. All together, more than 100 book bags, notebooks, supply bags, masks, sanitizer and other giveaways were distributed to children and families within the 11th Assembly District. Schoolchildren were also treated to a special read-along with Gretchen Cotton Rodney.

"I would like to thank all of the 11th District residents who supported this year's back-to-school supply drive," said Jean-Pierre. "Because of you, we were able to join together to provide local schoolchildren with the supplies and resources they needed to ensure a positive start to a new academic year. Assemblywoman Jean-Pierre Joins Long Island Elected Officials in Condemning Inhumane Treatment of Haitian Migrants at Nation's Border

Assemblywoman Jean-Pierre recently joined several of her governmental colleagues in denouncing the inhumane treatment of Haitian migrants by U.S. agents at our nation's border. Jean-Pierre, who is Haitian-American herself and the daughter of Haitian immigrants, said the following regarding the incident at the border:

"As an American and the proud daughter of Haitian immigrants, I am disgusted by the recent images depicting the inhumane treatment of Haitian migrants by U.S. agents at our nation's border. For years, our Haitian brothers and sisters have endured unspeakable tragedy and heartbreak from both political turmoil and destructive natural disasters, and this kind of treatment undermines the moral values that are supposed to define the America we all know and love. I expect the Department of Homeland Security to conduct a swift and thorough investigation into this matter so that these officials are held accountable for their actions."

According to the American Jewish Committee (AJC) landmark [State of Antisemitism in America Report 2020](#), which will soon be followed with the release of the 2021 report later in October, 46% of the general public doesn't know what the term antisemitism means. - Acids • Aerosols • Antifreeze • Automotive fluids/care products • Chlorine • Cleaning products • Driveway sealer • Fluorescent bulbs • Freon canisters • Full propane cylinders • Gasoline • Granular fertilizer containing insecticide • Herbicides • Mercury containing products • Oil paints and stains • Pesticides/insecticides • Pool Chemicals • Solvents • Thinners and reducers.

The following items **will not be accepted** under the STOP program but may be brought to the Residential Recycling Center Monday through Friday between 8:00 a.m. and 3:00 p.m.: • Alkaline and rechargeable batteries • Construction and demolition debris • Kerosene • Latex paint • Non-hazardous recyclable materials • Tires.

Ammunition, Asbestos, Explosives and Radioactive Materials are **unacceptable** under the STOP program or at the Residential Recycling Center and must be disposed of legally and safely.
