A Message from Keith:



A New Year, New Beginnings

The New Year is upon us! With shorter days and frosty nights, our thoughts turn to resolutions and new beginnings. I hope this year will be a memorable one. Be sure to plan a winter adventure - take a hike, ski, ice skate or visit a museum. Whatever you choose, our great State and amazing Island offer plenty of festive events and winter activities to enjoy!

Getting to Work in Albany

With the fun of the season also comes the work of the New Year and the start of the Legislative Session. My staff and I have been working hard to prepare for the months ahead. I've met with constituents, town leaders, civic organizations, and State and Federal officials to develop legislation and programs that will benefit District 12 and the State of New York. I believe this will be an exciting and productive Session.

Addressing Artificial Intelligence Responsibly

As we enter 2026, one of my top priorities is how New York addresses artificial intelligence. In this era of AI misinformation and unmarked AI-generated content, it is critical that we set clear parameters. Bill A9097 would require disclosure of Artificial Intelligence use to clients, criminal defendants, and courts in legal proceedings. Bill A9091 would require search engines to inform users when content is generated using Artificial Intelligence. Following the introduction of this legislation, I met with a Google representative to discuss the industry's responsibility to better police itself. AI is a powerful tool, but it must be used responsibly and with proper oversight. I am also working to organize an AI Forum featuring experts from the State University System to help educate policymakers and the public.

Supporting Our Youth and Families

The wellbeing of our youth remains a major focus. As the Ranking Minority Member of the Committee on Alcoholism and Substance Use, I am committed to addressing the substance use crisis affecting our children. I introduced A9287, legislation to regulate the sale of nitrous oxide and establish education and outreach programs addressing its misuse. This fall, my

office helped organize the Long Island Co-Occurring System of Care Committee at Molloy College, bringing together clinicians, service providers, academics, state agencies, and county leaders to advance a true “No Wrong Door” approach to care. I also continue to proudly support Outreach Long Island and was honored to speak at the ribbon-cutting ceremony for their new Young Adult Residence, which will provide vital services for youth in crisis.

Improving Road Safety

Keeping our roads safe is another key priority. I recently introduced A9331, legislation that would: Require slow-moving vehicles, trucks, and buses to use the right lanes on multilane roadways. Add “No Truck” pavement markings to left lanes on certain highways. Locally, I’m pleased to report that the NYS Department of Transportation has begun investigating traffic safety conditions on Main Street in Huntington Village following a recent pedestrian fatality.

Honoring Our History Ahead of America’s 250th Anniversary

In 2026, our nation will celebrate its 250th anniversary. I’ve been working with Suffolk County, the Town of Huntington Historical Society, and the Town Historian to create a digital Huntington Revolutionary War Trail, now available on Bloomberg Connects. I encourage you to explore it. My staff and I have also been assisting with the cleaning and repair of the twenty Revolutionary-era cemeteries throughout our district, honoring the brave men and women who helped found our nation. So far we have cleaned up seven, thirteen more to go in time for the Fourth of July, 2026.

Standing with Our Veterans

There is no greater honor than serving those who have served our country. Many veterans are facing serious challenges, and we are currently working to establish a veterans’ mental health coalition to support those who feel they have nowhere to turn.

Meeting with Our Federal Officials

A recent highlight was spending two amazing days in Washington, DC with my colleagues from the NYS Assembly Minority Conference, meeting with several federal officials, intergovernmental affairs personnel and Members of Congress. I was happy to have made a lot of connections and discussed many issues affecting AD 12, such as the Asharoken Sea Wall capital needs, diversifying our power generation portfolio to meet our growing energy needs and keep the Northport Power Station relevant, the Veteran Suicide Crisis and the current condition of the Northport VA, and strengthening our system of care for our most vulnerable residents with Co-Occurring Disorders, educating our kids about mental wellness in school and stopping the flow of fentanyl across BOTH of our borders! I came back energized and have already begun my follow ups!

Moving Forward Together

It is an honor to represent the residents of District 12. I remain committed to making our community and our State safer, healthier, and stronger. In the coming year, I will continue working to protect our shoreline and build a more secure and prosperous future for all. Thank you for your continued support and for entrusting me with the privilege of serving you in the New York State Assembly. I wish you a year filled with peace and prosperity.

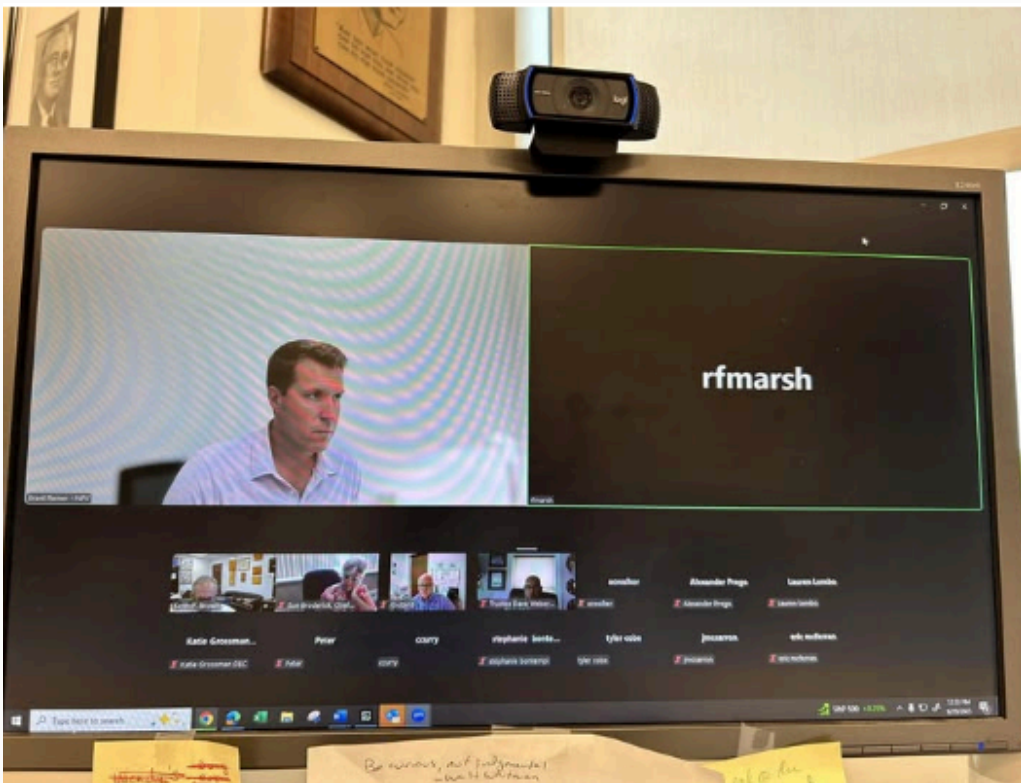


Grand Opening of Emma Stebbins: Carving Out History!

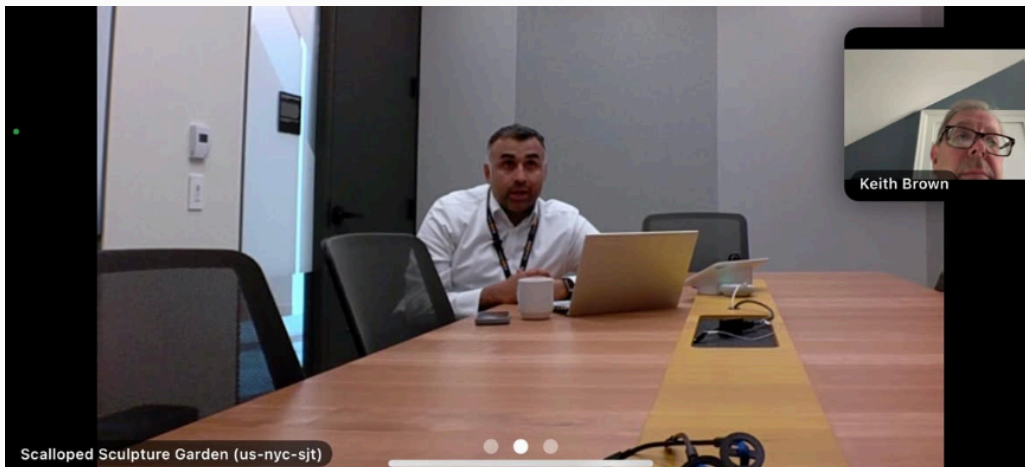
Huntington Townwide Fund Oktoberfest Fundraiser

We held a zoom call last week where I told them that the entire industry has to do a better job of policing itself and take responsibility for what it is putting out there.

A1 is generating information called “Hallucinations” or literally “Bullshit” when it doesn’t know the answer and people are spreading it as if it’s fact.
My bill is designed to address this by alerting users clearly stating that the information is AI generated and not factual!

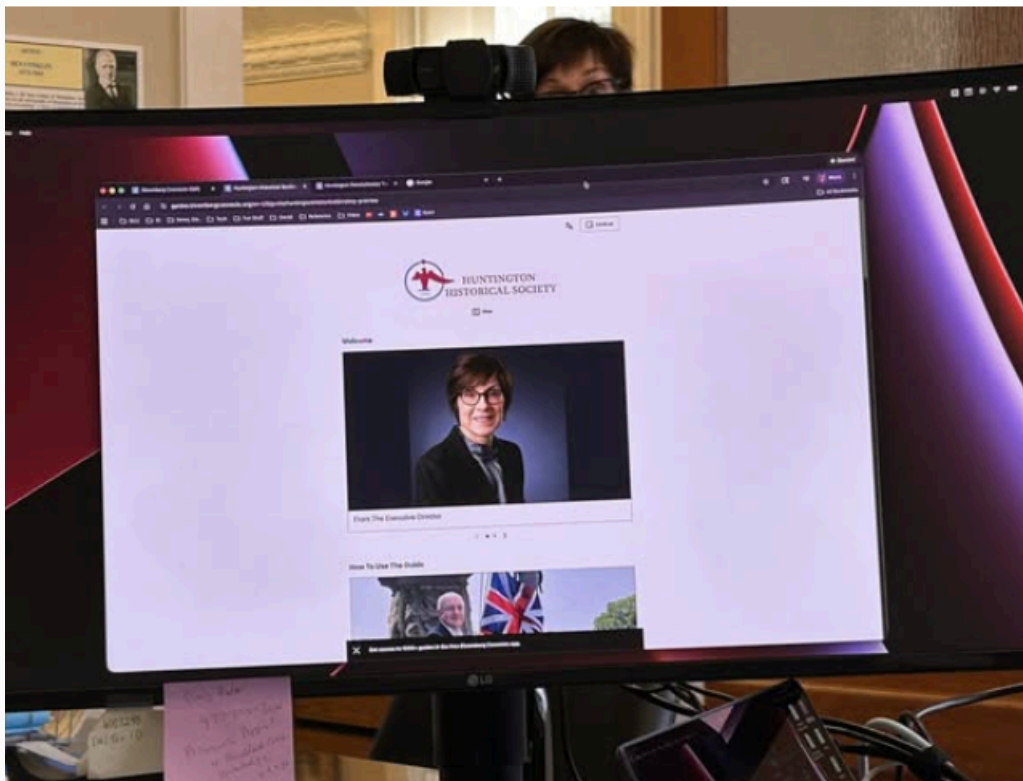
Meeting with Island Harvest

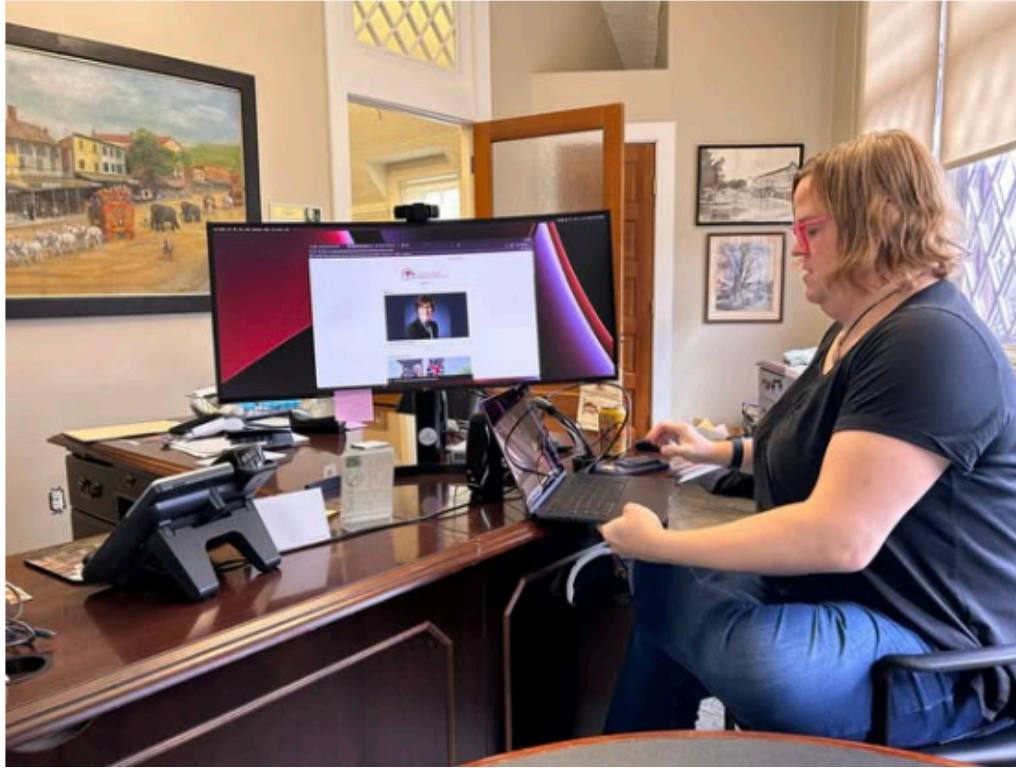


Huntington Revolutionary War Trail

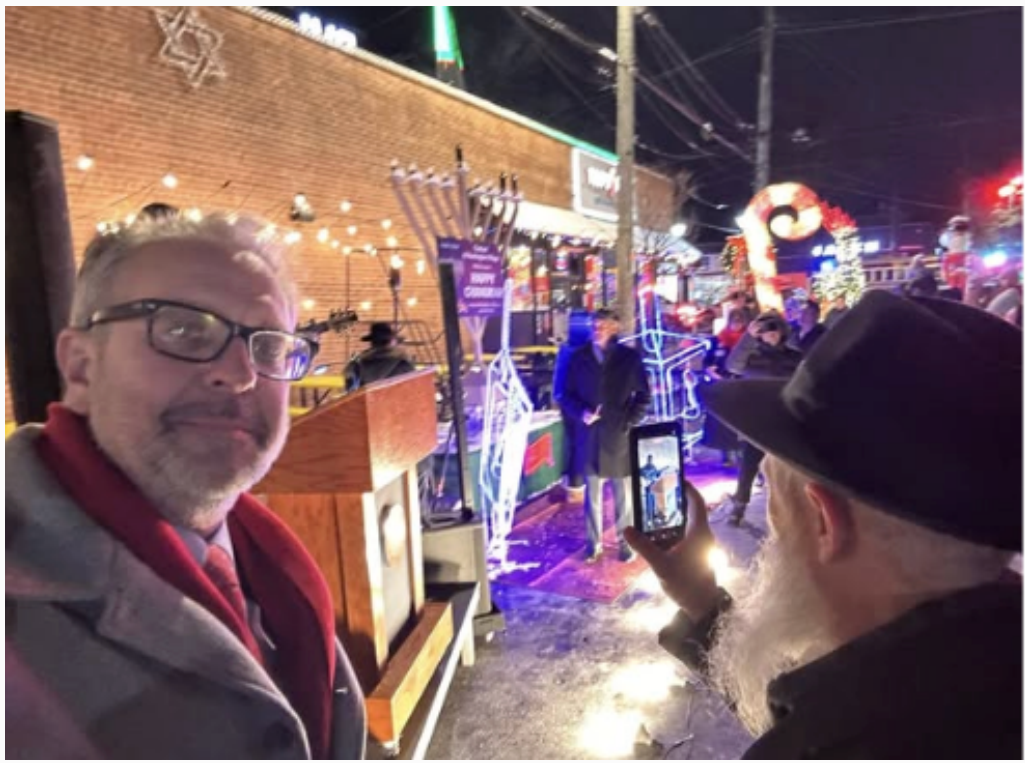
Mourning the Victims of Anti-Semitism this Hannukah
