Please find below essential updates on funding and legislative matters that directly impact you.

## **Funding Update:**

- West Hempstead Public Library \$125,000- Various upgrades to the facility (2019-20)
- Lakeview Public Library \$125,000- Renovation of the facilities third floor (2021-22)
- West Hempstead Union Free School District \$250,000- Purchase and installation of one underground oil tank (2023-24)
- Lakeview Public Library \$125,000- Renovations to facility (2023)

**A05679** Declares racism a public health crisis and establishes a working group to promote racial equity throughout the state (2021-22) Signed in to Law Chap.775 12/21/2021

**A07599** Relates to the secondary enforcement of certain motor vehicle equipment violations (2021-22) Signed into Law Chap.751 12/23/2022

**A07601** Relates to the execution of warrants in juvenile delinquency cases when family courts are closed (2021-22) Signed into Law Chap.456 10/08/2021

**A05994** Relates to research and restricting advertisement and promotion of electronic cigarettes (2023-24) Signed in to Law. Chap.566 10/25/2023

**A07393** Extends provisions of the public health law related to the redeployment of excess reserves of certain not-for-profit managed care organizations (2023-24) Signed in to Law Chap. 197 (7/19/2023)

**A07480** Authorizes the transfer of memberships for certain members of the New York state and local police and fire retirement system to the New York state and local employees' retirement system (2023-24) Pending upcoming Session

Dear Residents of District 18,


