Assemblywoman Solages meets with concerned residents over JFK runway expansion

Assemblywoman Michaelle Solages of the 22nd District held an open public forum on Tuesday, October 29, 2013, at the Elmont Memorial Library to discuss the airplane noise over Nassau.

This forum was in direct connection with Governor Cuomo's decision to have the Port Authority conduct noise studies for LaGuardia and JFK airports and to establish a community roundtable for airport noise and related issues in collaboration with the Federal Aviation Administration (FAA) and other stakeholders.

Assemblywoman Solages has been critical of the decision by the FAA to move forward with the permanent implementation of changes in departure procedures at LaGuardia Airport, in conjunction with specific runway configurations at John F. Kennedy Airport, that has resulted in an excessive increase in noise and air pollution throughout Nassau. Assemblywoman Solages in conjunction with other elected officials and community leaders throughout Nassau, continue to encourage the FAA to amend the new flight pattern and revert back to the old schedule.

Attendees at the forum voiced their myriad of concerns. Many raised issues regarding the serious negative impacts the project would have on the

community and the environment. While other residents who live in the area for more than 20 years expressed how the quality of life has deteriorated since the implementation of these new flight patterns.

Members of the Port Authority in attendance have agreed to work with the community to improve the quality of life for residents who live near, around and under the facilities operated by the Port Authority.

The meeting ended with the promise by Assemblywoman Solages and the Port Authority to work together with the Governor's office in order to address and alleviate the nuisance of air traffic noise.
