ASSEMBLYWOMAN SOLAGES' LEGISLATIVE VICTORIES

The 2019 Legislative Session adjourned with historic and progressive reforms. Assemblywoman Solages had a robust session, in which she passed thirteen bills through the New York State Assembly. Please review some of the passed bills below:

Improving the Southern State Parkway

Announcement of the passage of Assembly Bill A6761-A, mandating NY State Department of Transportation to coordinate with local governments to conduct a study of the configuration and signage at entrance/exit ramps on the Southern State Parkway.



Bolstering Protections for Small Businesses

Assemblywoman Solages drafted and passed Bill A2946 which establishes the Small Business Crime Prevention Services Program. This provides small businesses with information on strategies, best practices, and programs offering training and assistance in the prevention of crimes.



Reforming Industrial Development Agencies

Assemblywoman Solages championed legislation that requires the live streaming of Industrial Development Agency (IDAs) meetings. This law also requires IDAs to post the video recordings of all open meetings and public hearings to their website. In addition, Assemblywoman Solages passed Bill A2947 requiring notice to and confirmation by affected local taxing jurisdictions and school districts prior to the approval of projects by Industrial Development Agencies.



Increasing Protections for Women

Assemblywoman Solages passed legislation, which has been signed into law, making it professional misconduct for a provider to supervise or perform a pelvic exam on an anesthetized or unconscious patient without first obtaining the patient's informed consent, unless the pelvic exam is part of a medical procedure or the patient is unconscious and the pelvic exam is medically necessary and required for diagnosis.



2019 NYS Budget Highlights

With a Fiscal Year 2020 (FY2020) Enacted Budget of over \$175 billion, New York State is one of the driving economic forces of the United States. Each year, Assemblymember Solages' goal is to ensure that the state budget is reflective of the values in her district.

Due to the newly installed majority in the Senate, we had the opportunity this year to take steps to address the climate crisis, codify provisions of the Affordable Care Act, increase school aid funding by \$1 billion, and implement new criminal justice reforms. The Fiscal Year 2020 (FY 2020) Enacted Budget gives all New Yorkers a voice. From the public-school student who deserves every opportunity to achieve their goals, to the tenant whose quality of life has declined for far too long, to the hardworking parents struggling to afford childcare costs, and the families torn apart by the opioid crisis, the budget strives to improve the quality of life for all.



Bringing Universal Pre-K to Long Island



Prioritizing Education Funding

Assemblywoman Solages has long championed increasing education funding. The FY 2020 Enacted Budget will include \$27.86 billion in funding to General Support for Public Schools, an increase of \$1 billion, or 3.7 percent, over the 2018-19 Budget.

The spending plan also includes a \$618 million increase for Foundation Aid for a total of \$18.4 billion to help fund the state's obligation to our neediest schools. The approved budget allocates \$50 million for Community Schools Aid for a total of \$250 million in education funding.

Numerous studies prove the positive and long-lasting impacts of engaging children at an early age and its beneficial impacts on their behavioral, emotional, and intellectual development. This legislative session, Assemblywoman Solages, in coordination with Senator Martinez in the Senate, secured \$475,000 in funding for a Regional Pre-Kindergarten Technical Assistance Center (RTAC) on Long Island. The RTAC will implement best practices, tether Pre-K and early childhood education community programs to the K through 12 educational system, and serve as a model for New York State.

Tackling the Climate Crisis



Assemblywoman Solages supported the NYS Climate Leadership and Community Protection Act, which is a comprehensive bill that sets critical environmental standards, including reductions in greenhouse gas emissions and increasing the use of renewable energy.

Restoring Medicaid



The approved budget restores \$550 million in Medicaid cuts, including \$222 million for a two percent rate increase for hospitals, a 1.5 percent increase for nursing homes, \$190.2 million for the 0.8 percent across-the-board Medicaid claims cuts, and \$137.8 million for the hospital Indigent Care Pool.

The plan also provides \$31 million for the restoration of pharmacy benefits, including \$18.7 million to preserve prescriber prevails provisions, and \$12.3 million to maintain coverage for over-the-counter (OTC) drugs and prevent copay increases.

Reforming Criminal Justice



Ensures the Right to a Speedy Trial: The budget also enacts a necessary reform of the speedy trial provisions in New York's Criminal Procedure Law. Under New York's statutory speedy trial law, the prosecution must generally be "ready for trial" within six months for a felony charge and 90 days for a misdemeanor charge.

Transforms the Discovery Process: The budget law also includes reforms to the laws governing the exchange of information in criminal cases. Under the new law, the prosecution will be required to provide discovery to the defense within 15 days after arraignment and will have to make certain disclosures before most negotiated guilty pleas.

Building a Park in South Valley Stream



The Path to the Park Project has been completed. After Superstorm Sandy, Assemblywoman Solages helped secure \$3.8 million to help transform a public greenway in South Valley Stream. The project enhances the community's resiliency against future storm events, promotes waterfront access and provides additional opportunities for recreation.
