

I hope you are enjoying the summer and staying cool during the hot weather. It continues to be my pleasure to represent

District 24 and advocate on your behalf in the state legislature.

I am excited to announce that this legislative session was the most productive in our state's history and once again many of my bills have passed both houses of the legislature and have been signed or await the Governor's signature. Notably, many of the bills directly address issues brought to light by local community members. This year both houses were able to pass laws guaranteeing adoptees access to their birth certificates, prohibiting discrimination based on religious attire or appearances, authorizing a study to expand the Long Island Motor Parkway, and holding utility companies responsible for damages. You can read more about these bills in this newsletter.

While the legislature is not in session, it is my hope that we will meet at the many community events in the district. 
Celebrating Israel with Governor Cuomo

2019 Legislative Accomplishments

Working with his colleagues in the State Senate and State Assembly, Assemblyman Weprin was able to pass a number of important bills. Below you will find the bill numbers and a short description of the bills that were passed.


Aiding WTC Responders

A8278 - Assemblyman David I. Weprin's and Senator James Gaughran's bill provides disability retirement benefits to civilian public employees who aided in the 9/11 recovery efforts. Many public employees suffering from illnesses and unable to work could not claim the same benefits as uniformed employees causing financial hardships.

Ensuring Adoptee Rights

A5494 - Assemblyman David I. Weprin's and Senator Velmanette Montgomery's Clean Bill of Adoptee Rights passed after a decades long push by advocates and lawmakers. The legislation establishes the right of adoptees to receive a certified copy of their birth certificate upon reaching the age of 18. The legislation restores important civil rights to adult adoptees such as their right to access information that non-adopted persons have a legal right to obtain. In New York State, an adoptee cannot access his or her original birth certificate unless the adoptee goes through a judicial proceeding which does not guarantee that access will be granted.

Holding Public Utilities Responsible

A5254 - Assemblyman David I. Weprin's and Senator John C. Liu's bill requires public utility companies to repair or replace residential sewer and water pipes that they damaged. The legislation changes the current law which assigns responsibility to homeowners for repairs, regardless of who caused the damage, and was inspired by the plight of dozens of Queens homeowners who found themselves responsible for costly damages caused by Verizon.

Extending the LIMP Trail

A6413 - Assemblyman David I. Weprin's and Senator John C. Liu's bill commissioning a study of a proposed extension of the Long Island Motor Parkway trail, which runs through Fresh Meadows, Oakland Gardens, and Queens Village, awaits the Governor's signature. The historic parkway originally ran from Queens to Ronkonkoma but currently only small sections remain in use serving pedestrians and bicyclists.

Safeguarding Religious Freedom

A4204 - Assemblyman David I. Weprin's and Senator John C. Liu's bill prohibiting discrimination against religious attire and appearances was signed into law on 8/9/19. The bill was first introduced by Weprin in 2011 and is intended to protect the religious freedom of all New Yorkers in the workplace. It was inspired by the case of Kevin Harrington, a Sikh subway operator for the MTA, who was ordered to remove his turban or deface it with an MTA logo.

Additional Legislation that Passed Both Houses

A3985 - Establishes a new crime of staging a motor vehicle accident for the purposes of committing insurance fraud. Signed into law 8/8/19.

A4000 - An act to amend the administrative code of the city of New York to prevent banning members of the police force from wearing hearing assistance devices who can fully perform police duties with the use of such device.

A4336 - Requires that an un-redacted report regarding the death of any inmate be issued to the governor, the chairman of the Assembly Committee on Correction, and the chairman of the Senate Committee on Crime Victims, Crime and Correction.

A6849 - Amends the Correction Law to make it clear that visiting legislators may bring their staff into correctional facilities.

A7647 - Amends the Correction Law to authorize the pre-arraignment detention of arrested individuals in a county jail facility, when done as part of a plan for an off-hours arraignment part established by the Chief Administrative Judge.

A7751 - Amends the Criminal Procedure Law to allow a trial court to suspend jury deliberations for up to three days (excluding weekends and holidays) in appropriate cases.

A7944 - Amends the Correction Law, in relation to the designation of a substitute jail for programmatic purposes, allowing for an inmate's transfer between local correctional facilities for participation in beneficial programming.

A7994 - Establishes an arts fund to receive contributions for the support of the New York State Council on the Arts through a personal income tax return check-off.

A8138 - An act to amend the real property tax law, in relation to the determination of adjusted base proportions in special assessing units which are cities cap the maximum class growth rate at zero percent for fiscal year 2020.

Assemblyman David I. Weprin hosted the American Italian Cancer Foundation Mammogram Van at his Richmond Hill District Office. Local women were able to receive free breast cancer screenings and health education services. Screenings are important because it's estimated that there will be nearly 270,000 new cases of invasive breast cancer in 2019.

Measles Immunization Testing

In May, Assemblyman David I. Weprin co-sponsored a measles immunization testing event with Kamin Health at the Young Israel of Jamaica Estates in response to the measles outbreak in New York. Hundreds of people participated and the Assemblyman received an MMR titer blood test to ensure that he had retained immunity to measles since his initial immunization.

Disability Pride Parade

The parade has been held each year since 2015 to celebrate and raise awareness for people with disabilities.

Alley Pond Park Compost Giveback

Assemblyman David I. Weprin in partnership with Council Member Barry S. Grodenchik and the Department of Sanitation distributed 300 bags of compost made from New York City organic waste at Alley Pond Park in Queens Village. Food scraps comprise about 20% of our City's waste and creating compost from this material reduces landfill disposal costs and greenhouse gas emissions.

Celebrating Academic Success


Walkill Correctional Facility Visit
