

### COVID-19 SUPPORT

In May, the Legislature convened to pass a number of bills that provide additional support for New Yorkers battling the COVID-19 pandemic including rental assistance for New Yorkers, improvements to the UI claims process, and measures to support small businesses. This included legislation that protects critical library and school funding, ensures unemployed workers receive the benefits they need and protects health care workers and at-risk populations. Furthermore, in July the Assembly and Senate passed a second package to help small businesses provide PPE, keep contract tracing information confidential, and protect New Yorkers as they return to the work force.

### CRIMINAL JUSTICE REFORM

In June, following the deaths of George Floyd and Breonna Taylor, the State Legislature passed a comprehensive criminal justice reform package that will help ensure that police officers with poor disciplinary records are held accountable, promote transparency in law enforcement, and continue building trust between police departments and the communities they protect.

Following the reforms enacted in June, both the Assembly and Senate acted on a number of bills that I prime sponsor in the Assembly that will increase oversight in correctional facilities in New York State and prohibit discrimination based on religion in our prisons. This legislation is being sent to the Governor for his approval and signature.

### SAFEGUARDING ELECTIONS

In order to help safeguard our elections and provide safe options for people to vote, the legislature has passed and enacted a number of reforms and changes to ensure election security, provide for smoother voter registration, safeguard and streamline the absentee ballot process, and make sure that ballots for people voting from home are sent early and on time.

It is common sense to provide options for people to vote from home with an absentee ballot during the pandemic and I am proud to have supported these measures that will ensure that every New Yorker will have a voice and chance to participate in our elections.

### Hand Sanitizer and Face Mask Giveaway



My office hosted a hand sanitizer and facemask giveaway in June distributing over 40,000 surgical and cloth masks and over 1,000 bottles of sanitizer to individuals and organizations in the 24th Assembly District. Wearing a mask and using hand sanitizer can help prevent the spread of Coronavirus (COVID-19) and is recommended by the US Centers for Disease Control, New York State Department of Health, New York City Department of Health, and World Health Organization.

### Meal Delivery for Seniors with the Commonpoint Y Queens



I was glad to join Assemblywoman Nily Rozic, Commonpoint Y CEO Danielle Ellman and my staff member Ben Herman to deliver meals to our homebound seniors and immunocompromised individuals. ### Khalsa Aid USA & Ahmadiyya Mosque Food Delivery Partnership



My office has been glad to partner with the Ahmadiyya Muslim Community Center and Khalsa Aid USA to help connect individuals seeking food assistance with quality meals. Since April 6, the mosque has delivered 52 hot meals to seniors each day, partnering with Khalsa Aid, has distributed 500 meals from the mosque 6 days a week, and has delivered prepared meals to 150 low-income families six days a week.

### COVID-19 and Advanced Cardiovascular Testing with Councilwoman Adrienne Adams



My office has partnered with the office of Councilwoman Adrienne Adams and Dr. Perry Frankel of Advanced Cardiovascular Diagnostics through the first half of the year to bring mobile COVID-19 testing, antibody testing and Cardiovascular Testing to locations in Richmond Hill.

Sites where we have been able to offer these services include the Faith Assembly Church in South Richmond Hill, Baba Makhan Shah Lobana Sikh Center in Richmond Hill, and the Richie Rich Palace Restaurant in Richmond Hill, located across the street from my Atlantic Avenue District Office.

### Standing Against Gun Violence



In July, I joined District Attorney Melinda Katz, Queens Borough President Sharon Lee, and a large group of elected officials and community organizations from all around Queens for a peace rally against gun violence. I also joined the Queens Jewish Community Council for a car caravan to show appreciation for officers at the 107th Precinct in Fresh Meadows and the 111th Precinct in Forest Hills, who have been responding to calls and emergencies through the pandemic.

### Census Week Press Conference



In an effort to encourage Queens residents to complete the 2020 Census, I participated in a number of outreach events in Richmond Hill for Census Week 2020, July 27 to August 1, including a hand sanitizer and mask giveaway at Phil "Scooter" Rizzuto Park in South Richmond Hill with Queens Borough President Sharon Lee, Councilwoman Adrienne Adams and Councilwoman Karen Koslowitz.

As of July 23, Queens' overall response rate was 53.8 percent, with a response rate of 44% in Richmond Hill. The New York state response rate is 57.9 percent and the nationwide rate is 62.3 percent. 
