

Dear Friends,

I hope this message finds you well. This summer has been a vibrant, busy time in the 24th Assembly District, filled with activity, cultural events, conversations, and celebrations.

The 2024 Legislative Session, which concluded on June 8th, saw us adopt many common-sense legislative initiatives that are now being considered by Governor Kathy Hochul and signed into law. I'm proud to have passed 13 bills this year and I'm a prime co-sponsor on many more that will benefit all New Yorkers. Governor Hochul has signed important measures into law including protecting our youth from harmful online content, retail theft prevention measures, and innovative regulations for lithium-ion batteries and e-scooters.

Like many residents throughout the five boroughs and across the New York Metro Area, I was pleasantly surprised by Governor Kathy Hochul's decision to "indefinitely pause" the implementation of congestion pricing. As the countdown to the June 30th implementation neared, everyday New

Yorkers did what we do best: we spoke up for ourselves and said we won't accept a bad deal! I applaud Governor Hochul for having the courage, not just to listen to us, but to take a tough stand against this misguided policy. New Yorkers should not have to pay the price for the MTA's shortcomings and I will explore alternative revenue streams. I will continue to fight against this unfair congestion pricing tax.

I am also pleased to report that the NYC budget included full restoration of \$58.3 million for the library systems. This funding will help the Queens Public Library support their programming and staffing, and reopen the Hillcrest branch that so many of us use.

My staff and I are ready to assist you should you have any questions, comments, or concerns. No Congestion Pricing!

My opposition to the congestion pricing program has been long standing and unwavering for almost two decades. I fought the policy as a member of the New York City Council, and I am still in the fight as your representative for New York's 24th State Assembly District. I have held and attended multiple press conferences in Albany, Queens, and Staten Island to call for a full elimination of congestion pricing. Congestion pricing is not the answer and we need to find alternative revenue sources for the MTA without burdening New Yorkers.







Assemblyman Weprin joins multiple stakeholders and bipartisan elected officials to oppose the implementation of congestion pricing, including the United Federation of Teachers, United Firefighters Officers Association, and the Trucking Association of New York.

Cracking Down on Retail Theft

This year's 2024-2025 State Budget creates new protections for retail workers and small business owners and enacts targeted strategies to fight organized retail theft. These new protections include increased criminal penalties for anyone who assaults a retail worker and \$5 million in tax credits for small business owners to invest in added security measures. The budget also makes it illegal to foster stolen goods and authorizes prosecutors to combine the value of stolen goods when bringing a case against thieves. I was proud to support and vote for these pro-worker, pro-business measures.

Protecting Our Kids Online

As a cosponsor, I was proud to join Governor Hochul as she signed the Stop Addictive Feeds Exploitation (SAFE) For Kids Act (A8148A) to require social media companies to restrict addictive feeds on their platforms for users under 18 as well as the New York Child Data Protection Act (A8149A) to prohibit online sites from collecting, using, sharing, or selling personal data of anyone under the age of 18. Since the pandemic, our youth have become more attached to their devices than ever before. These bills will help safeguard our youth when they go online.

Fighting for LGBTQIA+ Community

I stood with Governor Hochul as she signed a package of bills including A8834B, which I sponsored. As Chair of the Committee on Insurance, I re-established that insurance companies cannot discriminate based on race, religion, age, color, nationality, disability, gender, sexual orientation, or prescribed medication. This bill codifies Department of Financial Services regulations prohibiting discrimination against individuals who were prescribed pre-exposure prophylaxis, otherwise known as PrEP, medication for HIV prevention, with respect to life, accident, and health insurance coverage. We still need to fight for LGBTQIA+ rights and challenge discrimination wherever we see it.


Giving to the Community with River Fund
