I'm pleased to report that 7 of my bills have been signed into law, along with another 31 additional bills that I've co-sponsored. We are already meeting with community groups and advocacy organizations to prepare priorities for the 2025 Legislative Session. As the Chair of the Assembly Committee on Insurance, I am committed to fighting fraud, ensuring market stability, and broadening coverage while bringing costs down for policyholders. We are facing many challenges - both statewide and at the city level - and we will be entering a new presidential administration. It is incumbent upon us to find ways to work with the new administration for the benefit of all New Yorkers, and I look forward to finding common ground and productive solutions.

I've been privileged to join communities throughout the 24th Assembly District for celebrations and commemorations. I look forward to continuing to share in these important moments and milestones as we welcome the holiday season.

Resilience & Flood Prevention

This year we observed the third anniversary of Hurricane Ida, remembering the lives lost and the terrible damage the storm caused. I'm pleased to report that the NYC Department of Environmental Protection has invested \$1.2 billion in anti-stormwater flooding projects and strategies to fortify communities against climate change. I joined the DEP for one of their Flood Preparedness Town Halls in Jamaica, which was an informative presentation that included a Q&A session and the distribution of 200 flood preparedness kits to attendees. In September we celebrated the completion of two flood mitigation projects in Eastern Queens: the conversion of three acres of concrete medians

in Queens Village into a system that can collectively manage 5 million gallons of stormwater, and an innovative porous pavement project in Jamaica Estates. While there is no single solution to these extreme weather events, we are deploying multiple strategies that can prevent or offset damage to our homes and neighborhoods. I will continue to work with my partners in Albany and at the city level to ensure that our communities are protected from these extreme weather events.

Back to School Giveaway

I partnered with Metro Health Plus in distributing backpacks and school supplies to families in need. Seeing the smiles on children's faces as they received their brand-new supplies was incredibly rewarding. Each backpack and notebook represent not just tools for learning but a boost of confidence and excitement for the school year ahead. By coming together to support students, we're helping to build a brighter future for them and our entire community.



Rosh Hashanah Food Pantry

I gathered with community leaders and the Met Council at Tomchei Shabbos of Queens to mark Rosh Hashanah - the start of the Jewish New Year. Over 13,000 pounds of food were distributed from this single site, going to needy families during the High Holidays. I'm proud to partner with and support both the Met Council and TSQ, and I look forward to boosting the great work that these and other mutual aid organizations deliver.




NO to City of Yes!

I stood alongside my colleagues in government and local community leaders to oppose the "City of Yes" proposal. For months, I have listened to the overwhelming concerns from Community Boards, Civic Associations, the Queens Civic Congress, and countless New Yorkers. This proposal would bring a host of new challenges that threaten to fundamentally alter the character of our neighborhoods. Our communities already struggle with inadequate transit options – limited bus and subway services are barely meeting current demand. Adding housing beyond what our infrastructure can support risks pushing these systems to a breaking point. I still have deep concerns about this measure's implementation, and I greatly appreciate the Council Members who voted against it.

I was a guest at the Grand Procession of Lord Ganesha, hosted by The Hindu Temple Society of North America. This incredible event, marking the grand finale of the temple's largest annual festival, celebrated Lord Ganesha in a magnificent silver chariot adorned for the occasion. Scooter Presser & DOT Community Engagement Forum

One of the pressing issues in our neighborhoods this year has been the unchecked proliferation of e-scooters, which are cluttering streets and sidewalks. While the concept initially held promise, its poor implementation has created significant challenges, including a lack of proper arrangements and safety measures. The high speeds at which these scooters operate on sidewalks have introduced new risks, endangering pedestrians as they exit buildings. I stood alongside Council Member Gennaro at a community press conference in front of the Hillcrest Jewish Center to advocate

for ending the e-scooter program in Council District 24. We also expressed deep frustration with the Department of Transportation (DOT) for its refusal to participate in town hall discussions with our office to address these concerns.

No to Congestion Pricing!

I held a press conference at my District Office in Fresh Meadows to firmly oppose congestion pricing. I have been advocating against this program since its initial proposal by Mayor Bloomberg in 2007 and called for its permanent cancellation during the pause implemented by Governor Hochul. Congestion pricing disproportionately harms lower-income New Yorkers who rely on their vehicles for commuting or daily needs and places a significant financial strain on small businesses across the

The MTA's ongoing failures to provide accessible transit services, especially for seniors, individuals with disabilities, and those with health issues, all highlight critical flaws in the system. Despite years of promises, these issues have not been addressed, leaving vulnerable communities with limited alternatives to driving. Adding to the already high cost of living in New York City, this program would further burden families who are already struggling to make ends meet.
