

Protecting Our First Amendment Rights

Assemblywoman Weinstein has authored legislation that will allow defendants to seek dismissal of frivolous legal action known as SLAPP lawsuits.

SLAPP suits, or Strategic Lawsuit Against Public Participation, are usually unwinnable lawsuits that allow the wealthy to silence critics by dragging them through protracted legal battles without any merit. More importantly, these suits usually also serve to quiet other critics with the fear of lawsuits and the expenses they pose.

The new law, co-authored by Senator Brad Hoylman will not only allow a judge to weigh the merit of any case that involves the First Amendment right to free speech, it will also place the defendants legal cost on the plaintiff if the defendant wins.

Protecting All New Yorkers

During a legislative session in June, I advocated for the passage of a package of bills, now law, seeking to increase law enforcement accountability, transparency and protections for all New Yorkers.

The cornerstone of this bill package, which I am particularly proud to sponsor, repeals of Civil Rights Law Sec. 50A (A.10611), which will immediately allow for the public disclosure of police disciplinary records and personnel history. Other sections of this important package prohibit the use of chokeholds by law enforcement - declaring it aggravated strangulation, hold officers liable for failure to secure proper medical attention, and allow those not in custody or under arrest to film police activities and maintain custody of their recording equipment. Additional measures establish a Law Enforcement Misconduct Investigative Office to investigate complaints of corruption and other abuses by law enforcement, and require courts to maintain records and report concerns involving low-level offenders, including demographic information and who was charged.

These laws will undoubtedly lead to an increase in safety for all New Yorkers. I will continue to fight for improvement to our policing and justice systems.

Combating COVID-19 and Protecting New Yorkers

The Legislature has passed a major legislative package to help support New Yorkers during the current COVID-19 pandemic, and help the state be prepared for future emergencies. The legislation focuses on protecting New Yorkers' rights, helping them stay in their homes, providing economic relief for struggling workers and businesses, strengthening the health care system and maintaining critical services.

The laws protect and preserve New Yorker's rights, help struggling homeowners and renters, provide more support to our struggling small businesses, prioritize protecting New Yorkers' health during this crisis and help New York prepare for future pandemics, all while maintaining quality of life and vital support services for vulnerable New Yorkers.

Protecting Vulnerable Seniors

Reverse Mortgages allow seniors 65 and older who are house rich and cash poor to borrow money against the equity of the home they've worked a lifetime to own. But, in some cases unscrupulous lenders haven't advised seniors of their obligations, and many are under the impression that since they don't owe a monthly payment as with typical mortgages, they cannot default. But there are indeed many ways to default, and in recent years there has been an uptick in defaults on reverse mortgages.

A bill authored by Assemblywoman Weinstein, which is awaiting Governor Cuomo's signature, builds on her previous years' efforts to protect seniors who have reverse mortgages, and will require Reverse Mortgage Lenders to:

Inform the Department of Financial Services of any imminent defaults, allowing DFS to provide uninformed seniors with tips and tools that would allow them to keep their homes.

Provide DFS with proof that the Department of Housing and Urban Development has approved the acceleration of the loan, proof of the default and proof that they've properly noticed the borrower.

Refrain from making any large advanced payments towards anticipated mortgage and tax liabilities; a practice usually targeted to saddle seniors with even more massive financial liability in the event of a default.

Improving Power of Attorney

New York's archaic process of obtaining Power of Attorney (POA) has long been a complicated affair begging for change. The form used to apply for POA is confusing, long, and once granted, POA imposes severe limitations in the scope of its use.

A bill authored and sponsored by Assemblywoman Weinstein will bring long awaited improvements, with a newly designed and shorter POA form, and expansion of the gift-giving parameters from the current \$500 limit to a larger \$5,000 one. Additionally, the bill would allow some leeway in the language one must use to meet the requirements of the State statute. This would allow many to craft their own, legally binding form.
