## *Winter 2019* **MWBE** Update **Minority-And Women-Owned Business Enterprises**

Message from Assemblymember Rodneyse Bichotte Chair, Subcommittee on Oversight of Minority and Women-Owned Business Enterprises

#### Dear Friends.

I am pleased that we have opened the 2019-2020 legislative session with a stronger New York State Assembly and new leadership in the New York State Senate. I am hopeful for the future of MWBEs!

Last session, I sponsored a bill that allows minority and women entrepreneurs who are veterans to submit their DD 214 form as verification of their status as MWBEs. This bill was signed into law and chaptered with help from the Hispanic Chamber of Commerce and the Veterans' Chamber of Commerce. But we still have much to do.

Last session, I advocated for a 5-year extension of the MWBE program, Article 15-A. However, the program was renewed only until December 2019. Although detractors have claimed that MWBE goals slow down projects when companies cannot find enough MWBE contractors to hit the target, the answer is not to scrap the MWBE

Last year's NYC Disparity Study reports that there is a 50.69% availability of MWBEs in the city and the 2016 Last years INTC Disparity Study reports that there is a 30.09% availability of INTW DES III the city and the 2010 NYS Disparity Study reports an availability of 53.05% of MWBEs ready and willing to do business with the state. Accordingly in this session, I will double down on my prior initiatives, which include but aren't limited to: extending Article 15-A, the MWBE program, for 5 more years

- increasing New York City and New York State agencies and authorities discretionary spending on MWBEs of up to \$400K

As a result of last session's drawbacks, I will double down on my past initiatives and legislation, while sponsoring many new ones.

# **HIGHLIGHTS**:

A01449 allows NYC agencies discretionary spending of up to \$400,000 on MWBEs

**A01440** allows the New York City School Authority discretionary spending of up to \$400,000

A01550 requires that public contracts be divided by size into large, medium, small and micro contracts for the purpose of increasing opportunities for small businesses. including MWBEs, to participate in state contracts

A02987 eliminates personal net worth cap of \$3.5 million

A01541 requires that waivers of compliance to be published in an effort to ensure transparency in the event that there is no reasonable availability of MWBE

A01480 expedites the certification for MWBEs by requiring that the process take up to 30 days

**A01481** would inform MWBE of the reason that they were not awarded a State or municipal MWBE contract

**A01484** ensures that all state funded contracts to municipalities and school districts have MWBE goals

A01541 publicizes waivers on each vendor per contract with details of the bid won

A02427 stipulates employment goals for minorities and women in construction-related companies according to the recent New York State Disparity Study

A02511 authorizes the comptroller to issue a letter grade assessing each state agency's utilization of MWBEs

(Bill Number pending) allows NYC Department of Education an increase of discretionary spending of up to \$400,000 on MWBEs

A01487 mentoring programs in State agencies and Authorities such as Dormitory Authority of the State of New York, Office of General Services, Department of Health. Department of Transportation, and the ESD
