Greetings -

This week in Albany, I was proud to join my Assembly colleagues in passing a package of legislation to help people with disabilities in New York State get the services and opportunities they need and deserve. Included in this package is a bill (A.1577) that would expand the Developmental Disability Ombudsman Program to ensure individuals with developmental disabilities are aided in exercising their rights and bettering their quality of life through a toll-free telephone hotline, an interactive website and an in-person staff member. Also passed, were two bills to expand and promote employment of people with disabilities. A.6397A establishes a taskforce to promote state agency employment for people with disabilities while A.5815 requires state agencies and contractors to report data on the employment of people with disabilities and their level of participation.

Advocating for the Passage of the Heat Act

This Wednesday, I again joined my colleagues and advocates at a rally in Albany calling for the passage of the NY HEAT Act (A.4592) by the end of session. This essential environmental legislation eliminates the current requirement that utilities provide gas connections to customers on demand. The costs of this have been passed on to ratepayers effectively making them subsidize fossil fuel infrastructure expansion. The HEAT Act would instead compel the Public Service Commission to promulgate rules aligned with clean energy build-out to replace gas infrastructure as well as ensuring that low and moderate customers pay no more than 6% of their income on utility bills (the accepted standard for affordability).



Contingency Management Legislation Moves Forward

My bill on Contingency Management (A.6674) passed the Assembly Committee on Alcoholism and Drug Abuse this week. Contingency Management is a method used in substance use disorder treatment that provides an incentive structure to help participants overcome their addiction. It is one of the most evidence-based and cost-effective yet underutilized treatments for substance use disorders and it's time for New York to embrace and scale-up this innovative approach. This legislation would require the State to establish guidelines for a statewide program and make New York a leader in this area.

Dyslexia Diagnosis Act Advances in the Senate

My bill, the Dyslexia Diagnosis Access Act (<u>A.2898/S5481</u>), which passed the Assembly earlier this year has now passed the Senate Insurance Committee and is currently under consideration in the Senate Finance Committee. The bill would mandate that private health insurance policies pay for neuropsychological exams for the purpose of diagnosing dyslexia. The cost of such exams makes them out of reach to many families and my bill would significantly address this. An essential part of children with dyslexia and related learning

disorders getting the services they need is positive identification of the nature of their disorder.
