# Are you frustrated with a bureaucratic agency? Our district office is here to help you.

Here are a few examples of how we recently helped constituents overcome bureaucratic red tape:

# Social Workers' Religious **Observance Defended**

When four Orthodox Jewish social workers were being forced to work on Yom Kippur at a NYC hospital, they reached out

He immediately reached out to the president of the hospital, expressing his outrage and shock that these employees were denied the opportunity to take off on Yom Kippur, the holiest day of the Jewish calendar. Following Assemblyman Eichenstein's engagement with the hospital's president, the hospital reversed its decision, and the four social workers were permitted to spend Yom Kippur in fasting and prayer. The hospital president apologized for this gross violation of the workers' basic religious rights and assured Assemblyman Eichenstein that this will never happen again and that workers' religious rights will be respected.

# **Special Needs Children's Unforgettable Trip to Florida**

Students from a local school for special children were all set and ready to go on a class trip to Florida which would give their parents a much needed break and the children a most memorable experience.

As they prepared to leave, the school experienced a major bureaucratic nightmare - permission for the trip was needed from the New York State Office for People with Developmental Disabilities (OPWDD), and that consent often involves a process that takes several weeks.

After realizing the serious predicament they were in, the school called Assemblyman Eichenstein's Office to see if anything could be done so the trip could continue as planned. After working through the overwhelming bureaucracy, Assemblyman Eichenstein and his staff were able to work with OPWDD to ensure that these special children would not be disappointed and could continue with the most wonderful experience of a lifetime on their school trip to Florida.

# Assemblyman Eichenstein Introduces Legislation to Amend Bail Reform for Hate Crimes

New York State's new bail laws have taken effect in January of 2020. As a result, judges are prohibited from imposing cash bail on defendants accused of committing misdemeanors and nonviolent felonies. Instead, these defendants are being released on their own recognizance until the trial. Given its fundamental faults, Assemblyman Eichenstein opposed this bill and voted against this legislation.

With the dramatic increase in hate crimes across the country, Assemblyman Simcha Eichenstein has authored legislation that would amend the criminal procedure law pertaining to those who are charged with committing hate crimes.

Assemblyman Eichenstein believes that hate crimes represent an extreme form of prejudice and therefore judges should have the discretion to impose cash bail on hate crime perpetrators. Perpetrators of hate crimes generally show little or no remorse and are likely to become repeat offenders. His bill (A8944), would enable judges to keep violent hate crime offenders off the streets until trial and thus keep our communities safer.

# Who gets counted?

Every ten years, the Census Bureau conducts a census that counts every person living in the United States. In the past, our communities have been severely under-represented so I'm urging everyone to participate this time. Any community that is under-represented might not receive the services and funding it deserves.

### Why is it important to count everybody?

It's important to participate in the census because this data is used by the government to decide on how to distribute funds, allocate services, and determine representation based on population. It takes just a few minutes to fill out the census form, but the benefits are huge. It's in our best interest to be accurately counted so that we are properly represented. And if we don't respond, we don't count!

# How do I fill out the form?

For your convenience, this year you can respond to the census by paper, by phone or online. You should be receiving instructions by mail in March of 2020. If you need help, call my District Office and my staff will be happy to assist you. Please take the time to respond—it only takes a few minutes! Do it for yourself, for your family, and for your community.

Every household will have the option of responding online, by mail or by phone.

# **Assemblyman Eichenstein Hosts Workshop on Hate Crimes Grant Program**

The Securing Communities Against Hate Crimes grant program was founded by Governor Andrew Cuomo in 2017. In 2019, Assemblyman Simcha Eichenstein's first year in office, he spearheaded a campaign to expand the program to include summer camps as eligible recipients. As a result, summer sleepaway camps may now be eligible to receive as much as \$250,000 in grant funding for security upgrades such as surveillance cameras, perimeter lighting, alarm systems, fencing and barriers, security doors, and other safety measures.

Assemblyman Eichenstein recently hosted a workshop for summer camp administrators where experts shared guidance on how to apply for the grant program and acquire the necessary funding to ensure safety and security. Nearly 150 representatives of summer camps attended the workshop.

The overwhelming response to the workshop indicates a serious response to the increasing safety and security. Assemblyman Eichenstein continues to fight for additional security measures that help institutions protect our safety.
