

StandWithUs Partners with Assemblyman Simcha Eichenstein and Gerstman Schwartz LLP on New Hate Crimes Civil Lawsuit Initiative

In response to the alarming rise in antisemitic crimes, the national organization StandWithUs is partnering with Assemblyman Eichenstein and the law firm Gerstman Schwartz LLP to promote their newly created civil lawsuits initiative to bring perpetrators of hate crimes to justice. Gerstman Schwartz LLP is ready to file civil suits on behalf of victims of antisemitic hate crimes as a means to fight back against the perpetrators who commit these senseless and despicable crimes. The initiative provides all legal services, free of cost, to the victims.

"Filing a civil lawsuit is an additional consequence that will force perpetrators to regret their actions and will serve to deter others from doing the same," said Assemblyman Eichenstein. "Victims of hate crimes will no longer have to suffer in silence while their attackers get released with a slap on the wrist."

Assemblyman Simcha Eichenstein Successful in Passing Camp Health Provider Amendment

When state lawmakers recently passed a bill which would have potentially caused hardship to our local community's summer camps, Assemblyman Simcha Eichenstein stepped in to rectify the situation. Because of the Assemblyman's tireless efforts, the bill was amended to reflect the needs of countless camps throughout New York State.

The original bill, which passed last year, would have required summer camps to employ licensed health providers on their premises, but a clause in the bill stated that the camp medical director must be a physician, a PA, or a nurse. This caused concern to camp directors, many of whom currently employ Emergency Medical Technicians for this role.

After being approached by Rabbi Yoel Rosenfeld, Director of Machne Gila, Assemblyman Eichenstein launched a campaign to amend the bill so that it reflects the current reality. Assemblyman Eichenstein worked with Assembly leadership and the original sponsor of the bill, requesting that new chapter amendment legislation be passed that includes qualified EMTs as camp medical directors. His efforts were successful and the new amended bill passed both houses of the State Legislature in January.



Assemblyman Simcha Eichenstein sponsored legislation (Bill A2590-B) which would require agencies that service the aging to record and report when elderly New Yorkers are denied services due to lack of sufficient funding. The purpose of this legislation is to ensure that the state will reinvest funding in specific areas so that the needs of this vulnerable population are properly and sufficiently met. "With this data we can identify which investments need to be made in order to assure our older adult population receives quality care," said Assemblyman Eichenstein.

Assemblyman Simcha Eichenstein Hosts Assembly Speaker Carl Heastie on a Tour of the Boro Park and Midwood Communities


Visits Were Focused on Issues that are Currently at the Forefront of Assemblyman Eichenstein's Advocacy in Albany

One woman rolled up her sleeve to display the numbers tattooed on her arm at Auschwitz. Speaker Heastie spoke about his own visit to Yad Vashem several years ago and how it made a tremendous impact.

Upon the conclusion of the visits, Speaker Heastie said, "Today's visit to Brooklyn with my friend and colleague Assemblymember Simcha Eichenstein was both inspiring and deeply moving. From Imagine Academy working to give students with autism a bright future, to the volunteer first responders at Central Hatzalah ensuring the community has the emergency medical care they need, to meeting with Holocaust survivors at Nachas Healthnet, we were able to talk to residents about their needs and see the resilience and vibrancy of the community."


