I look forward to representing my constituents – no matter how complicated the issue or how daunting the task. I never ran and I never will.

# HERE ARE SOME LEGISLATIVE HIGHLIGHTS FROM 2024 AND PRIORITIES GOING FORWARD:

- I was the Assembly sponsor of **A.2656**, which allows pregnant women to enroll in the state's health exchange at any time without penalty. The bill, which Gov. Kathy Hochul signed into law in October, was important to me as a mother. It sends a clear message to all New Yorkers that the state is committed to combatting increasing maternal mortality rates, especially among Black women. Pregnancy is a time for joy and optimism, not for anxiety over access to healthcare.
- The Assembly Majority waged a successful fight to secure hundreds of millions of dollars to save **SUNY Downstate Hospital**, which had been facing the possibility of closing because of ongoing financial trouble. The FY 2025 budget includes \$100 million in operational funds and \$300 million in capital funding. The funds will help SUNY Downstate's continued efforts to address health disparities within communities of color served by the hospital.
- The FY 2025 budget includes \$347 million to support New York State's efforts to reduce **gun violence**.
- On Jan. 1, New York will be the first state to ban co-pays for insulin, legislation supported by the Assembly Majority and signed by Governor Kathy Hochul. The ban applies to any New Yorker on a state-regulated health insurance plan. There are 1.58 million New Yorkers diagnosed with diabetes, and the proposal is expected to save New Yorkers an estimated \$14 million in 2025.
- The Clean Slate Act of New York (A.1029C), which I proudly co-sponsored, went into effect on Nov. 16. The new law will bring relief to 2.3 million New Yorkers with criminal histories. Under the Clean Slate Act, New Yorkers will be eligible to have conviction records sealed three years from sentencing for misdemeanors and eight years from sentencing for felonies removing barriers to employment, housing, education, and other opportunities needed to successfully reenter society and make meaningful contributions to their communities.
- I am the Assembly sponsor of the Second Look Act (A.531), which would allow judges to review and reconsider excessive sentences, giving incarcerated people the chance to receive a sentence reduction when it's in the interest of justice. It is not a get-out-of-jail-free card. The measure would provide people serving lengthy sentences the opportunity to petition the Court and demonstrate that they are fit for release, or that the sentence is no longer appropriate. This bill will be among my priorities in the upcoming legislative session.
- I will be fighting in the upcoming session for **A.1089**, a bill that I sponsor. It would impose an excise tax on the sale of ammunition, generating money that would go into a gun violence impact fund. The legislation is an effort to provide relief to families in underserved communities who experience violence. The money from the violence impact fund could be used for funeral costs, medical bills, mental health resources or other unplanned expenses.

It also includes manufacturing space, an exciting and unique addition to Brownsville.
