As many of you know, I was a nurse before being elected to represent you all in the Assembly. So one of the things I'm most proud of from this year is that my bill (A.4141) to eliminate insulin copays passed as part of this year's budget! This first-ofits-kind groundbreaking piece of legislation will make New York the first state in the country to completely eliminate copays for insulin prescriptions for anyone with a stateregulated insurance plan, ultimately saving millions of dollars and countless lives.



It was an honor and a joy to lead this fight alongside Senator Gustavo Rivera, advocacy organizations like the American Diabetes Association and the AARP, patients, and health care practitioners. The bill will kick in on January 1st next year. I look forward to going back to Albany next year and continuing the fight to make sure health care is a right!
