
Masjid al Ihsan Food Giveaway

Summer Reading Challenge

There is no better way to help kids expand their horizons and keep their minds active than by picking up a good book. This year I am inviting our local youth to participate in the Assembly's annual Summer Reading Challenge, held in partnership with New York State Libraries. The challenge asks children to read a book for a minimum of 15 minutes a day for at least 40 days during July and August. Children can read on their own or with a partner or caregiver and mark off days on the calendar provided. Once they've completed 40 days or more, they submit the calendar to my office and then receive a certificate in the mail.



Updates From Albany

This week my colleagues and I passed lifesaving legislation to require safe staffing standards in hospitals and nursing homes.

A.108-B:


- The legislation requires hospitals to establish clinical staffing committees that would be responsible for developing and overseeing a clinical staffing plan.
- The clinical staffing plans would set nurse-to-patient ratios in hospitals as well as set guidelines for the number of ancillary staff in each unit.
- These committees would be made up of registered nurses, licensed practical nurses, ancillary staff members providing direct patient care and hospital administrators.
- Plans would be submitted to the state Department of Health (DOH) by **July 1** of each year, and these committees would be responsible for adjusting and improving these plans as need be.
- The DOH would be required to set regulations for intensive and critical care unit staffing, including at least 12 hours of registered nurse care per day.
- Plans must be made accessible to the public and posted on the DOH hospital profile website.
- The DOH is tasked with investigating any violations or complaints, and hospitals that violate these guidelines may face civil penalties; however, the DOH will consider any unforeseeable emergency circumstances when determining these matters.
- An independent advisory commission will also be created to help further improve working conditions and quality of care in hospitals.

A.7119:

- A.7119 would direct the Department of Health commissioner to establish minimum nurse staffing levels for nursing homes in order to promote the highest standards of resident health and well-being.
- The DOH would also be tasked with creating penalties for noncompliance and reviewing compliance through quarterly federal staffing documentation; however, the DOH will take into account factors, such as unforeseeable disasters or emergencies, the nature of the violation and labor-supply shortages, when issuing penalties.
- The minimum nursing home staffing standard must include a minimum of 3.5 hours of nursing care per resident per day.

- Of that 3.5 hours, at least 2.2 would need to be provided by nursing assistants and at least 1.1 would need to be provided by licensed practical nurses (LPNs) or registered nurses (RNs).

I want to commend and congratulate my colleague, Assemblymember Aileen Gunther for her dedicated persistence in getting these important measures finally passed. Even before the pandemic hit our communities, the problems with nurse staffing were evident. The COVID-19 pandemic shined a light on how important nurses and other direct care workers are to our society. Rest assured, I along with my Assembly and Senate colleagues will continue to fight for policies that protect essential workers and put our families first.



This week the Assembly passed legislation to extend residential and commercial eviction moratoriums

- The State 2021-22 Budget included approximately \$3 billion in combined federal and state dollars for rent and homeowner relief.
- This included a rental relief program to aid eligible tenants with up to 12 months of rent and utility arrears assistance, plus up to three months' prospective rent assistance for rent burdened households to maintain housing stability.
- The rental relief has not yet been distributed.
- Legislation that was passed this week would allow New Yorkers to remain in their homes while they await this relief by extending the COVID-19 Emergency Protect Our Small Business Act of 2021 and the COVID-19 Emergency Eviction and Foreclosure Protection Act of 2020, both of which were set to expire [May 1](#), retroactively through [August 31](#), 2021
- In a separate piece of legislation, the Assembly also passed legislation that will ensure landlords qualify for \$100 million in funding to assist in back rent due to COVID-19.

Just as important it is to extend protections for our tenants, we also need to backup our landlords and property owners. We need to keep in mind that by protecting our tenants from eviction, if landlords foreclose, those same tenants would be pushed out into the streets.



I sent a letter to the Governor urging Mosques throughout New York State to fully reopen in acknowledgment of Eid-al-Fitr.

On behalf of my fellow Muslim brothers and sisters, this week I wrote a letter to Governor Cuomo urging him to allow Mosques to fully reopen – starting next week – in acknowledgment of Eid-al-Fitr which begins in the evening of [May 12th](#) and ends on the evening of [May 13th](#). To have the state recognize this Muslim holiday by allowing Mosques to fully reopen is an important message that we are viewed fairly and equally here in New York State.



Critical Updates, New Policies, and Testing Locations to Protect You and Your Community

1. The Governor announced this week that large-scale outdoor event venues will only be limited by the space available for patrons or parties of patrons to maintain the required social distance of 6 feet starting [May 19](#). This will apply to outdoor sports, performing arts and live entertainment, and horse and auto racing venues statewide. Appropriate social distancing, masks and other applicable health protocols will still apply.

2. It was announced this week that Broadway will fully reopen its doors this September, in accordance with the State's health and safety guidance. Beginning May 6, and throughout May, tickets for Broadway shows - which begin September 14, 2021 - will be made available for sale at 100 percent of theater capacity. This announcement builds upon the reopening of performing arts and live entertainment venues at limited capacities last month and further sets the stage for Broadway shows to return to theaters throughout the fall.
3. The curfew will be removed for outdoor dining areas beginning May 17 and indoor areas beginning May 31. The curfew for catered events where attendees have proof of vaccination status or negative COVID test result will be lifted beginning May 17 and curfew for all catered events lifted May 31. It was also announced that the 1 a.m. curfew for catered events where attendees have provided proof of vaccination status or a recent negative COVID-19 test result will be lifted beginning May 17, with the curfew for all catered events set to be lifted May 31.
4. Tax Day for individuals extended to May 17: Treasury, IRS extend filing and payment deadline. The Treasury Department and Internal Revenue Service announced that the federal income tax filing due date for individuals for the 2020 tax year will be automatically extended from April 15, 2021, to May 17, 2021. The IRS will be providing formal guidance in the coming days.



CLIENT SUCCESS STORY

Ms. M., a 68-year-old Black homeowner, fell one month behind on her mortgage when she had to pay for her sister's funeral expenses. For one year, her mortgage company continued to accept her payments, but her payments were forwarded to a new company. The new mortgage company notified Ms. M. to pay arrears (one year behind) on the loan. She was unable to pay for three years. Ms. M. had to negotiate with her lender, but it refused to work with her even though she had sufficient income and was eager to be helped. She contacted her attorney, who after being used in foreclosure, Ms. M. was able to contact with Brooklyn Legal Services, who helped her negotiate a modification with a lower interest rate and more affordable monthly payment, saving her \$300 per month on her housing expenses and allowing her family to remain in their home.


