

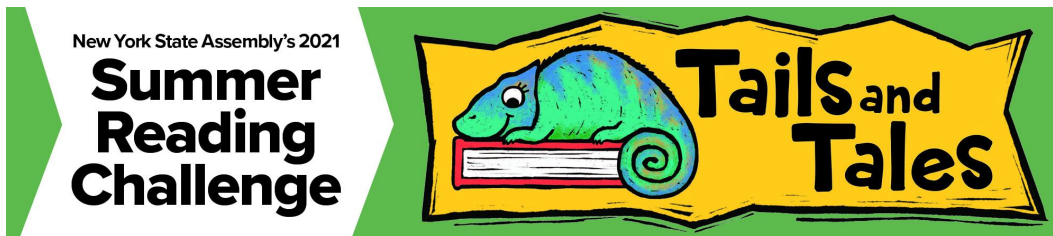


Weekly Report from Assemblyman Charles D. Fall

Summer Reading Challenge and Calendar

There is no better way to help kids expand their horizons and keep their minds active than by picking up a good book. This year I am inviting our local youth to participate in the Assembly Annual - Summer Reading Challenge, held in partnership with New York State Libraries. The challenge asks children to read a book for a minimum of 15 minutes a day for at least 40 days during July and August. Children can read on their own or with a partner or caregiver and mark off days on the calendar provided. Updates From Albany

The Assembly has passed a comprehensive package of legislation to better protect New Yorkers from gun violence.

A.6762-A: allow those responsible for the sale, manufacture, importing or marketing of guns to be held liable for the public nuisance caused by such actions. The legislation complies with the Protection of Lawful Commerce in Arms Act (PLCAA) as interpreted by the U.S. Court of Appeals for the Second Circuit in *City of New York v. Berretta USA Corps*. The PLCAA has been used to shield the firearm industry from civil liability.

A.613-A: Entitled the Jose Webster Untraceable Firearms Act, the bill prohibits the possession of ghost guns. Ghost guns are unserialized firearms, typically assembled from unserialized parts, including unfinished frames or receivers. It would require licensed gunsmiths to serialize and register with the New York State Police any unserialized firearm, rifle, shotgun, finished frame or receiver, or unfinished frame or receiver in their possession.

A.2666-A: Entitled the Scott J. Beigel Unfinished Receiver Act.

- Prohibits the possession and sale of unfinished frames and receivers by individuals that are not licensed gunsmiths.
- Unfinished frames and receivers are incomplete gun components that do not require serial numbers under federal law.
- Because guns assembled from unfinished frames and receivers do not have serial numbers, they are untraceable and can be built and transported without the normal background checks required when purchasing a gun from a licensed retailer.
- The legislation is named for Scott J. Beigel, who lost his life during the tragic shooting at Marjory Stoneman Douglas High School in Parkland Florida while trying to protect his students.
- **A.6198-B:** Prohibits the purchase, acquisition, sale or disposal of a weapon by or to anyone known to be the subject of an outstanding warrant of arrest for the alleged commission of a felony or serious offense. It would also prohibit an individual from purchasing or acquiring a gun on behalf of another person who the purchaser or acquirer knows to be the subject of such a warrant.
- **A.7957:** Authorizes the court, in matrimonial matters, to order a search and the seizure of firearms when a person against whom an order of protection has been issued refuses to surrender their firearms when so ordered. The Criminal Courts and the Family Court currently have similar statutory authority.

- **A.1005-A:** Requires mental health facilities to provide patients and their authorized representative with information on how to seek an extreme risk protection order prior to a patient's discharge or conditional release. This builds on the 2019 red flag law, which allows law enforcement to confiscate firearms and prohibit an individual from purchasing a firearm if they are deemed to be a threat, and if an extreme risk protection court order is issued.
- **A.6522:** Amends the definition of "disguised gun" to include any rifle, shotgun or machine gun that resembles a toy gun. This would prohibit the possession, manufacture and design of such disguised guns.
- **A.7243:** Requires the Division of Criminal Justice Services (DCJS) and the Division of State Police to publish quarterly reports providing information on firearms, rifles and shotguns that are used in the commission of crimes in New York. This would provide lawmakers and the public with a better understanding of the nature of the firearms used in crimes in the state and better inform policy actions in the future.

My colleagues and I have worked hard to address the root causes of gun violence in our state, and the legislation we passed this week builds on that, helping keep dangerous weapons off our streets and making it easier for law enforcement to trace and track down firearms that are used in crimes.

The Assembly has passed legislation to continue allowing outdoor dining on sidewalks and streets.

- **A.7733:** Allows restaurants to continue to use streets and sidewalks for outdoor dining for an additional year as they work towards recovery from the COVID-19 pandemic.

As we all know, restaurants were particularly hard hit by the pandemic and while many have been forced to close their doors permanently, many more have survived due to the ability to operate outdoors on sidewalks and streets. However, restaurants that sell alcohol were only allowed to operate outdoors because of an executive order, a privilege that will only last if the executive order is in effect. This bill will ensure that these restaurants can continue to operate outdoors for another year as they work to gain back stability and recover from the economic effects of the pandemic.

In the last remaining days of the 2021 Session we successfully passed legislation dealing with the opioid crisis.

A.6395-B: Establishes an opioid settlement fund for future opioid settlement agreement monies.

- This bill creates an Opioid Settlement Fund.
- It would ensure that all future funding allocations would only be used for approved purposes including substance use disorder prevention, treatment and recovery programs, treatment programs for co-occurring mental illnesses, and public education campaigns to combat the ongoing epidemic.
- It would also ensure that no future funding would be used to supplant or replace any current local, state or federal funds that would be used for the purpose of substance use disorder prevention, treatment or recovery services and programs.

New York slated to receive millions of dollars from opioid manufacturers and distributors as a result of legal actions brought by the state Attorney General's Office, this important legislation will ensure any money the state receives from these legal settlements is only used for eligible costs, such as substance use disorder prevention, treatment and recovery programs and public education campaigns to combat this epidemic.

The Assembly also passed legislation expanding the MERIT Scholarship by making it available to all Gold Star families

A.7685: The purpose of this bill is to expand the MERIT Scholarship by making it available to all Gold Star families.

- The Military Enhanced Recognition Incentive and Tribute (MERIT) Scholarship provides financial aid to children, spouses and financial dependents of members of the United States Armed Forces or state organized militia.
- Currently, the MERIT Scholarship is only available to gold star families if their qualifying family member served on or after August 2, 1990.
- While this date becomes less relevant as the years move forward, there are still today gold star families seeking MERIT scholarships who do not meet the program's requirements simply because of this arbitrary date.
- By simply removing the cut-off date we can ensure that no deserving gold star families are left out of this important program.



Critical Updates, New Policies, and Testing Locations to Protect You and Your Community

1. [The Governor this week, proposed legislation to waive taxes on grants from the \\$800 million COVID-19 Pandemic Small Business Recovery Grant Program. Applications for the program will be accepted starting June 10 for small and micro businesses and small for-profit independent arts and cultural organizations to help them recover from the economic impact of the pandemic.](#) The small business recovery grant program will provide funding to small and micro businesses and small for-profit independent arts and cultural organizations to help them recover from the economic impact of the pandemic, with priority being given to socially and economically disadvantaged business owners, including minority- and women-owned business enterprises, service-disabled veteran-owned businesses and veteran-owned businesses, and businesses located in economically distressed communities.
2. [The Governor announced this week that \\$3.5 billion in assistance for renters and small businesses experiencing financial hardship as a result of the COVID-19 pandemic. The rental assistance program makes up to \\$2.7 billion in emergency rental assistance available for struggling New Yorkers impacted by the COVID-19 pandemic.](#) Applications for the program have started as of June 1 for eligible New Yorkers who are behind on their rent and have suffered financial hardship due to COVID-19. Administered by the state Office of Temporary and Disability Assistance, the New York State Emergency Rental Assistance Program will assist with up to 12 months of

past-due rent, 3 months of prospective rental assistance, and 12 months of utility arrears payments to eligible New Yorkers, regardless of immigration status. The program is expected to serve between 170,000 and 200,000 households.

3. [It was announced that Broadway will fully reopen its doors this September, in accordance with the State's health and safety guidance. Beginning May 6, and throughout May, tickets for Broadway shows - which begin September 14, 2021 - will be made available for sale at 100 percent of theater capacity.](#) This announcement builds upon the reopening of performing arts and live entertainment venues at limited capacities last month and further sets the stage for Broadway shows to return to theaters throughout the fall.
4. [The Governor announced today two new vaccination sites will come online in New York City on June 11. The Empire State Building Observatory site, established in partnership with SOMOS Community Care, will operate from Friday, June 11 to Sunday, June 13, and the first 100 individuals who get vaccinated at the site will receive a free ticket to the Empire State Observatory.](#) **Additionally, the College of Staten Island site, established in partnership with Northwell Health, will operate from Friday, June 11 to Thursday, June 17, and will participate in the State's ['Vax & Scratch' Program](#). Based on demand, sites may be extended beyond this initial timeframe.**

CLIENT SUCCESS STORY
Ms. M., a 64-year-old Black homeowner, fell one month behind on her mortgage when she had to pay for her sister's funeral expenses. For one year, her mortgage company continued to accept her payments, but then her services was transferred to a new company. The new mortgage company refused to accept Ms. M's payments unless she could catch up on the one missed payment. For three years, Ms. M. tried to negotiate with her lender, but it refused to work with her even though she had sufficient income and was caring for her husband, who suffered from Alzheimer's disease. After being sued in foreclosure, Ms. M. was able to connect with Brooklyn Legal Services, who helped her negotiate a modification with a lower interest rate and more affordable monthly payment, saving her \$300 per month on her housing expenses and allowing her family to remain in their home.

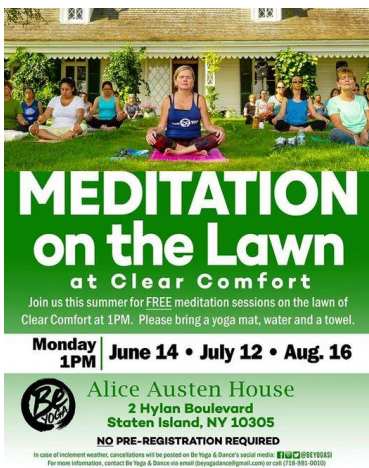
