

Additionally, this bill would require that a majority of board members be primary residents of Battery Park City. **Congestion Surcharge Exemption (A7697):** Recognizing the unique challenges faced by residents of Lower Manhattan and Staten Island, this bill seeks to exempt them from congestion surcharge pricing. Our goal is to alleviate the financial burden on Lower Manhattan residents while promoting a more equitable approach to congestion pricing.

These bills reflect my commitment to addressing the specific needs of our community, whether it's improving healthcare information, enhancing local representation, or providing financial relief to residents. # Unveiling the New York Climate Exchange: A Groundbreaking Initiative on Governors Island for a Sustainable Future

The introduction of regular, ecofriendly ferry service to Governors Island starting in summer 2024 is a testament to our dedication to sustainable transportation.
