Alex stood at the fair for eight hours to meet neighbors, hear their concerns, and provide them with services. Remember to support our small businesses!

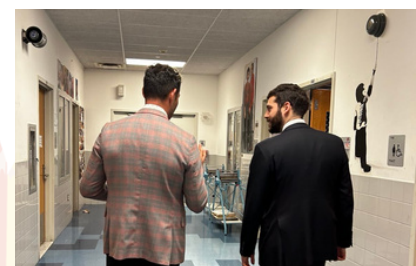


Assemblymember Bores joined students at Sacred Heart to participate in their final exam: "lobbying" a local elected official on causes they were passionate about.

## RALLYING FOR THE NO CAP ACT



Assemblymember Bores, Senator Hoylman-Sigal, and the New York City Bar Association hosted a rally in support of the No Cap Act, which would lift the Constitutional Cap on Supreme Court Justices and reduce the backlog on our trial court system. A broad coalition of groups—including lawyers, business interests, prosecutors, defenders, judges, and good government advocates—has come together to advocate for the passage of the No Cap Act.

The Knickerbocker Greys traveled to Albany to meet with various members of the Assembly and their staff to advocate for Assemblymember Bores' bill, which would enable them to continue their afterschool program in their historic home.

## PASSING LEGISLATION

### Alex passed two bills to regulate e-bikes, mopeds, and other micro mobility devices.

The first bill, A7628, adjusts DMV forms and systems so that we can track collisions involving e-bikes and mopeds separate from normal bicycles and full motorcycles, and finally have accurate data on crashes and safety.

The second bill, A8450, requires that mopeds be registered with the DMV before they leave the store.
