### The Bores Brief

Only have minutes to spare? Here's what you need to know:

- **The Governor included versions of two of my bills in her budget proposal:** one ensuring fertility preservation coverage for patients at risk of infertility from radiation or surgery (A2686) and another making it easier to cancel recurring subscriptions (A3928). I am fighting to ensure they end up in the final budget deal.
- Last year, Senator Gournardes and I teamed up with the Governor's team to make **free federal and state tax filing** available to New Yorkers with simple returns. The program has expanded this year to help in more situations. To see if you qualify, visit [bit.ly/FileTax25](https://bit.ly/FileTax25). The Assemblymember held his second annual State of the District address, where he shared an overview of the year's initiatives, projects, and legislative priorities. The event kicked off with an opening speech from Senator Chuck Schumer, followed by the presentation of a \$150,000 grant to the High School of Art and Design. Thank you to the 450 neighbors who came for the discussion.



Alex joined political and community leaders from across New York at the annual Jewish Community Relations Council Congressional Breakfast, hosted here in the 73rd District. Speakers discussed a wide range of issues, including American foreign policy, religious freedom, civil liberties in the Trump era, and antisemitism within New York City.



Assemblymember Bores launched his Youth Council, a program designed to provide students in the district with opportunities to learn about government and civic engagement. The program features guest speakers and monthly meetings focused on legislation and advocacy. This semester, the Youth Council will choose a bill to focus on and rally support for, before heading up to Albany to advocate for it.

This month, they had a personal tour of City Hall and learned about the relationship between the State and City governments.

## PROGRESS IN ALBANY



In February, the legislature held hearings on the Governor's proposed budget. The Assemblymember participated in five hearings in which he pressed Commissioners and advocates on ways of improving the budget. Some of the lessons include:

- The Office of Court Administration continues to support the Assemblymember's "Uncap Justice Act" to create more judges and speed up trials.
- The Division of Criminal Justice Services reported that New York lags behind other states in documenting and reporting hate crimes, and that by mandating reporting, we could keep New Yorkers safer (the Assemblymember has a bill to do just that).
- Lenox Hill Hospital is one of the most profitable hospitals in New York State, leaps and bounds above other New York hospitals. This is useful context as conversations around their renovation continue.
- Our state workforce has high turnover, but we do not systematically require exit interviews so that we can learn how we can retain staff. The Assemblymember has introduced a bill based on an NYC initiative to require exit interviews.

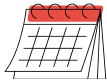
