



Dear Neighbor,

I hope this email finds you well. I'm reaching out to share some important updates about the work I've been doing to support our community, small businesses, and fight back against the Donald Trump/Elon Musk White House.

Outdoor dining has been a lifeline for restaurants, creating thousands of jobs and making our streets more vibrant. However, new city regulations are making it harder and more expensive for businesses to maintain their outdoor spaces. That's why I introduced bill A7598, which will remove seasonal restrictions, cut unnecessary costs, allow restaurants to offer year-round outdoor dining, while letting municipalities keep reasonable regulations to promote clean, safe, and visually appealing outdoor dining setups. At a recent press conference, I stood alongside restaurant owners, hospitality leaders, and community advocates to push for this much-needed change—we can't let red tape dismantle a program that has benefited so many.

Beyond outdoor dining, I'm proud to share some information about the Assembly's 2025-26 budget proposal, which makes historic investments in housing, public safety, education, healthcare, and infrastructure. From increasing funding for affordable housing and mental health services to ensuring all students receive free school meals, this budget is designed to lift up working families and strengthen our neighborhoods.

Additionally, I am continuing to fight for affordability in our economy, democracy, immigrant protections, and LGBTQ+ rights. I recently passed a bill to expand ballot drop boxes, spoke out against federal overreach on immigration, and joined advocates to defend gender-affirming care.

Lastly, I invite you to join me at some upcoming events I am hosting including an **Easter Egg Hunt, a town hall, and a free mammogram bus visit**. Also, don't forget to check your ID—starting May 7, 2025, travelers will need a [REAL ID](#) to board domestic flights.

## BUDGET & LEGISLATIVE UPDATE

I am happy to announce some of the amazing ways we are supporting our community in the Assembly's 2025-26 budget proposal.

### Addressing the Housing Crisis:

- The budget proposal addresses New York's housing crisis with \$250 million for a Housing Access Voucher Program.
- A \$100 million towards NY-RUSH (Redevelopment of Underutilized Sites for Housing) and another \$100 million for Mitchell-Lama and NYCHA affordable housing developments to offset maintenance costs.
- \$750 million towards lead, mold, and asbestos remediation in NYCHA, and \$750 million for Mitchell-Lama preservation. These efforts will help low-income families, reduce homelessness, and improve housing conditions for New Yorkers.

#### **Easing the tax burden on families and providing inflation relief:**

- Cut income taxes for approximately 8.3 million taxpayers providing an average tax cut of \$446 in the coming year.
- Eliminate income taxes for the lowest-income households, putting over \$225 million back into the pockets of over 350,000 filers.
- Support the governor's proposal to return sales tax payments directly to New Yorkers in the form of \$300-\$500 inflation rebate checks.
- An income tax credit of up to \$750 for eligible renters with incomes under \$200,000 in New York City, providing \$275 million in tax relief for around 1.87 million filers.
- Invests \$2 billion in helping cover childcare costs for families. This includes \$327 million towards expanding universal pre-k and \$100 million to support nonprofits that offer afterschool programs.

#### **Public Safety:**

- The Assembly's budget supports law enforcement, improving mental health care, and ensuring fair access to justice for all New Yorkers.
- \$10 million for anti-gun street outreach and other crime reduction initiatives focused on safeguarding at-risk youth to combat the epidemic of gun violence affecting our communities. It also allocates \$80 million for the Communities Helping Improve Lives Daily (CHILD) program for at-risk youth in high-need communities.
- Invests in criminal justice reform, mental health crisis response organizations, and provides \$20 million for Daniel's Law pilot programs.
  - Daniel's Law ensures mental health crises are treated as a public health issue, not a criminal threat, by establishing a meaningful response system to mental health crises outside of police and creating councils of mental health experts focused on de-escalation, trauma-informed care, and avoiding criminal justice system involvement.
- Improves monitoring of those in the mental health care system by requiring that hospitals create discharge plans with patient agreements, confirm follow-up appointments, coordinate care, and refer patients to community programs.

#### **Infrastructure:**



- Fully funding an elevator at the 23rd street A/C/E station.
- Invests in infrastructure with \$7.2 billion for the DOT Capital Plan, \$1.48 billion in local capital aid, and \$3 billion for the MTA's 2025-2029 Capital Plan.
- Modernizes roadways, bridges, and public transportation, making commuting safer, more reliable, and affordable for all New Yorkers.

## Education:

- Invests in education to ensure every child has access to high-quality learning. It includes a \$2.7 billion increase in school aid, \$1.1 billion over governor Hochul's proposal; this includes a \$2 billion increase in Foundation Aid, \$569 million over the governor's budget.
- Provides free school meals for all students and introduces the LEAD summer youth program to connect kids with summer jobs.
- An additional \$2.5 million in library aid, bringing the total to \$107.1 million to support programs and resources in schools and libraries across the state.
- Makes higher education more accessible by offering tuition-free community college for all New York students, regardless of age or field. It also includes \$3.5 billion in capital funding for SUNY, \$1.2 billion for CUNY, and additional operating funds for both systems. To support students, the

plan expands income eligibility for TAP and the Excelsior Scholarship Program and restores \$9 million for college opportunity programs, with a \$6.2 million increase, totaling \$212 million.

#### **Healthcare:**

- Prioritizes healthcare access for all New Yorkers, with \$35 million for reproductive and maternal health.
- Addresses hunger with \$75 million going towards hunger prevention, and \$75 million for Nourish NY.
- A 7.8% wage increase for health and human service workers.

#### **Environmental Protection:**

- Invests in climate action by putting \$500 million towards the Environmental Protection Fund, \$600 million for clean water infrastructure, and \$1 billion for green building and transportation programs.
- Includes a requirement that the New York Energy Research and Development Authority (NYSERDA) conduct an updated comprehensive study of energy affordability and energy burden throughout the state.
- These efforts aim to mitigate climate change and preserve New York's natural resources for future generations.

#### **Supporting Small Businesses and Communities:**

- Creates job opportunities for veterans and formerly incarcerated individuals through a new Work Opportunity Tax Credit, which rewards businesses with up to \$9,600 for hiring individuals from these groups who have historically faced barriers to employment.
- Invests in infrastructure, including \$50 million in Temporary Municipal Assistance and \$758.2 million in AIM funding to support local governments and their public works projects.

#### **Supporting Veterans:**

- Allocates \$35 million for veterans' programs and fully funds the Joseph P. Dwyer Peer-to-Peer Veterans Support Program, providing counseling for veterans dealing with PTSD and other mental health challenges.

Families are living in fear! Kids can't go to school! We cannot afford to deport thousands of hard-working people who keep our economy functioning!

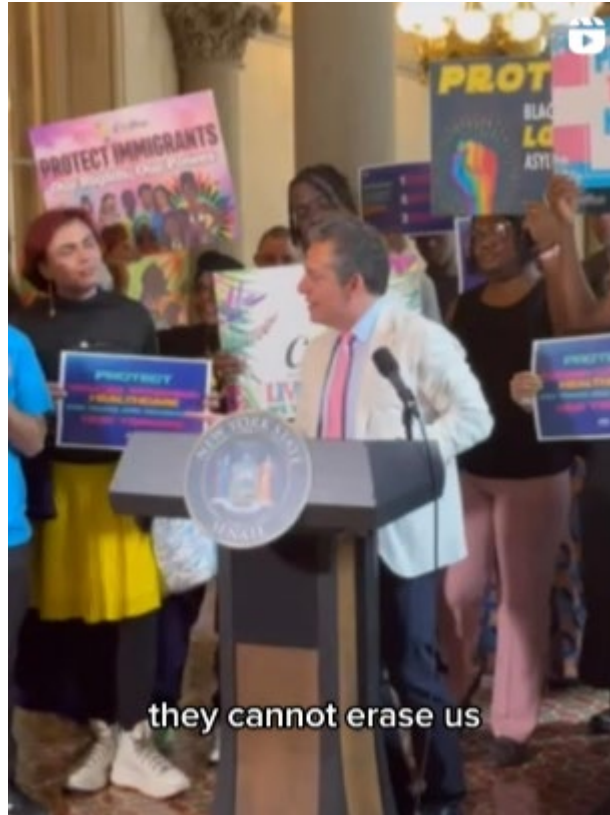
If Republicans were about real solutions they would pass comprehensive immigration reform, but they only want fear.

## Congestion Pricing





Congestion pricing was developed as a crucial solution to multiple crises in our city and in the time since the cameras went live it has more than achieved its mission. Our subway system is crumbling. Congestion pricing has unlocked \$15 billion to fix it. Our city center had been brought to a standstill by an overwhelming number of cars. Congestion pricing has already significantly decreased congestion without spillover into surrounding areas. Our streets are cleaner and safer because of the traffic reduction. Spending in the Central Business District has not declined, transit ridership is up, and honking has decreased. Congestion pricing is finally here and it is exceeding expectations. ## FIGHTING TO SAVE OUTDOOR DINING IN NYC

Outdoor dining has been a game-changer for New York City—creating thousands of jobs, helping restaurants stay open, and making our streets more vibrant. However, new city regulations are making it harder and more expensive for restaurants to keep their outdoor spaces. Seasonal restrictions, costly fees, and excessive red tape have forced many beloved spots—like **Empire Diner in Chelsea**—to dismantle their setups and lose valuable seating.

That's why I introduced a bill ([A7598](#)) to legalize year-round outdoor dining across New York State. This legislation will:

- ✓ **Remove seasonal restrictions** so restaurants don't have to tear down and rebuild setups each year.
- ✓ **Reduce unnecessary fees and red tape** that make it too costly for small businesses.
- ✓ **Allow municipalities to regulate outdoor dining in a way that makes sense for their communities, and promotes public safety and health**, while keeping it accessible for small businesses.

New Yorkers love outdoor dining, and the numbers prove it: at its peak, the program created nearly **12,000 jobs**, earning **working-class** New Yorkers nearly **\$375 million in wages**, and **generated \$9.6 million in tax revenue**. We can't let bureaucratic obstacles crush something that has been such a success.

At a press conference on March 31st, I stood with **restaurant owners, hospitality leaders, and community advocates** to highlight the urgent need for action. **Together, we will fight to save outdoor dining and ensure that New York remains a world-class dining destination.**

"In so many cities around the world, in Paris, in Italy, you name it, you can eat in the street. You have people, you have folks eating and dining. We can't restrict these rules," Simone said. "Unfortunately, the city put restrictive rules that make outside street dining too expensive. Too many bureaucratic obstacles in place."

"The city has effectively killed, in so many ways, outdoor dining in the roadway, because of the seasonality of it," New York City Hospitality Alliance executive director Andrew Rigie said.

Empire Diner founder and chief operating officer Stacy Pisone said she understands that guidelines needed to be put in place for roadway dining, but they withdrew their application because it was so limited.

“State Assemblymember Tony Simone led a demonstration at the Empire Diner on Monday morning after introducing a bill in the state legislature calling for outdoor dining structures to be allowed year-round in city streets. Beginning **May 7, 2025**, all U.S. travelers will need a Real ID or Enhanced Driver's License to fly domestically.

Starting May 7, 2025, travelers 18 years or older will require a REAL ID-compliant form of identification to board domestic flights at JFK, LGA, EWR, and Stewart International Airport. If your New York State


