



Masked ICE agents murdered an innocent woman and the Feds lied about it. This comes after [32 deaths in ICE custody in 2025](#), more than any year in decades

In response to the murder of Renee Nicole Good by an ICE agent in Minneapolis, and all those wrongly detained, fallen ill or died in ICE custody, I convened over 20 state and local elected officials, the New York Immigration Coalition, Chelsea Neighbors United, D3 Open Arms and other advocates to demand justice and the passage of the MELT (Mandating End of Lawless Tactics) Act ([A.8908](#) Simone / [S.8462](#) Fahy), RADAR (Reporting of Arrests, Detentions, Actions, and Removals) by Immigration Enforcement Act ([A.9376](#) Simone / [S.8858](#) Fahy), and the New York for All Act ([A.3506](#) Reyes / [S.2235](#) Gounardes) that when signed into law would curb illegal masked operations by ICE.

Renee Nicole Good, a woman, a mother, a poet, was murdered by our own federal government. We mourn Renee, as we mourn all those who have died in ICE custody and the families that have been wrongfully separated.



Masked ICE agents have been abducting people throughout the country for over a year, and they have now murdered an innocent woman. We are a nation of laws. [The MELT Act](#) will ensure that ICE and all those who have the power to enforce our laws are held accountable to the people by banning the use of masks or facial covering and requiring a clearly identifiable name or badge number on all law enforcement officers. History teaches us that once police begin to hide their identity the future of that nation is rarely free, stable, or democratic. This bill will help to protect the rights of all people in New York and hinder the proliferation of a secret police state.

**The RADAR Act** would require New York State to create a public, online dashboard disclosing data on ICE (Immigration and Customs Enforcement) and immigration officials' activity across the state. Despite a massive surge in ICE enforcement, New York currently has no centralized tracking mechanism to publicly track where, and how often, ICE and immigration officials operate. This legislation requires the Division of Criminal Justice Services (DCJS), in collaboration with state agencies and local enforcement organizations, to maintain a dashboard reporting anonymized, aggregated ICE data.

**The New York for All Act** broadly prohibits state and local resources from enforcing a cruel federal immigration agenda, funneling people into ICE custody, and sharing sensitive information with federal immigration authorities. It also ensures that people in custody are informed of their rights before being interviewed by ICE. The act prohibits ICE and CBP from entering non-public areas of state and local property without a judicial warrant and begins the process of limiting their access to state information databases.
