Seawright Votes NO to Changing Admissions Criteria for New York City Specialized High Schools

"As a member of the Assembly Education Committee, it is with the highest regard for families in my district and students across New York City, that I voted "No" in the Education Committee on Assembly Bill A10427A which aims to change the admissions criteria of specialized high schools in New York City and to limit the Specialized High School Admissions Test (SHSAT).

I received the bill last Friday and a vote was scheduled for this morning. Therefore two business days were allowed for review, discussion, and debate. On a topic this important, public hearings should first be conducted in each of the five boroughs to allow the public and stakeholders to express their views, concerns, and suggestions. Rushing to a vote as we near the end of session is not the most effective way to address the issues at hand. There are many questions crying out for answers, including how successful middle school pipeline programs can prepare students to compete and what programs must be replicated to create a more level playing field. I cannot support legislation on the future of specialized high schools with little opportunity for student, teacher, parent, alumni, and educator input.

We must be thoughtful and look at the issue holistically, with all stakeholders present before making a decision which will impact millions of children and families in New York City for decades to come. I look forward to working with New York City Schools' Chancellor Richard Carranza to further address injustices in our public school system. All students deserve access to high-quality educational opportunities and to take advantage of specialized high schools in New York City if they merit the opportunity. That is why I voted "No" on A10427A," said **Seawright**.

Seawright Bill That Tracks Policy-Makers By Gender Passes Both Houses



Albany, New York – On June 6, 2018, Assembly Bill 5487, legislation introduced by Assembly Member Rebecca A. Seawright that would identify how many policy-making positions are held by women in New York State Government passed the Senate and will be delivered to the Governor. The bill would compel the Secretary of State to compile a list of positions subjected to Public Officers Law Section 73-a and a representation of policy-making positions held by women compared to policy-making positions held by men. The compilation will track the length of time an individual maintains his or her position and compare the number of positions held by men and women on the Department of State's website. Making this information available will allow us to continue to push for gender equality in government, exposing where more work needs to be done to enable women to achieve leadership positions.

"Although we have our first appointed Attorney General, no woman has ever been elected in New York State as governor, attorney general or comptroller, and less than 30 percent of members of the New York State Legislature are women," Seawright said. "It is time to identify where in government gender equality is lacking, and pursue the necessary adjustments to better reflect gender realities in our society. I am hopeful that, by tracking this information and making it publicly available, our state will clear the path of inequities and enable all women to achieve their fullest potential."

Seawright is proud to have worked with Joyce Bahr, President of the Unsealed Initiative, to cosponsor and support Assembly Bill 9959B which will strengthen the rights of adoptees and their biological parents. This legislation would allow for an adopted person who has reached the age of 18 to request from the Department of Health a non-certified copy of his or her birth certificate and medical history if available. It is important that we give the right to personal information and family history. This basic information is pertinent to a person's physical and mental health.

Currently adoptees may only obtain original birth certificates through a cumbersome judicial process or by hiring an often expensive private investigator. Ethnic and religious heritage, medical history, and the ability to make contact with one's birth parents should not only be available to adoptees who can afford a private investigator, but to all adult adoptees.

Limiting Painkiller Prescriptions Will Aid in the Fight Against the Opioid Epidemic

"The opioid crisis continues to wreak havoc in communities across our state, claiming countless lives each and every year. From 2015 to 2016, the number of drug deaths in New York State – fueled primarily by opioids like fentanyl and heroin – increased by nearly 30 percent. Many individuals become addicted to these deadly drugs after being prescribed opioid painkillers following an injury or operation.

To ensure New Yorkers aren't left with extra painkillers that could be misused or could fall into the wrong hands, I passed legislation enabling patients to partially fill controlled substance prescriptions (A. 10392-A). Under current law, patients who partly fill this type of medication initially are not allowed to fill the remainder of the prescription later on. This measure would allow 30 days to fill the remainder of the prescription. It gives patients the final say when it comes to their treatment and may help stop prescription drug abuse before it happens.

Today's legislation builds on our efforts to tackle this epidemic head-on. That includes the recent creation of a \$100 million Opioid Stewardship Fund, a partnership with the pharmaceutical industry to expand prevention, treatment, and recovery programs for those struggling with substance use disorder.

I will keep doing everything I can to combat opioid addiction and help more New Yorkers struggling with addiction stay on the road to recovery," said Assembly Member Seawright.

Assembly Member Rebecca Seawright, Alyssa Milano, Congresswoman Carolyn Maloney, ERA Coalition Call for Ratification of the Equal Rights Amendment



Assembly Member Rebecca Seawright joined Congresswoman Carolyn B. Maloney (NY-12), House Sponsor of the Equal Rights Amendment (H.J. Res. 33), activist and actress Alyssa Milano, the ERA Coalition, and women's rights advocates to call for the ratification of the Equal Rights Amendment (ERA). The ERA would guarantee that Constitutional rights apply equally to all persons regardless of their sex. Currently, the right to vote is the only right guaranteed to women in the Constitution.

Although the ERA passed Congress in 1972, it was ratified by only 35 of the 38 states required to amend the Constitution. Rep. Maloney has reintroduced the ERA 11 times. In 2017, Nevada ratified the ERA and just last week Illinois became the 37th state to ratify.

"Women everywhere are demanding equality," said Alyssa Milano. "The #MeToo movement was such a powerful phenomenon because for far too long, women have not felt heard. It's hard to empower women when they are not recognized as part of our constitution. Now is the time for that to change and for the ERA to become part of the law for our nation."

"I commend America's Congresswoman Carolyn Maloney for being a national champion for women and for introducing the Equal Rights Amendment every year since she has been in office!" said Assembly Member Rebecca Seawright. "Let's make this year, the year it happens. I am proud to have introduced and helped to pass the Equal Rights Amendment in the New York State Assembly. The women of our state, like the women of our country, deserve the constitutional protection of equal rights to ensure that progress made thus far in policies to prohibit sex discrimination is not weakened or undermined. The Equal Rights amendment to the New York State and the United States Constitutions will ensure that women are permanently protected from sex-based discrimination. The time to act is now!"

The Fresh Food Box GrowNYC's Fresh Food Box Program is a food access initiative that enables under-served communities to purchase fresh, healthy, primarily regionally-grown produce well below traditional retail prices. Through the power of collaborative purchasing, Fresh Food Box customers purchase for \$14-15 what would cost \$20-\$30 in a store. All Fresh Food Box sites accept SNAP/EBT and Health Bucks, to make our shares even more affordable.

The produce included in each Fresh Food Box is the best of what's seasonally available. From July through November, Fresh Food Box sources from farms in the Northeast; in the winter and spring, Northeast produce is supplemented with produce from carefully vetted farms in Southern states, like Florida. This ensures Fresh Food Box provides a wide variety of fresh produce year-round while driving sales of locally-available items such as apples, root vegetables, eggs, grains, and dried beans.

How Fresh Food Box works:

- Visit a Fresh Food Box site near you

- Pay \$14 (or \$15 at workplace sites) in cash, credit/debit, EBT/SNAP, or Health Bucks for next week's share
- Return the following week to pick up your share containing 10-15 pounds of fresh, high-quality produce


