Happy New Year 2019! On New Year's Eve, I was filled with pride and gratitude as I was sworn in to my third term as New York State Assembly Member for the 76th District. We are excited to announce the signing by Governor Cuomo of my legislation to require the Secretary of State to identify and maintain a publicly available website indicating how many policy-making positions are held by women in New York State Government. May your new year be filled with new beginings, plans for the future, great happiness, health and much prosperity.

As a member of the New York State Assembly and its Education Committee, and former PTA activist, one of the areas of progress I'm most proud to have been a part is the expansion of New York City's Pre-K for all program. Very soon in the new year—between early February and March 15—families with children born in the year 2015 can apply for full-time Pre-K programs provided by the NYC Department of Education.

Now is the time, during the month of January for parents and guardians of soon-to—be four year olds to research the different opportunities for their children. Consider all the options! Visit the schools and early childhood centers for a tour and file an application by March 15<sup>th</sup>. Governor Signs Seawright Bill Requiring Secretary of State to Collect and Make Public Information on Women in Leadership Positions



On December 21, 2018, Governor Cuomo signed A5487, legislation introduced by Assembly Member Rebecca A. Seawright that would identify how many policy-making positions are held by women in New York State Government. The bill will compel the Secretary of State to compile a list of positions subjected to the Public Officers Law Section 73-a and a representation of policy-making positions held by women compared to policy-making positions held by men. The compilation will track the length of time an individual maintains his or her position and compare the amount of positions held by men and women on the Department of State's website. Making this information publicly available will allow us to continue to effectively push for greater gender equality in

government, highlighting where more work needs to be done to enable women to achieve leadership positions.

"No woman has ever been elected to serve in New York State as governor, or comptroller and less than one/third of the members of the New York State Legislature are women," Seawright said. "It is time to identify where in government gender equality is lacking, and pursue the necessary adjustments to better reflect gender realities in our society. I am hopeful that, by tracking this information and making it publicly available, our state will clear the path of inequities and enable all women to achieve their fullest potential."

Assembly Member Seawright expressed her deep appreciation to Governor Cuomo and the New York State Legislature for ensuring enactment of this important initiative.

### We Must Combat Opioid Epidemic On All Fronts

New statewide drug takeback program taking effect

Assembly Member Seawright announced that the Drug Take Back Act goes into effect on Jan. 6, creating a statewide drug takeback program – paid for by drug manufacturers, not taxpayers (Ch. 120 of 2018). The program requires participation



by all chain and mail-order pharmacies doing business in the state and is part of the continued efforts to fight the opioid

epidemic and save lives. The Assembly previously led the push for "I-STOP," creating the first real-time prescription-drug database in the country.

"There are families grieving in every corner of this state, trying to make sense of why their loved ones were taken so soon," said Seawright. "The opioid epidemic has shown us that addiction knows no bounds and will often hold its victims powerless until it's too late. One of the most important ways we can combat this devastating crisis is to stop addiction before it even starts, and that's what this drug takeback program will help do."

The new law requires all drug manufacturers to implement a takeback program in which both chain and mail-order pharmacies offer on-site collection or prepaid envelopes for New Yorkers to dispose of unused medication. Assemblymember noted that opioid addiction often begins with the use of prescription painkillers, whether obtained legitimately through a doctor or illegally from someone else's medicine cabinet, and that the program will help cut off supply. The program will also help ensure that these drugs are not improperly disposed of by flushing down the toilet or throwing them in the trash, which can cause them to seep into the water supply.

"With a new legislative session underway, we must continue to do everything we can to prevent addiction, increase access to treatment and ensure those suffering are not forgotten or ignored," said Seawright.

### **NYC Foam Ban in Effect**

As of January 1, 2019, New York City stores, food service establishments, and mobile food commissaries may no longer offer, sell or possess single-use foam food containers such as foam takeout

clamshells, cups, plates, bowls and trays. Additionally, manufacturers and stores may no longer sell or offer for sale loose fill foam packaging ("packing peanuts") in the city.

### **Minimum Wage Increase**



Assembly Member Rebecca Seawright believes that every hardworking New Yorker deserves the opportunity to climb the economic ladder. We know that putting families first means putting them on a path towards financial independence. No one working a full-time job should live in poverty.

That is why we fought tirelessly to establish a meaningful plan for sustainable wage growth in New York.

In 2016, we successfully enacted legislation that scheduled annual wage increases for workers all across the state.

With the new year, wages will rise to: \$15 an hour for workers employed by large businesses in New York City; \$13.50 an hour for workers employed by small businesses in New York City; \$12 an hour for workers in Nassau, Suffolk and Westchester Counties; and \$11.10 for workers across the rest of the state.

**Christmas "Tree-cycling" in NYC** 

Need Curbside Collection? - Please, "Naked" Trees Only!



The New York City Department of Sanitation will begin its annual curbside collection of Christmas trees on Wednesday, January 2, 2019. Collection runs through Saturday, January 12, weather permitting.

Residents should remove all stands, tinsel, lights and ornaments before putting trees out for collection. Clean, non-bagged Christmas trees left on the curb between Wednesday, January 2 and Saturday, January 12, will be chipped, mixed with leaves, and recycled into compost for the city's parks, institutions and community gardens.

Those needing to get rid of mostly plastic and metal fake Christmas trees should consider selling or donating them. Donation opportunities may be found at nyc.gov/donate. If donation or resale is not an option, remove all ornaments and lights, and put them out next to your recycling on regular recycling days.

NYC Parks provides additional options for bidding "fir-well" to your tree at Mulchfest. With 68 total drop-off sites, including parks and Greenthumb gardens, New Yorkers can drop off their trees between January 4 and 13, 2019. Dates have been extended this year for those who celebrate Three Kings Day. On the final weekend of Mulchfest, January 12 and 13, at 31 chipping sites across the city, visitors can pick up mulch to take home. Please remember to remove all lights, ornaments, decorations and netting from trees.
