Outlines Session Agenda and District Accomplishments on Represent NYC




MNN El Barrio Firehouse Community Media Center was host to the Represent NYC show where Comptroller DiNapoli interviewed Seawright on her progress and priorities in the Assembly. Seawright said "this session has been a historic one with the signing of the strongest tenant protections in New York state's history and the signing of the Reproductive Health Act increasing protections for women and reproductive health."

Additionally, she spoke about the women's website bill to track women in policy making positions, signed into law this year, Seawright shared "In my own district we are having issues with diversity on the RIOC board of directors, a board which critical to the governance of Roosevelt Island. As such, we must have a board representative all islanders including the women."



Seawright Speaks to Community Board 8



At the November meeting of Community Board 8 on Wednesday, November 20 Assembly Member Seawright let neighbors know about her election reform legislation signed into law by the governor, about her questions posed to the MTA Chairman regarding F Train Service and M31 bus service in light of anticipated increased ridership after the opening of the new Memorial Sloan Kettering facility. She invited constituents to come to Albany during the session, beginning in January, to advocate for the issues and concerns that are most important to them including congestion pricing and universal healthcare.

Give Back This Holiday Season In Our Community!

The holidays are a joyous time to spend with friends, family and loved ones and reflect on all that we have to be thankful for. Unfortunately, there are many New Yorkers who struggle to make ends meet and don't know where their next meal will come from. As we prepare for the upcoming holiday season, it is important to remember those in our community facing food insecurity and think about what we can do to make their holidays a bit brighter.



The Assembly took action to combat poverty and fight for the struggling families in our communities. Earlier this year, we passed a state budget that provides \$4.5 million for the Empire State Poverty Reduction Initiative to continue its work reducing inequality and lifting New Yorkers up. The budget also includes \$2.3 million to ensure eligible students don't have to pay for reduced-priced meals so that they can focus on their studies – not hunger pains.

In our neighborhood, there are ways to help families with access to healthy food, such as supporting local food banks and soup kitchens with donations and volunteering.
