Dear Friends and Neighbors,

Detur Friendu stud veginoris, This session brought unexpected uncertainties because of the COVID-19 pandemic. As a State, we are facing economic challenges and budgetary deficits, unprecedented unemployment claims, and tough challenges a the expense of preventing the spread of a deadly disease.

In the expense of preventing the spreat of a deadly disease. In Albany, we responded to the COVID-19 virus with aggressive emergency legislation. The legislation prohibits the eviction of tenants in financial distress during the pandemic. Nursing homes would be required to develop and adopt annual pandemic emergency response plans for review and approval by the State Health Department. Price gougers of products or services "visual or necessary to the health, safety, and welfare of consumers or the general public" would be subject to strict samctions. Other actions provide state-financed rental vouchers, a one-year extension for employers who take action against employees who speak out against workplace safety hazards.

In our community, we provided vital personal protective equipment to medical professionals, held Virtual Town Hall Tuesdays, delivered hundreds of meals to homebound seniors, and supplied constituents with thousands of face coverings and hand sanitizer to prevent the spread of COVID-19.

While there is still much work to be done to stop a history of discriminatory police conduct, we took the first steps in the fight towards a fully transparent, equitable, and unbiased police force with the repeal of 50-A, the passage of the Eric Garner Anti-choking bill, and many other legislative reforms.

Election Reform Assembly Member Rebecca A. Seawright's election reform measure, Bill 9001, passed both houses with overwhelming support. The law will save taxpayer dollars and promote efficiency and transparency by allowing candidates to satisfy both local and state requirements when running for office. Governor Cuomo signed the measure into law.

Coler Hospital on Roosevelt Island

"We are here today to deliver to Coler Hospital these urgently needed supplies and to thank our courageous frontline medical workers for their service," Seauright said.

Seawright held a press conference to spotlight the COVID-19 response at Coler and to distribute life-saving personal protective equipment (PPEs). She also co-hosted a meeting with patients, advocates, elected officials, and the City's Health + Hospitals leadership to get answers about Coler's patient care during crisis. As a result, a new community-based task force has been established to monitor operations at Coler, including COVID-19 testing and related protocols. Our advocacy for Coler Hospital residents on Roosevelt Island continues.

Delivering Food to Those in Need

With the support of dedicated volunteers, Seawright launched weekly meal deliveries to the homebound and seniors on the Upper East Side as part of our COVID-19 crisis response effort. Many thanks to the Stanley Baacs Senior Citizens Center and their dedicated culinary staff for preparing nutritious and delicious meals. Seawright Consumer Financial Literacy Bill Passed Both Houses

Legislation Aims to Greatly Strengthen Consumer Awareness and Financial Education Assembly Member Rebecca Seawright's Consumer Financial Literacy bill passed Assembly and Senate this week. The legislation directs the New York State Department of Financial Services and the New York State Department of State's Consumer Protection Division to conduct a study on consumer awareness and financial education in New York state and to make recommendations to greatly strengthen consumer awareness and financial education program.

An informed consumer is one who can utilize resources and information to manage their personal finances and avoid debt. *"Financial literacy is essential for good personal financial health. Each generation faces its own economic stressors. Some people alive today will have experienced the great depression, the subprime mortgage crisis leading to a great recession in 2007, and the current uncertain period of economic hardship as a result of the COVID19 pandemic," said Seawright.*

Legislative Update

Seawright Cosponsors Legislation Establishing Auto Voter Registration, Supporting Vulnerable New Yorkers and Improving "Test and Trace"

Automatic Voter Registration

To make it easier for eligible voters to register to vote by creating a system for automatic voter registration (*A.8280-C*). This process would allow state and local agencies to provide the New York State Board of Elections with voter registration information for people that submit an application for services or assistance. Agencies participating in this program will include the Department of Motor Vehicles (DMV), the Department of Health, the Office of Temporary and Disability Assistance, the Department of Labor, the Office of Vocational and Educational Services, city and county departments of social services, the New York City Housing Authority and other agencies designated by the governor in the future.

Legislation to promote the timely use of absentee ballots during the COVID-19 pandemic:

 Assuring voters concerned about the transmission of COVID-19 that they may obtain an absentee ballot (A. 10833)

- Allowing applications for absentee ballots to be processed earlier than 30 days before the election, as provided by current law (*A.10807*)
- Imposing a presumption that an absentee ballot envelope without a postmark is timely if it is received at the board of elections by mail the day after the election (*A.10808-A*)
- Allowing a number of current defects on an absentee ballot envelope to be timely "cured" by a voter after notice from the board of elections (A. 10830)

Protecting Vulnerable Populations

Legislation passed this week would provide an alternate way for young adults between 18 and 21 who were previously in the foster care system to re-enter the system without submitting a motion to family court during a state of emergency. Under current law, these young adults are able to return to foster care under the approval of family court if they have no other alternative or are participating in a vocational or educational program. This bill would authorize former foster care youth to request the commissioner of the local social services district to return to foster care during the COVID-19 crisis where the courts can be severely restricted (*A. 10581-B*).

Protecting New Yorkers from Discrimination by Real Estate Brokers and Agents

Seawright cosponsored and strongly supported legislation to help end discriminatory practices in the real estate industry that disproportionately affect minority homebuyers. This legislation makes clear that real estate brokers and salespersons may be fined and their licenses suspended or revoked for subjecting prospective homebuyers to discriminatory practices (*A.8903-A*). New York already prohibits housing discrimination on the basis of race, creed, national origin, sex, age, disability, marital status, military status, family status, sexual orientation or gender identity. The Department of State has the authority to fine, suspend or revoke the license of a broker or real estate salesperson for violations of law, but the statute does not specify that this includes for discriminating in their capacity as an agent or broker. This important legislation changes this, expressly confirming the Department's authority to punish such conduct in order to deter future behaviors and to better secure for homebuyers the right to fair and equal treatment in the real-estate and housing marketplace.

Testing and Tracing

Legislation passed this week would require that those who are uninsured are not charged for COVID testing, and that data gathered as a result is kept confidential (*A.10494-A*).

Contact tracing is a very important aspect of the reopening of New York State and the economy. Legislation passed this week would help foster trust between contact tracers and the communities they are reaching out to. One bill would provide for the confidentiality of tracing information from the identification of those who come in contact with a person with a confirmed or probable diagnosis of COVID-19 (A.10500-C). Another bill would require that COVID-19 tracers be representative of the cultural and linguistic diversity of the communities in which they serve to the greatest extent possible. Encouraging this diversity will lead to more employment opportunities and enhance the efficiency of the contact tracing program (A.10567-A).

Also passed this week is legislation that would require employers to notify employees if they come into contact with another employee that has been diagnosed with COVID-19. The employer would be prohibited from releasing the name of the diagnosed employee (A.10353-A).

Banning Glyphosate on State Property

(*A.732-B*) to ban the use of the herbicide glyphosate on State property. The chemical is an active ingredient in many common weed killer products and is widely used to kill weeds in parks, playgrounds and picnic areas.

These essential workers' wages and benefits must reflect the important role they play. The Healthy Terminals Act is dedicated to Leland Jordan, who worked as a baggage handler at JFK airport and fought for eight years on behalf of airport workers for safer working conditions and expanded benefits. Mr. Jordan passed away from COVID-19 on April 13, 2020," said Seawright.

We are productivity disquiated by the actors of federal agents operating on the streets of Portland, Oregon. Their presence is in direct contravention of the declarations of both the mayor of Portlance and the governor of Uregon, as well as both Oregon United States Senators, all of whom have demanded that the Iedeelal agents be removed. Deadline for COVID Rent Relief Program Is July 30



Now accepting applications through July 30

The program offers a one-time rental subsidy for eligible households that will be sent directly to their landlords. Preference is given to households with the greatest need. With the deadline fast approaching, make sure to apply now!

COVID Rent Relief Program - Application Period Now Open

HCR is pleased to announce that the application period is now open for the new COVID Rent Relief Program. Applications will be accepted through the program's online portal from **Thursday**, **July 16 through Thursday**, **July 30**.

Applications will be accepted throughout this period and the program will NOT make determinations on a first come, first served basis.

Our website provides residents with a link to the application portal, a list of Frequently Asked Questions, and a PSA video to help guide residents through the program.

To qualify for COVID Rent Relief Assistance, an applicant must meet ALL of the following eligibility criteria:

- Be a renter with a primary residence in New York State.
- Before March 1, 2020 and at the time of application, household income must be below 80% Area Median Income (View AMI by county and household size)
 - Families with extremely low income will be prioritized.
 - Income includes unemployment insurance payments/PUA.
- Before March 1, 2020 and at the time of application, household must pay more than 30% of gross monthly income for rent.
- Applicant must have lost income during the period of April 1, 2020 to July 31, 2020.

What is the application process?

The application can be accessed on <u>HCR's website</u> starting Thursday, July 16 and will be available until <u>Thursday</u>, July 30.

Applicants will be asked questions to determine eligibility and will be required to submit certain information and documents for verification, including:

- Proof of identity: Government-issued ID such as a driver's license or governmentissued identification card
- · Copy of lease or other proof of their monthly rental amount; and
- Proof of income, such as W-2 and tax return

Applicant information will be verified and processed at the close of the application period and a one-time payment will be sent directly to the resident's landlord.

Mediation for Tenants At Risk of Eviction

This week Mayor de Blasio announced a new citywide Landlord-Tenant Mediation Project to begin to address rent-related issues outside of the housing court system. Mediation puts decision-making power in the hands of the parties involved, resulting in practical solutions for both landlords and tenants.

Non-profit Community Dispute Resolution Centers (CDRCs) will assist tenants and small landlords in finding solutions to rental issues due to the COVID-19 pandemic. The goal is to resolve cases before they reach litigation and avoid the long-term effects of an eviction proceeding. The Mediation Project will handle cases in a setting where both parties feel safe, and priority will be given to tenants and small landlords who do not have legal representation.

You can request the mediation service by calling 311 and asking for the Tenant Helpline. Specialists will screen residents for eligibility and refer them to a CDRC in Manhattan.
