


### Martin Luther King Jr. Day Jan. 18

Dr. Martin Luther King Jr. was a visionary, a global figure, and an icon whose ideas have influenced people for generations since his untimely death. Dr. King dedicated his life to unifying people of all backgrounds and actualizing his dream of a nation where people thrived together in spite of their differences. Every year since 1983, the third Monday in January has been recognized as a federal holiday to commemorate his life, legacy, and accomplishments.

On Wednesday, January 20, we will also witness the Inauguration of our new President Joe Biden and Vice President Kamala Harris. The National Day of Service for the Inauguration of Joe Biden and Kamala Harris will celebrate and honor the spirit of Dr. Martin Luther King Jr. Join us and commit to serving your community on Monday, January 18! New York is now including individuals age 65 and up as eligible to schedule appointments to receive the vaccine. We are advised that the number of eligible New Yorkers is currently over 7 million people while the allocation to New York is only 300,000 doses per week from the federal government. The State has not been allocated enough doses to meet the demand. In coordination with the Manhattan Borough President's Office, we are taking part in a task force to better serve our communities during the vaccination rollout which has proven to be disorganized and overwhelming for those people who are seeking appointments.

Over seven million New Yorkers are now eligible for the vaccine. Eligible groups include doctors, nurses and health care workers, people age 65 and over, first responders, teachers, public transit workers, grocery store workers, and public safety workers.

New York State and NewYork-Presbyterian Hospital launched a new vaccination site for eligible New Yorkers in Washington Heights. This new site, at Fort Washington Armory in Upper Manhattan, was made possible thanks to a partnership with Weill Cornell Medicine and Columbia University Irving Medical Center. The site is offering vaccinations to New Yorkers age 65 and up and appointments can be scheduled online through the NewYork-Presbyterian *Connect Online Patient Portal*. Appointments are required.

### Seawright Appointed to Assembly Ways and Means Committee



New York State Assembly Speaker Carl Heastie announced Assembly Member Rebecca Seawright's appointment to the powerful Ways and Means Committee.

The committee plays a pivotal role in the annual New York State budget process. The committee also examines all department budgets, appropriation requests, appropriation bills and holds public fiscal hearings conducted jointly with the Senate Finance Committee.

"I am privileged to serve and grateful to Speaker Heastie for his trust," said Seawright. "New York State faces fiscal challenges not seen in more than a generation. The task ahead will not be easy as we work to defeat the COVID-19 virus and its fallout."

### Assembly Member Seawright joins Speaker Heastie Urging Swift Congressional Removal of President Trump

Assembly Member Rebecca Seawright joined Speaker Carl Heastie and a total of 75 Assembly majority colleagues urging Congress to impeach and remove President Donald J. Trump for incitement of insurrection and violence against the United States government. Seawright, who serves the Upper East Side, Yorkville, and Roosevelt Island, signed onto the letter to Congress expressing outrage over the President's actions.

"President Trump's actions and words knowingly helped incite this attempted coup and the extraordinary acts of domestic terrorism we witnessed last Wednesday," they wrote. "This was nothing less than an attempt to nullify the sacred trust of the American voter, who overwhelmingly expressed their choice for President by exercising their most fundamental American right – the right to vote – in an election that was fair and secure. Instead, a mob desecrated the U.S. Capitol and cost five American lives."

Speaker Heastie, who released the letter jointly with upstate Assembly Member Pat Fahy, said, "The deadly, violent acts of domestic terrorism we witnessed last week at the U.S. Capitol were an assault on our democracy incited by President Trump and his allies. He must be held responsible. We must set the precedent that attempting to overturn the will of the American people cannot and will not be tolerated."

According to the letter, the only appropriate recourse left for inciting domestic terrorism is impeachment and removal from office to prevent further, irreversible damage to our republic. The letter notes the urgency of setting a precedent to prevent future occurrences.

The Federal Bureau of Investigation warned of potentially armed protests at the U.S. Capitol and all 50 state capitols, including the New York State Capitol in Albany, from January 16 through January 20. The New York State Police have said that they have taken steps to strengthen security in and around the Capitol out of an abundance of caution.
