Seawright Passes Renter Protections

Assembly Member Rebecca Seawright announced the passage of state legislation she co-sponsored that extends and expands protections for renters and small landlords facing financial distress caused by the COVID-19 pandemic.

Seawright said the COVID-19 Emergency Eviction and Foreclosure Prevention Act of 2020 would temporarily stay evictions and residential mortgage foreclosures until May 1.

"More evictions will lead to more infections and more deaths. The devastating job and income loss, societal disruption, and business closings we've seen this year have made keeping a roof over New Yorkers' heads even more challenging. The lack of rental income hurts small property owners. They need our help. I am proud to have co-sponsored this legislation which benefits those most in need."

COVID-19 Rent Relief Application Extended through February 1, 2021

The COVID-19 Rent Relief Extension Program is open through Monday, February 1, 2021. Previous applicants will not have to reapply to be reconsidered. 
Seawright Distributes 7,000 N95 Masks to "High-Risk" Nursing Home Residents and Healthcare Workers

With the long-awaited COVID-19 vaccination program advancing, Assembly Member Rebecca Seawright lead a new distribution of 7,000 specialized masks to protect highrisk nursing home residents and healthcare workers at Mary Manning Walsh/Archcare Nursing Home, Lenox Hill Hospital-Northwell Health, and Memorial Sloan Kettering Medical Center on the Upper East Side, Yorkville, and Roosevelt Island. The Doe Fund's nationally recognized program to help formerly incarcerated and homeless men return to the workforce also received 1,000 masks.

Funding New Laptops, Bottle Filling Stations, and Bathroom Renovations

Assembly Member Rebecca Seawright presented a New York State Assembly grant in the amount of \$500,000 for technology upgrades and renovations. Working with Principal Doreen Esposito, Seawright allocated funding for the needs of the Manhattan New School to have new technology, bottle filling stations, and bathroom renovations.

In the age of COVID-19, it is critically important that all students have access to laptops to strengthen their communications skills, research, self-direction, and problem solving skills to work independently. "As a proud public school parent and former PTA activist, I understand the importance of funding for the classroom. Our students deserve to have the technology and resources to have the opportunity to learn, especially at a time when some students are learning remotely," said Assembly Member Seawright. The grant will also provide for the installation of additional smart boards in classrooms.

The water bottle filling stations will present a healthy option for students to develop healthy habits at school. The bathroom renovations will include facilities with greater capacity, automatic flush toilets, and sink repairs to ensure a safe and sanitary school day.

Assembly Member Seawright is a member of the Education Committee in Albany, securing over \$12 million in funding to date for our public schools, parks, non-profits, and senior centers. Seawright has previously funded a green roof for the Manhattan New School, PS 290.


New York State Assembly Speaker Carl Heastie appointed Assembly Member Rebecca Seawright, a longtime advocate for women's rights, to chair the New York State Assembly Task Force on Women's Issues.

Seawright is the prime sponsor in the Assembly of legislation for an Equal Rights Amendment to the State Constitution. Now entering her fourth term representing the Upper East Side, Yorkville, and the Roosevelt Island, she has passed groundbreaking legislation such as laws that require health insurance policies to include 3-D mammography at no cost to the consumer.

Seawright also championed legislation, which was signed by the Governor, encouraged greater representation of women on corporate boards. She authored a law to promote greater consumer financial literacy.

"I'm thrilled and honored to be chairing this task force," Seawright said. "I am especially grateful to Speaker Heastie for this appointment and his longstanding leadership and support for women's issues. And I pledge to work tirelessly to build upon the progress we have made as we face the challenges ahead."

Seawright said she will "continue to be inspired to renew the movement for the federal Equal Rights Amendment to guarantee that our rights are anchored in our State and U.S. Constitutions."



The committee plays a pivotal role in the annual New York State budget process. The committee also examines all department budgets, appropriation requests, appropriation bills, and holds public fiscal hearings conducted jointly with the Senate Finance Committee.

"I am privileged to serve and grateful to Speaker Heastie for his trust," said Seawright. "New York State faces fiscal challenges not seen in more than a generation. The task ahead will not be easy as we work to defeat the COVID-19 virus and its fallout."

Legislation Aims to Greatly Strengthen Consumer Awareness and Financial Education

Assembly Member Rebecca Seawright's Consumer Financial Literacy bill (A.6070) has been signed into law. The legislation requires the New York State Department of Financial Services to provide, on the department's website, information to enhance consumer financial literacy and consumer awareness. Educational material will be provided on basic banking and personal financial management, how credit scores are determined, ways to establish good credit, and options for investing and increasing personal savings.

"New York is the financial capital of the world and represents 8% of the total U.S. gross domestic product. Our economy is only as strong as the collective financial health of individual consumers. As a result of the COVID pandemic, we are facing parallel health and economic crises. This legislation establishes basic consumer awareness and financial education for all New York State consumers. We want to empower consumers to fight the economic impacts of COVID-19," said Seawright.
