On Tuesday I was honored to present Governor Kathy Hochul with a "Women in Service" Award at a Veterans Day tribute hosted with Co-Chair Howard Teich at the Women's Overseas Service League Flagstaff and Grove, rediscovered in Central Park in 2019. It was a wonderful tribute to the hardworking and dedicated women in service. You can find photos and profiles of the women honorees in this report.

Two months after the devastating September 11th terrorist attacks, another tragedy took the lives of 260 people on board American Airlines Flight 587 bound for the Dominican Republic, including five people on the ground in Belle Harbor, Queens. The crash devastated the Dominican communities in New York. Two decades later, we remember those who tragically perished and keep their loved ones on our minds and in our hearts.

You may have heard about the recently passed \$1 trillion federal infrastructure bill. It is a historic investment in the foundation and future of our communities. This legislation will allow for the creation of better roads, reliable high-speed internet, improved public transportation and airports, safe and clean drinking water and the implementation of electric vehicle charging infrastructure. It includes funding to help New York repair the aging infrastructure that our families use every day while also moving us toward a greener future with additional resources to combat pollution. This boost of federal funding is critical to build on our recovery from COVID-19 and move our nation forward.



Honorees include Brigadier General Loree Sutton, US Army (Retired); Theresa Tobin, Chief of Interagency Operations, New York Police Department; Michelle Fitzsimmons, Battalion Chief, Fire Department of New York City; Zeita Merchant, Captain, US Coast Guard; Yesenia Mata – Executive Director, La Colmena; Dottie Brier – Disaster Mental Health Volunteer, American Red Cross in Greater NY.

The event was co-organized by the Office of Assembly Member Rebecca Seawright, The Howard Teich Network, The American Red Cross in Greater NY and community partners including the Columbus Citizens Foundation and the Eastside WWI Centennial

Commemoration.



James Hendon, Commissioner NYC Department of Veterans Services addresses the crowd and congratulates the women in service or who he calls "this generation's giants."




Honoree Captain Zeita Merchant has dedicated more than 24 years of her life to maritime safety and emergency management, becoming a leading expert through her countless disaster response assignments across the country. Merchant is a decorated civil servant, with nineteen personal military awards, and other honors recognizing her leadership, community service, and professional achievements. Last year, she took on the role of Deputy Commander, Sector New York for the Coast Guard, overseeing hundreds of personnel and complex, large-scale operations.



Council Member-Elect Julie Menin presented Yesenia Mata, Executive Director, La Colmena with her "Women In Service" award. Yesenia Mata is a young leader in Staten Island, representing the borough on New York City's recently formed Racial Justice Commission. As a member of the U.S. Army Reserve, Mata is one of eleven representatives tasked with identifying and uprooting systemic racism. Mata advocates for low-wage immigrant workers as executive director of La Colmena, a community-led organization that provides education and legal assistance to vulnerable groups.



Assembly Member Jenifer Rajkumar (Right) presented Retired Brigadier General Loree Sutton with her award for her dedication of nearly four decades to public service. As a veteran, she has received recognition for her role in Operation Desert Storm and her experience as a psychiatrist developing specialized veterans' programs to empower and improve veterans' lives after service. In this role she has created holistic health programs to fulfill veteran's psychological needs, including treating PTSD symptoms. She calls this work the most important in her lifetime.

Honoree Theresa Tobin, Chief of Interagency Operations, New York Police Department. Deputy Chief Theresa Tobin comes from a family of police officers, with a father and three siblings having also served with the NYPD. During 9/11, Tobin was on duty at the towers and sustained serious injuries, later saying the experience deepened her commitment as a police officer. Ten years later, Tobin earned her doctorate in criminal justice, working steadily throughout her recovery. She has been honored for her heroism with the NYPD Medal of Valor, and since rose to become a twostar Assistant Chief, one of just four women leading the department who have been promoted to the role.



Honoree Dottie Brier, Disaster Mental Health Volunteer, American Red Cross in Greater NY. Dottie Brier is a retired social worker, has dedicated the past 29 years of her life helping individuals cope with trauma after disaster. As a Red Cross volunteer since 1992, she has provided emotional support following some of the biggest tragedies of our time, including 9/11, Hurricane Andrew, Superstorm Sandy, the Oklahoma City bombing, the crash of TWA flight 800, and the "Miracle on the Hudson," just to name a few emergencies.

Statement on the Blood Center Vote


On Wednesday the Land Use and Zoning committees of the City Council voted to approve the rezoning for the New York Blood Center/Longfellow commercial tower. The applicant made some concessions including 100 feet shaved off the original proposal for an adjusted height of 233 feet, and a promise of funding for St. Catherine's Park and the Julia Richman Education Complex.

"I am disturbed to hear that for the first time in our city's land-use history, our local Council Member was not given "member deference" in Committee, therefore bypassing his objections and setting a new and dangerous precedent of ignoring the pleas of a local community. I will continue to stand with my East Side colleagues Council Member Ben Kallos, Council Member-elect Julie Menin, Senator Liz Krueger and Congresswoman Carolyn Maloney in opposition to this project, and with our neighbors against powerful interests," said Assembly Member Rebecca Seawright.

The revised plan heads to the Department of City Planning for a review of the changes, which could take up to 15 days. After that, the plan moves to a final vote of the full City Council, where a supermajority vote will be required in order to pass the project.

Seawright Cosponsored Legislation Signed into Law This Week

IMPROVING PUBLIC SAFETY

with new laws that support data-driven research to stop gun violence:



Creates the Firearm Violence Research Institute within SUNY to lead gun violence research efforts statewide (Ch. 595 of 2021) Creates the Gun Violence Research Fund and allows taxpayers to contribute to gun violence research (Ch. 589 of 2021)

Assembly Member Rebecca Seawright cosponsored new laws that will enable us to further study the root causes of gun violence and craft new legislation to improve public safety.

The Assembly Majority championed new laws to help combat unwanted robocalls

- Require telecommunication companies to *proactively block calls from invalid or unused phone numbers* (Ch. 582 of 2021)
- Require providers to implement a more robust authentication program to better identify spoofed or illegitimate calls (Ch. 585 of 2021)



"I am proud to have cosponsored and supported the robo-call bills to both screen and block unwanted callers to protect New Yorkers from the nuisance of robo-calls," said Assembly Member Rebecca A. Seawright.

COVID-19 Vaccine Update:

Children ages 5-11 are now eligible to receive the COVID-19 vaccine.



COVID-19 Vaccines Are Available for Children Ages 5 to 17!

- Children can get vaccinated at their doctor's office, pharmacies and vaccine sites across the city.
- Vaccines are safe, effective and free! You do not need to have health insurance or share your immigration status to get vaccinated.
- Children receiving their first-dose at City-run vaccination site are eligible for incentives, including a \$100 pre-paid debit card.
- Parents or guardians must give permission to get vaccinated and children ages 5 to 15 must have an adult with them.
- Children ages 5 to 17 can get the Pfizer vaccine. The Pfizer vaccine requires two doses, three weeks apart. People are considered fully vaccinated two weeks after their second dose.

Make an appointment or visit a walk-up vaccination site

Schedule an in-home vaccine appointment

To make an appointment, go to nyc.gov/homevaccine or call 877-VAX-4-NYC (877-829-4692).



The CDC has approved the Pfizer COVID-19 vaccine for children ages 5-11 and it's free for everyone. Together we can all do our part to stay healthy and protect ourselves and those around us. Visit <u>www.covid19vaccine.health.ny.gov</u> to learn more.

Governor Hochul signed into law a *new moratorium on* <u>COVID-related residential and</u> <u>commercial evictions</u>, which is in effect until January 15, 2022.

The Open Enrollment Period for health insurance for uninsured New Yorkers has been extended through December 31, 2021. New Yorkers can apply for coverage through <u>NY</u> <u>State of Health</u> or directly through insurers.

Health care workers can text NYFRONTLINE at 741-741 to access 24/7 emotional support services.

Any New Yorker can call the COVID-19 Emotional Support Hotline at1-844-863-9314 for

mental health counseling.

Excelsior Pass provides a free, fast and secure way to present<u>digital proof of COVID-19</u> vaccination or negative test results.

Free Transportation and In-Home Vaccinations

City residents 65 and older can get free transportation to and from a vaccination appointment. This service is also available for those with disabilities who have no other way to get to a vaccination site.

To schedule free transport by either ambulette or taxi (including wheelchair accessible vehicles), call 877-VAX-4NYC (877-829-4692). If you are younger than 18, you must have your parent or guardian call to book the trip on your behalf.

You can also *sign up online for an in-home vaccination* or by calling 877-VAX-4NYC (877-829-4692). Anyone 12 and older is eligible for in-home vaccination.

NYC FAST FOOD WORKERS' RIGHTS

Under NYC's **Fair Workweek Law**, employers must give workers predictable schedules and the chance to work more hours. **The law now prohibits wrongful discharge**. Specifically, employers cannot fire or lay off workers or reduce their hours by more than 15% without just cause or a legitimate economic reason. Employers must post this notice where employees can easily see it at each NYC workplace.

Your Rights

Fast Food Workers Covered by the Law


Employees who perform at least one of the following tasks at a fast food establishment in NYC:

cleaning

- off-site delivery
 routine maintenance duties
- cooking
 customer service
- food or drink preparation
- security
- stocking supplies or equipment

The law applies regardless of immigration status.





Can only fire underperforming workers after giving them multiple disciplinary warnings in a year.

No layoffs except for economic reasons (Effective 7/4/2021)

Layoffs must be in reverse order of seniority, with longestserving workers laid off last.



- Your employer must advertise open shifts on posters in the restaurant and by text or email.
- Your employer may only hire new workers if no laid-off or current NYC workers accept the shifts by the posted deadline.

of hours, or layoff (Effective 7/4/2021) Written long-term regular schedule Your regular schedule must be stable week to week so you know when you are expected to work. Your employer must give you an updated regular schedule if there are changes.

14 2 weeks' advance notice of work schedule Work schedules must show all shifts for at least 7 calendar days and reflect your regular schedule, unless you requested or agreed to any changes.

Written explanation for firing, reduction



\$100 premium to work "clopening" shifts and the right to say no

A clopening involves closing and opening a restaurant on back-to-back shifts. You can agree to work and get premium pay or you can refuse.

Premium pay for schedule changes by employer with less than 14 days' notice and the right to say no to additional hours

Amount of notice	Rate for additional hours	Rate if no impact on hours	Rate for reduced hours	 You do not give up your right to premium pay when you agree to a schedule change. Premium pay is not required when: Your employer closes due to: threats to worker safety or employer property; public utility failure; shutdown of public transportation; fire, flood, or other natural disaster; government-declared state of emergency. You request a schedule change to a shift in writing. You rade shifts with another employee. Your employer must pay overtime for a changed shift.

No Retaliation

It is illegal to punish or fire employees for exercising their rights under the law. Workers should immediately contact DCWP about retaliation.

File a Complaint

The Department of Consumer and Worker Protection (DCWP) enforces the law. For more information or to file a complaint:

DCWP will keep your identity confidential unless disclosure is required by law.

You can also file an action in court. However, you cannot have a complaint with DCWP and a claim in court at the same time.
