

Seawright Opposes Changes to the Consumer-Directed Personal Assistance Program (CDPAP)

The Consumer Directed Personal Assistance Program (CDPAP) is a Medicaid home care program that allows disabled and senior residents of the state to hire their friends or family members as a Personal Assistant (PA). CDPAP's purpose is to allow seniors and people with disabilities to be comfortable in their home by having their loved ones assist them. Until now, the CDPA Program has had between 600 and 700 subsidiaries, who are contractors that employ the actual assistants, working throughout the state to employ personal assistants to approximately 250,000 New York State residents.

The FY 2024-2025 New York State Budget approved significant changes to CDPAP. Under the new legislation, "the Statewide Fiscal Intermediary (SFI) will subcontract with several entities to facilitate the delivery of Fiscal Intermediary (FI) services." These changes will streamline the intermediaries to create one SFI who will hire several subcontractors. The governor's office has announced that Public Partnerships LLC (PPL) will be the Statewide Fiscal Intermediary starting April 1, 2025. Current intermediaries have until April 1, 2025, to suspend operations or apply to be subcontractors under Public Partnerships. These changes are causing concern amongst those who receive CDPAP services. Seawright is here to help if you need support!

Cracking Down on Retail Theft



Retail theft is a serious problem in our community. Assembly Member Seawright cosponsored and strongly supported a new state law creating the crime of fostering the sale of stolen goods to crack down on organized retail theft (Ch. 55 of 2024). I have zero tolerance for those who threaten our small businesses and our families' safety.


