Assembly Member Seawright stated her commitment to work on the most pressing issues to the care of individuals with intellectual and developmental disabilities. She said, "In our state budget, I am pressing for higher and higher Cost-of-Living Adjustments (COLA) so provider agencies can recruit and retain critical staff. We're fighting for a Direct Support Wage Enhancement, so DSPs earn a living wage, recognizing their enormous contributions and living costs."

Seawright Helps Secure \$2 Million for Mobile Museum of Tolerance Touring Upper East Side and Roosevelt Island Schools

Simon Wiesenthal Center's Executive Director Rabbi Meyer H. May and Assembly Member Seawright discussed the importance of bringing the Mobile Museum of Tolerance to students in our community.

The first-of-its-kind in the United States, the Mobile Museum of Tolerance is a free, traveling, mobile education center, utilizing innovative technology and interactive lessons to bring a message of tolerance directly to communities across the United States.

Assembly Disabilities Chair Rebecca Seawright Rallied to Register New York Voters with Disabilities

In 2022, only 50.8% of eligible people with disabilities voted, and 14% reported struggling to vote. That's three times more than voters without disabilities. Based on estimates, 2.2 million voters with disabilities faced challenges in 2022.

The coalition of students with disabilities (pictured here) includes CUNY Votes, the CUNY Office of Disability Programs, the New York Coalition of Students in Higher Education with Disabilities, the CUNY Coalition for Students with Disabilities (CCSD), the New York Public Interest Research Group (NYPIRG), the Viscardi Center, Quality Services for the Autism Community (QSAC), the



CUNY Graduate School and University Center, the CUNY Graduate Center, and the NY State Disability Services Council.

Henry Viscardi Jr. (1912-2004) was an American disability rights advocate who championed the cause of equality and employment of disabled people in the workforce. In 1952, on Eleanor Roosevelt's advice, he founded Abilities, Inc. which has now expanded to the Viscardi Center – a non-profit organization and global leader advocating for the empowerment of people with disabilities.


Community Office Held No-Cost Glucose, Blood Pressure Screenings, and Flu Shots!

Office volunteer Barbara Mandel got her blood pressure screening at no cost. The District Office of Assembly Member Rebecca Seawright held a no-cost glucose and blood pressure screening event in partnership with Drug Mart.

Seawright Earned 100% on New York League of Conservation Voters Environmental Scorecard

NYLCV-supported budget measures included:

- \$400 million for the Environmental Protection Fund, without raiding the fund to pay for agency staff;
- \$500 million for the Clean Water Infrastructure Act;
- RAPID Act to expand cleanenergy transmission capacity;
- Sammy's Law, which allows NYC to lower speed limit to 20 mph on certain streets;
- Authorization for the MTA to waive penalties for fare evasion if the offender instead enrolls in the Fair Fares program;
- Stronger enforcement of illegal license plate covers to help ensure effective implementation of the congestion pricing program in New York City;



- A needs evaluation for highway and depot electric vehicle charging infrastructure;
- Clarification that Bond Act grant funding for electric school buses will not impact a school district's transportation aid; and
- The creation of a Zero-Emission School Bus Resource Center within NYSERDA.
